



Our new President's Address A New Millennium - The Challenge Ahead

(delivered at the HKIS AGM on 13th December 1999)

Dear members,

Thank you for attending the Annual General Meeting. It is most encouraging to note that members are keen in the affairs of the Institute as witnessed by the number of members turning up this evening.

During the past two years we were in the midst of the financial turmoil. However, it is my observation that despite of the difficulties encountered, our members are, in general, performing well and maintaining a very high professional standards and ethics in their work. With the gradual recovery of the economy, I am sure that there will be more job opportunities and our role as professional surveyors is becoming more and more important in providing services to the community.

Now turning to the work of the Institute, no doubt you are aware of the 5-year plan as launched by our out-going President, Mr. Samson Wong, the working group to promote surveyors' image, various committees on current affairs, enhancing communication with members etc. All these assignments had a good start, some are almost finished. In my current term as the President, I together with the General Council and Divisional Chairmen, will continue monitoring progress on these key issues. Furthermore, the Institute will

take on a more proactive role in advising Government on formulation of policies, through active participation in various committees/panels. Our attention will focus on operation of the property market and major issues like urban renewal, sustainable development, reclamation, construction standards and safety etc. More CPD events and forums will be held on a strategic basis with a view to enabling members to exchange ideas and inform them of the latest knowledge about the professional and technological development. Also, a recruitment exercise for an IT officer is being held so that we will be able to provide better services through electronic means to members and the general public. On the PR aspect, the spokesman system will remain. We will explore whatsoever ways possible to enhance our professional status. At the same time, the Institute is keen to find more accommodation in order to give better services to members.

On the international front, we have appointed Mr. Graham Heath to be our contact person with the RICS. This is most important in view of Mr. Heath's background and personal contact with key personnels in the RICS, particularly at the time in which HKIS is exploring possible incorporation with the SST in Hong Kong.

With regard to our contact with the mainland, and nearby regions, I note that some members had, in the past few years,



News from the General Practice Division

1. The New Council, General Practice Division

At the General Practice Division Annual General Meeting held on 2 December 1999, which was attended by 227 members, 20 members were elected as Council members for the year 1999/2001. The first Council meeting was held on 8 December 1999 at which the following office bearers have been elected.

To enable the Council to tackle Division matters more effectively, Council members agreed to increase the number of the Vice-Chairman post to 3. Each of them will be responsible for different aspects of the divisional matters which could be categorized into 4 main areas, namely:-

- i) Professional Practice and Standards Affairs;
- ii) Government Practice and Local Affairs;
- iii) Education, Membership, APC and CPD Affairs; and
- iv) Public Relation, PRC and International Affairs.

The allocation of responsibility of these areas amongst the Chairman and Vice-Chairmen is to be confirmed at the coming Division Council meeting, and thereafter shall be reported to members.

2. New List of Independent Valuation Expert

At present, the HKIS maintain a List of Independent Valuation Expert. The President of HKIS carries out the appointment and nomination service of members on the List to act as Independent Valuers on request of the

public. There are about 20 names on the current List. However, there are no formal procedures and criteria by which members could be included in the List. In 1998, the General Council of HKIS agreed to set up a Working Group headed by Mr. S. C. Liu together with members Mr. Thomas N. T. Poon, Mr. H. F. Leung and Mr. K. K. Chiu to study the issue. Based on the Working Group recommendation both the General Practice Division Council and General Council of HKIS endorsed the following criteria and procedures of appointing members to the List. It is also the decision of the General Practice Division Council that a new List be drawn up to replace the existing one as soon as possible. Members who would like to be included in the new List of Independent Valuation Expert are therefore required to submit their application together with details and particulars which should meet the following criteria:-

- i) a Fellow membership of General Practice Division;
- ii) 10 years post-qualification experience in Hong Kong;
- iii) the immediate past 5 years experience should mainly involve property valuation; and
- iv) not having been used successfully for professional negligence in the past.

All applications will be considered by a Panel formed by the General Practice Division to endorse, if the qualifications and experience of the applicants meet the criteria, before recommendations are made to the President of HKIS for inclusion in the new List. Moreover, the List will be updated every 2 years and the Chairman of General Practice Division will be consulted prior to the President of HKIS appointing an Independent Valuation Expert under the List on request from the public. Cases will be allocated on a rotation basis.

As it is intended that the new List will take effect as soon as possible members are requested to submit their application on or before 19 February 2000.

Task Force on Electronic Tendering

Electronic tendering is the distribution of tender documents and the subsequent submission and receipt of the tender returns in electronic format. It is one of the initiatives pursued by the local construction industry to bolster its competitiveness. To collaborate with the construction industry on this important initiative, Works Bureau (WB) of the HKSAR Government has recently formed a Task Force on Electronic Tendering in July 1999. This Task Force is tasked to consider the business case for electronic tendering, to assess its feasibility and to formulate a strategy for implementing the initiative.

With full awareness that e-tendering is a multi-disciplinary task, the Task Force is composed of all sectors of the construction industry. Trade organisations, professional institutions and government agencies, who are involved in the local construction industry, are represented. The trade organizations include the Hong Kong Contractor's Association (HKCA), the Electrical, Mechanical Contractors' Association (HKEMCA) and the Hong Kong Association of Consulting Engineers (HKACE). The professional institutions include the Hong Kong Institute of Architects (HKIA), the Hong Kong Institute of Surveyors (HKIS) and the Hong Kong Institution of Engineers (HKIE). The eclectic membership assures that the requirements, options and deliverables from the various sectors of the industry will be duly considered in the deliberation of the Task Force.

The assignment of the task force is divided into three stages. In the first stage, the task force will consider the business case for electronic tendering through the conduct of a survey on electronic tendering. This survey serves to gather information on the existing IT infrastructure of the industry, the industry's perception of the scope, benefits and drawbacks of electronic tendering, and to gauge the willingness of the industry to make investments and volunteer participation in the tendering process. The results will enable the Task Force to make an informed judgment on whether there is a sufficient business case for electronic tendering.

The Task Force will tackle the electronic distribution of tender documents in the second stage and the submission of electronic tender returns in the third stage. In these stages, the Task Force will sail through the largely uncharted waters of conducting the tendering exercise through electronic transactions. The Task Force will undertake the arduous task of identifying legal, technical and administrative issues that need to be addressed in implementing electronic tendering. On legal issues, the Task Force will tackle the enforceability of contracts concluded using electronic transactions, the authenticity of electronic records and the authentication of parties in electronic transactions. On technical issues, the Task Force will devise data format for exchanging information between widely different computing platforms and measures for

protecting unauthorized access and alteration to tender information. On administration issues, the Task Force will formulate a transitional plan to enable the existing hard copy based procedures to metamorphose into a system that supports both hard copies and electronic records.

The Task Force needs to look at the various forms of contracts now in use in different construction sectors and to complete its tasks under a very tight schedule. Hence, we divide the Task Force into six functional entities: Plenary Meeting, four Sub-Groups and the Task Force Secretariat. All Task Force members attend the Plenary Meeting, which exercises an overall steer on the assignment. The Task Force Secretariat, staffed by the Works Bureau, provides secretarial support for the Plenary Meeting and the Sub-Groups.

The Sub-Groups are the main forums in which the issues on electronic tendering are deliberated in details. There are four Sub-Groups: Building (BSG), Civil (CSG), Electrical and Mechanical (EMSG) and Infrastructure Facilities (IFSG). The BSG, CSG and EMSG deal with the electronic tendering of contracts in the building, civil engineering and electrical and mechanical disciplines respectively. As the contract forms and nature of business

for these three disciplines differ some substantially, it is more effective to deal with them separately in dedicated Sub-Groups. The IFSG will function as the adviser on legal and technical issues referred to by other Sub-Groups. The numbers of members of the Sub-Groups vary from 12 to 20 members, indicating the industry's strong support for the electronic tendering initiative.

The first series of meetings of the Sub-Groups was held in late October and early November. During these meetings, members elected the Chairman and Vice Chairman of the Sub-Group, deliberated on the working programme and made valuable comments on the scope and methodology for the questionnaire survey on electronic tendering.

The Task Force will strive to complete the questionnaire survey shortly before the Chinese New Year in early February 2000. To ensure timely completion, WB has engaged consultants to formulate the

survey methodology, to design the questionnaire and to analyze survey results. The targets of the survey will include architectural firms, quantity surveying firms, engineering consultants and contractors.

The deliberation of the Task Force is scheduled for completion in late 2000. By that time, the Task Force will present its recommendation on electronic tendering strategy to the Contracts Committee of the Construction Advisory Board.

The Task Force is the first ever collaboration between the public and private sectors of the local construction industry on the use of IT for making improvement in our service delivery. The two sectors have maintained a strategic partnership in other areas. In the light of these remarkable track records, we are confident that the Task Force will be another success story.

Electronic tendering is only the first step

in promoting electronic services delivery (ESD). ESD is the exchange of information and the conducting of business transactions through electronic communications. As ESD is one of the Administration's major initiatives in revitalizing our business process, Works Bureau will actively explore with the construction industry the opportunities of extending ESD from tendering into the other parts of the project life cycle.



The New - 1999 General **Conditions for Civil Engineering** Works

On 1st December 1999 the new 1999 Edition of the Government of Hong Kong General Conditions of Contract for Civil Engineering Works was promulgated by Works Bureau Technical Circular No 28/ 99, and will be used in all appropriate tenders called after that date. Revised versions of the Building and Electrical and Mechanical Conditions will follow in due course.

This 1999 Edition is the latest in a number of revisions made to the totally revised 1985 Edition. The amendments, like those made in the previous 1990 and 1993 Editions are largely minor in nature, and many simply serve to either reflect the current political and social situation in Hong Kong, to update phrases and expressions no longer in use or to improve upon poor wording in previous editions.

Examples of such amendments can be seen in:

Clause 1(1) - definitions, where the Employer is now defined as the Government of Hong Kong Special Administrative Region.

Clause 4 - sub-contracting, where reference is now made to sub-contracting rather than sub-letting, and to workers rather than workmen.

Clause 21 - care of the works, where the "Excepted Risks" now rather alarmingly refer to 'contamination by radio-activity from nuclear fuel or nuclear waste'.

Clause 42 - quality of materials, workmanship and tests, which has been totally re-written to provide clearer wording, but contains no substantive change in provision.

However, in addition to these relatively minor changes there are a number of changes of more significance, and worthy of consideration.

Clause 2 - duties and powers of the Engineer and the Engineeris Representative has been completely rewritten and now contains a sub-clause making it clear that the Engineer may, under the terms of his consultancy agreement, be required to receive the approval of the Employer before carrying out certain actions (to be defined in a Special Condition of Tender) under the Contract, and if such approval is not given to act in accordance with the Employee's directions.

Enclosed with the Works Bureau Technical Circular is a standard Special Condition of Tender to accompany this

provision that provides that the Engineer must seek the Employer's confirmation of no objection before he can commit the Employer to additional expenditure (other than for claims) of over HK\$300,000.00.

Whilst the next sub-clause makes it clear that the Contractor shall not be prejudiced by any failure of the Engineer to comply with this requirement, this new clause formally recognising that the Engineer may be prevented from acting as a professional impartial contract administrator is a significant amendment.

Cynics may say however that this has been the situation, albeit unwritten, for many years and that in reality the Engineer has always been fettered in his actions as a contract administrator.

Nonetheless the new clause is to be welcomed for formalising and confirming the situation, and in this respect follows similar provisions in FIDIC and the latest ICE Conditions of Contract which also contain provisions for detailing any restrictions placed upon the Engineer in performing his duties under the contract.

Clause 50 - extensions of time contains three significant amendments. Firstly notice that a delay has occurred to the progress of the Works must now be given in 28 days (i.e. the same as for Cost



Claims in Clause 64) rather than 42 days, and the starting time for such notice is amended from the subjective test of "within 28 days of the cause of any delay becoming apparent" to an objective test of "within 28 days of the cause of any delay having arisen". This amendment, whilst being more restrictive for a contractor adds more certainty into the starting date, and is repeated in Clause 64 referring to Cost Claims.

Secondly Clause 50(1)(b)(v), a sub-clause detailing events giving entitlement to an extension of time, has been amended from a substantial increase in any item of work to that set out in the Bills of Quantities or the Bills of Quantities, to a substantial increase in the quantity of any item of work included in the Contract. This is an interesting amendment because it is a return to the same wording as the 1985 Edition but which was amended in the 1990 Edition. The intention here appears to be to restrict the situations in which a contractor can claim an extension of time to those situations where the quantity of a BQ item which can not be ascertained from the drawings has substantially increased - such as the excavation of rock, but not to permit an extension of time being claimed where the substantial increase is due to an error in measurement, e.g. where there are 100 manholes shown on the drawings but only 50 measured in the Bills of Quantities.

The third significant amendment to Clause 50 is the inclusion of sub-clause 2(A) that makes it clear that if a contractor is in a period of culpable delay, and a further delay occurs for which the Employer is responsible (such as a variation), then the extension of time granted will be the time of the subsequent delay added to the original date for completion, i.e. a net extension not a gross extension to the end of the time when the Employer's delay is finished. This clause, whilst a significant addition gives effect to the decision in Chestermount Properties v Balfour Beatty, and may therefore be simply an express statement of the correct legal position.

Clause 78 - interim statements and Clause 79 - interim payments contain the only other interesting amendments in the 1999 Edition. In both these clauses it is made clear that materials on site to be included in interim statements and interim payments are to be valued as a percentage of the applicable contract rate and not at invoiced prices.

This is an odd amendment and whilst it is understood that this is to avoid potential arguments concerning whether such sums should be included in the Effective Value for the calculation of Contract Price Fluctuations under Clause 89, it will nonetheless be interesting to see how Engineers assess a bag of cement as a percentage of the rate for concrete.

In conclusion, the majority of the amendments are minor in nature, tidying up existing wording to equate to current situations. However, significant amendments are made to Clause 2 concerning the duties of the Engineer, Clause 50 concerning extensions of time and Clauses 78 and 79, concerning interim statements and payments, and quantity surveyors working for both professional consultants and contractors should make themselves familiar with these amendments, and their effect.
