From the Editor 編者話

The GPD Council will hold an APC workshop entitled "Property Development in Hong Kong - Professionals in Practice" on 11 July 2009 to help probationers to enhance and update their knowledge.

The BSD Council has set criteria for listing and delisting of building surveying firms in their website. The BSD Council will study the use of expert determination to settle disputes on building maintenance and management related matters. In order to attract more secondary students to study building surveying programmes, the BSD Council have set up a scholarship for secondary school students.

The BSD and QSD Councils jointly launched a new standard form of contract entitled "Standard Form of Contract for Decoration, Repair and Maintenance Works" on 7 May 2009. This new standard form is applicable to minor repair and maintenance works with contract price up to HK\$400,000. The QSD Council reached an agreement with China Engineering Cost Association (CECA) to arrange the second registration in June.

The PDD Council welcomes papers to be presented in the 5th Cross Strait Four Land Academic Conference on Land organised by the People's University of Beijing on 1-3 July 2009 in Kunming.

The Guangdong Property Management Association visited the PFMD Council on 23 April 2009. Both Institutes shared their experience and professional examination arrangements in property and facility management areas.

The YSG has co-organised some APC series for probationers in conjunction with the BSD, GPD, LSD and QSD. The YSG will also organise a mingle party with the Young Members Committee of Hong Kong Institute of Certified Public Accountants and the Hong Kong Institution of Engineers on 12 June 2009.

產業測量組將於2009年7月11日舉辦「香港的物業發展一專業實踐」 專業評該試工作坊,向見習學員講解相關知識。

建築測量組制訂了守則,以刊登或刪除於組別網頁內的建築測量公司 名單。建築測量組亦會研究讓專家處理樓宇維修及管理的相關糾紛。 為鼓勵更多中學生選擇就讀建築測量課程,建築測量組已為中學生設 立獎學金計劃。

青年組聯同學會其他組別,為見習學員舉辦一系列專業評核試的 工作坊。青年組亦聯同香港會計師公會及香港工程師學會的青年 委員會於2009年6月12日舉辦聯誼派對。

The following is a speech given by President Francis Leung at the HKIS Diploma Presentation on 22 May 2009

Distinguished guests, fellow members, ladies and gentlemen:

On behalf of the Hong Kong Institute of Surveyors, I welcome you all to tonight's Diploma Presentation Ceremony. I have prepared a speech, but in the relaxing atmosphere now built up after chatting with so many of you before the start of the Ceremony, I don't think I should read from my script.

Instead, I will speak around a few topics that I managed to pick up from the conversations with some new members, and share with you my experience. I have jotted them down. Please therefore bear with me if my speech will appear a bit disjointed.

First of all, I congratulate all of you who will receive your diplomas tonight. It is of course a day for you to celebrate your achievement. I would like to tell you that I feel equally excited. To have the opportunity to witness your success and present the diplomas to you is a great honour for me indeed.

The fact that I have the privilege of being your President does not mean I am any wiser or any more able than you. Yes, I might have been the mentor of some of you a few years ago when you were a student. I might have been the examiner on the interview board when you attended the APC interview. That was then. Today, after you have received your Diploma,



I cannot claim to be any superior than any of you, if "superior" is the right word. You and I enjoy the same "qualified professional surveyor" status. If you insist, there is one difference: I am on the downhill, agewise and contribution-wise, and you are on the uphill, with a brighter future ahead of you. Looking back your past 20, 30 years, the HKIS qualification might be one of your most important achievements. I hope looking ahead your next 20, 30 years down the road, you will see the HKIS qualification not as "the achievement" but "the springboard" for you to scale higher grounds.

To those who are qualified in your first attempt at APC, my heartfelt congratulations to you for a job really well done. To those succeeding only after more than one attempt, from your position now as a qualified member, I hope you will see the need for the Institute to uphold the highest quality of our members, even to the extent of having previously erred on the side of caution, for which I am quite ready to apologize.

In the early days when I studied management, some 15 to 20 years ago, the term "paradigm shift" was quite popularly used. I am not sure whether the term now means as much to you as it did to me, but I would like to share with you the following changes in focus of attention at various stages of academic and career advancement.

When you start out as a student, you <u>learn</u>. You are at the receiving end of education, taking in as much knowledge as possible.

In university education, the focus is shifted to **analysis**. It's no good to just take what you receive for granted. You doubt and challenge them, and accept only what you think is correct.

The real challenges only come after tonight, after you have attained your professional qualification. The real challenges are your ability to **generate solutions** based on what you have learned and the alternatives that you have considered, and be ready to be **responsible for the results and consequences**. Your ability to generate solutions, and your readiness to say you are responsible for them, in my opinion, are the key attributes that determine your development in the next 20, 30 years, your future as a qualified surveyor. As to the next "paradigm shift", you will find your responsibility becoming heavier. You are responsible for what you say and what you do, no longer just as an individual. You are responsible for them as a surveyor, representing our profession. Only one month ago on 26 April, the Institute celebrated its 25th Anniversary. As you will see the 25th Anniversary Logo on the backdrop behind me, our motto is "Building our Community, Contributing our Professionalism". I call upon everyone to bear this in mind. Think not only of yourself, but also our profession, and our responsibility towards society.

The next question is how you can contribute. We are a multidisciplinary Institute with expertise in General Practice, Building Surveying, Land Surveying, Property and Facility Management, Planning Development, and Quantity Surveying. While

our skills are diversified, we stay united as one Institute. The Institute works closely with the Government and many related organisations on many subjects touching



on planning, real estate, construction and facilities management and having a bearing on society. Cross-fertilization of our skills and speaking with one single voice are paramount to our success. As new members, I would like you to reach out, not only to other disciplines of surveying, but also to other professions with a view to building our community and contributing our professionalism. Straddling the various Divisions is our YSG, Young Surveyors Group. All new members below 40 years old will have already received relevant details about the activities that you may be interested to join and the services that you may wish to provide. You are welcome to talk to our YSG Chairman, Mr Joseph Chong.

I cannot fail to mention the adverse effects of the Global Financial Crisis. 2009 is definitely not the best year for you to become a qualified surveyor. The immediate effect is that a newly qualified should not expect a substantial pay rise, unlike what your seniors did in previous years. Job security is also a concern. At HKIS, we have set up a committee to look into ways of helping members through the Financial Tsunami, such as setting up a job market page and asking employers to sign up charters of no redundancy.

I am afraid that is as much as I would like to say for tonight, as I understand the Diploma Presentation is officially due to

begin. Because of the large number of members receiving diplomas, I am advised that the presentation will last for some 45 minutes, and dinner will not be served until after then!



I would like to close by once again welcoming all new members. I cannot over-emphasize the need for nurturing a sense of belonging to our big family. I would like to share my feelings and leave you with the following questions:

- Do you feel distressed when you hear bad news about surveyors, e.g. in February, when two of our members were sentenced to imprisonment on account of offences of dishonesty?
- Do you feel angry when you hear bad words and read unfair and unjustified reports about surveyors?
- Do you feel happy when you see positive coverage of surveyors in the media, and the respect that we surveyors command in society?

香港測量師學會會長梁立基於會員証書頒授典禮中致辭 2009年5月22日

各位嘉賓、各位會員:

我代表香港測量師學會,歡迎大家來到今晚的會員証書頒授典禮。 我原本準備了講稿,但於典禮開始之前與大部份會員傾談後,已經 建立了輕鬆的氣氛,我想之前準備的講稿已不再適用。但由於這原 故,我的説話可能有點零碎,請大家見諒。

我打算與大家分享一下剛才與部份新會員閒談的內容,以及我的個 人經驗。

首先,我衷心祝賀大家獲頒授會員証書。今晚是值得慶祝的日子, 我的心情與你們同樣興奮,我亦十分榮幸能向各位頒發証書,見證 各位的成就。

事實上,我雖然選為學會會長,但並不表示比會員聰敏或能幹。也 許若干年前我曾當過某些會員的導師,又或者曾經作為專業面試的 考官,但這些已成過去。今天,各位接過會員証書後,我不能再說 優於大家,因為我們大家都同樣獲得了「專業測量師」資格。

如果要堅持我與大家有所不同的話,只可説不論年紀和貢獻,我正 在走下坡;而在座各位的新會員正往上走,對未來充滿憧憬。回顧 你們過去的20至30年,獲取測量師學會的專業資格可說是人生的 一項重要成就。我希望於未來的20至30年,你們對測量師學會的 專業資格不再以「成就」來形容,而是個人發展的一個「台階」。

對於一次過通過專業考試的學員,我衷心祝賀你們所付出的努力; 對於經過重考的學員,今天能成為正式會員,我希望你們明白到學 會需要維持會員的專業水平,因此評核時有時或過於嚴苛,我希望 你們諒解。

大約15至20年前當我修讀管理學時,「思維轉換」的理念十分流 行。我不知道這個用辭現今是否依然普遍,但我想與你們分享一下 學術和事業發展於不同階段的轉變。

當你作為一個學生,是在學習階段,接受教育,汲取知識。

當接受大學教育,你集中於**分析**,不再單是接收訊息,而是對訊息 產生疑問、反覆思考,尋求正確答案。

但真正要面對的,是大家於獲取專業資格後出現的種種挑戰。真正 的挑戰是你如何運用專業知識來**解決問題**的能力、你可曾考慮的方 案,以及隨時準備對後果負上責任。在我來說,解決方案的能力、 個人的責任感,將會是大家於未來20至30年作為一個成功專業測 量師的主要關鍵。 於「思維轉換」的另一階段,你會發覺到個人的責任比以往沉重。 你將要對自己所説及所做的負責,既作為測量師,亦代表測量專 業。於4月26日,學會慶祝了成立25周年,而在我背後佈景版的25 周年標誌上,寫上了學會的訓言「測量邁銀禧、專業惠社群」,我 希望各位可以謹記這訓言,從今起不只是對個人,而且要對測量專 業、及從社會責任方面著想。

另一個問題便是你如何可以對學會作出貢獻。我們是一個多元化的 專業學會,當中的專業組別包括產業測量、建築測量、土地測量、 物業設施管理、規劃及發展、及工料測量。雖然我們分為六個組 別,但它們全屬於學會的框架之下。學會與政府及有關團體經常就 規劃、房地產、建築及設施管理等課題作出研究,學會的成功亦建 基於不同的專業意見下所歸納出來的整體立場。作為一位新會員, 我鼓勵大家向外發展,這不單是於學會的六個組別,而是擴展到其 他專業範疇,以建設社會及貢獻專業為目標。另外,測量師學會青 年組橫跨了六個組別,所有40歲以下的會員應已收到青年組未來 活動的詳細資料,有興趣參與的會員,可與青年組主席<u>莊學正</u>聯 絡。

我在此不得不提全球經濟危機對業界的影響。2009年未必是成為 專業測量師最合時的一年。最明顯的影響,便是相對以往,獲取專 業資格後的薪酬未必有太大升幅;穩定的工作亦不一定受到保障。 就此學會已成立委員會,探討如何協助會員渡過金融危機,例如設 立招聘網頁、及鼓勵測量師行及僱主簽署不裁員約章。

証書頒發儀式即將開始,今天出席領取証書的會員實在太多,相信 頒發所有証書需時約45分鐘,我亦留意到晚宴將於頒發証書後才 開始。

我再次多謝各位的光臨。歸納我今晚所説,大家建立對學會的歸屬 感至為重要:

- ✤ 於今年2月份兩位測量師因不誠實行為而被判處監禁。當你 聽到有關測量師的壞消息時,會否感到不安?
- * 當你聽到對有關測量師不真實或不公平的報導時,會否感到 憤怒?
- 當你看到有關測量師對社會的貢獻及正面評價時,會否感到 高興?

以上問題,謹留待大家思考。

由國家住房和城鄉建設部及香港特別行政區政府發展局合辦 的「2009內地與香港建築業論壇」,已於4月8日至10日於 四川省成都市香格里拉酒店舉行。論壇於1997年起每年舉 辦,迄今已是第十三屆。香港測量師學會、香港規劃師學會 及香港園境師學會獲委任為是次論壇籌備委員會的聯合主 席,並由香港測量師學會負責團員的報名事宜及聯絡工作。 是次論壇參加人數為歷屆之冠,港方報名人數達240人;中 方出席論壇的人數約150人,而學會亦因此委派了十多名不 同組別會員參與。

Building Surveying Division Chairman's Message

Kenneth Yun BSD Council Chairman

Major topics discussed in the recent Council meetings are summarised below for members' information.

Criteria for listing and delisting of BS firms in BSD website

Listing

The BS firm should fulfill the following requirements:

- (i) The firm must possess a valid Business Registration Certificate in Hong Kong;
- (ii) The firm must be providing professional building surveying consultancy services to the public;
- (iii) Having at least one corporate member of the Hong Kong Institute of Surveyors (the Institute) in the Building Surveying Division, being a director, partner or holding a senior position in the firm; and
- (iv) No director, partner or senior staff of the firm has been convicted of a criminal offence or has been suspended / expelled by the Institute in the past three years.

The Building Surveying Division (BSD) Council has sole discretion to reject, suspend or approve the application and its decision shall be final.

All listed firms shall renew their application on or before 15 January each year by providing their latest information through a prescribed form as decided by the BSD Council.

Any re-application from delisted BS firms shall be considered by the BSD Council as a fresh application.

De-listing

Any listed firms will be removed if:

- (i) They no longer possess a valid Business Registration Certificate in Hong Kong; or
- (ii) The number of corporate members in BSD, the Hong Kong Institute of Surveyors, does not reach the minimum application requirement; or
- (iii) Any director, partner or senior staff of the firm has been convicted of a criminal offence or has been suspended / expelled by the Institute; or
- (iv) Renewal application was not received by the Institute on or before 20 January each year or the next working day if it falls on a Saturday, Sunday or public holiday; and

(v) Subject to the resolution of the latest BSD Council Meeting.

Proposed Amendment to Air Pollution Control (Volatile Organic Compounds) Regulation

The Government has just gazetted the proposed amendment regulation to Air Pollution Control (Volatile Organic Compounds) Regulation on the following:

- (1) Control of Volatile Organic Compounds Contents in Adhesives and Sealants; and
- (2) Vehicle Refinishing Paints, Marine Paints and Pleasure Craft Paints.

The amendment regulation will be implemented in phases starting from 1 January 2010 as proposed.

Pilot Scheme on Expert Determination to settle disputes on Water Seepage Cases

In the first consultation paper of Mandatory Building Inspection Scheme (MBIS), the Government adopted our proposal to explore the possibility of establishing a new Building Affairs Tribunal in order to settle disputes relating to occupation of building, including water seepage and other building maintenance and management matters.

After the consultation period ended, we were given to understand that the possibility of setting up a new tribunal is diminishing as the Government is promoting alternative means of dispute resolution (ADR), such as mediation and arbitration rather than litigation. In order to pursue our expertise on settling disputes on building maintenance and management related matters, the BSD formed a working group early this year to study on promoting Expert Determination to settle such disputes. The working group is led by Mr Peter Wong with Mr James Pong, Mr Edwin Tang, Mr Gary Yeung, Mr Andrew Lam and Ms Margaret Chan as members. They are now working on a pilot scheme on expert determination to settle disputes





on water seepage cases. If you are interested to join the working group or contribute in this matter, please contact me or the BSD Council members.

Scholarship for Secondary Students

In order to attract more secondary students for admission to post secondary Building Surveying Courses, the BSD Council have decided to set up a scholarship for secondary school students with details as follows:

Background

 A building surveying scholarship under the sponsorship of the Building Surveying Division is proposed to be set up for Form 6 students in Hong Kong with a view to motivate them and promote the choice of building surveying as their further study.

Objectives

- To attract the attention of youths on the roles and functions of Building Surveying profession in Hong Kong;
- To promote the professional image of Building Surveyors; and
- To promote planning on careers in building surveying.

The Awards

- A scholarship each with a cash award of HK\$5,000.
- A total of ten awards will be allocated each year.

Eligibility

- Candidates for the scholarship should:
 - (a) Possess a valid Hong Kong Identity Card;

- (b) Have resided in Hong Kong for at least three years;
- (c) Be a full-time Form 6 student at a secondary school; and
- (d) Be recommended by their school principal.

Assessment

- The selection of awardees will be based on the following criteria:
 - (a) Academic achievement;
 - (b) Understanding and knowledge of Building Surveying profession; and
 - (c) Awareness of common building problems in Hong Kong and their social implications.
- Principals of selected schools will be invited to provide nominations. The nominated students will then be required to submit an article on a selected theme. Based on the submitted articles, candidates will be short listed for a casual interview.

We wish more proper yet simple contract terms could be adopted by the public with the use of this contract form.

Our spokesman, Vincent Ho had also represented the BSD in attending a Legco sub-committee meeting on the Buildings (Minor Works) Regulation on 30 April 2009. We presented our support to the new legislation and urged the early implementation of this control system so as to ease out the currently complicated submission procedure for those minor building works.



Assessment of Professional Competence Workshop

An APC workshop entitled "Property Development in Hong Kong - Professionals in Practice" will be held in the morning of 11 July 2009 to help probationers and students to enhance and update their knowledge in this area from four distinguished practitioners. Ms Daisy Wong, Senior Estate Surveyor of the Lands Department, will give an outline of the major aspects of development control under the lease conditions, followed by applications to vary lease conditions to implement planning intention. Mr Eric Ho, Senior Manager of Cheung Kong (Holdings) Ltd and Council Member of the GP Division will provide his side of the story as a practising surveyor. Mandatory Valuation Standards

On behalf of the GPD Council, I wish to remind members that the HKIS Valuation Standards on Properties (First Edition 2005) and the HKIS Valuation Standards on Traderelated Business Asset and Business Enterprises (First Edition 2004) are mandatory standards that all members have to follow. Moreover, members have to make sure these standards, rather than the ones that have been superseded, are quoted in their valuation reports.

The Board of Education will be conducting a meeting on 30 May 2009 with a view to improving the APC/ATC Rules and Guides for all Divisions.



Property & Facility Management Division Chairman's Message

Visit by the Guangdong Property Management Association (廣東省物業管 理行業協會)

The Guangdong Property Management Association (廣東省 物業管理行業協會) visited HKIS on 23 April 2009. The team of more than 20 delegates was led by its President Xu Jian Hua (許建華會長), Vice President Luo Xiao Gan (羅小鋼副 會長) and President of Guangzhou Property Management Association, Mr Li Zhuo Zhang. President Xu is also the Vice President of the China Property Management Association (中國物業管理協會副會長). They were received by our Vice Chairman Gary Yeung, Honorary Secretary Dick Kwok, Council Members Dr K W Lam and K S Wong. In the closeto two-hour discussion, members shared experience and professional examination arrangements in property and facility management areas from the Hong Kong and China perspective. Vice President Luo raised an interest in the HKIS Rules of Conduct and requested a copy for their future reference.



It was noted from President Xu that on the first series of professional examination leading to the China Certified Property Manager (中國物業管理師) qualification, Guangdong Province had produced the biggest group of successful candidates among other provinces in China. The first woman CPM, Ms Huang Hui Xia, the General Manager of Guangzhou Wannin Property Management Co. Ltd, also comes from Guangdong Province and was one of the incumbent visiting team members. It was advised by President Xu that the property management profession of Guangdong Province were indeed the forerunners of implementing professional property management service in China and it would not be surprising if it produces more professional property managers than other regions of China.

As the Association is also a member of the China Property Management Association in Beijing, it will also administer the professional examination of Certified Property Manager. We had expressed interest on how the professional property and facility management surveyors in Hong Kong may acquire the professional qualification in the Mainland. We also discussed the feasibility of mutual recognition between China Property Management Association and HKIS through the CEPA arrangement. President Xu suggested that mutual recognition may start from Guangdong Province first as this may be easier and more effective considering the close relationship between Hong Kong and Guangdong Province.

As time was short, it was concluded that HKIS would find an opportunity to visit the Association in the near future for more detailed discussions. The visit ended with a tour to our Learning Centre and library facility.

With the kind arrangement of Dick Kwok, the delegates visited StarCrest (星域軒), a luxury residential apartment in Wanchai on 24 April 2009 morning and shared experience with the concierge management there. The group was received by Kenneth Chan, Dick Kwok and Daniel Hui. The tour kicked off with a brief introduction and was followed by a welcome note. The concierge managers at StarCrest gave a detailed explanation of the management of the facilities. Throughout the tour, delegates had shown their enthusiasm in various aspects from the design of the club house to the implementation of green initiatives in the daily management operation. We exchanged our views on issues like preventive maintenance planning, budgeting, greening, etc. We also shared our experience and differences between Hong Kong and Mainland China. But more importantly, we all treasured this opportunity to have a better understanding of our counterpart which will undoubtedly attribute to the further development of our industry in Greater China. Standard Form of Contract for Decoration, Repair and Maintenance Works (2008, 1st Ed) 裝飾、維修及保養工程 標準 合約 (2008年第一版)

A standard form of contract titled "Standard Form of Contract for Decoration, Repair and Maintenance Works" was formally launched on 7 May 2009. This form of contract is applicable to minor repair and maintenance works with contract price up to HK\$400,000. It stipulates balanced rights and liabilities between property owners and contractors. A property owner can now use this standard form to formulate the contract with his contractor for carrying out minor repair and maintenance works for his property rather than relying on the quotation submitted by his contractor. This can avoid the situation where the quotation contains terms that are unclear in liabilities or unbalanced in risk sharing. The new form of contract should be able to minimize unnecessary arguments or disputes between both parties.

This new form of contract is attributable to the co-effort of the Building Surveying Division (BSD) and the Quantity Surveying Division (QSD). It was drafted by our ex-Chairman, Dr Paul Ho in conjunction with council members from BSD and QSD, and vetted by lawyers well experienced in construction law. The contract contains provisions to cope with the special features of repair and maintenance works pursuant to the professional advice of the members of BSD.

To cater for large-scale repair and maintenance works, another standard form of contract for repair and maintenance contracts is in the pipeline. Hopefully, this can be launched within this year.

Registration as Cost Engineers in China

This year, one of the main tasks of the Mainland Subcommittee, led by our immediate past Chairman, Mr Stephen Lai, is to arrange the second batch of HKIS members, who possess the necessary qualifications, to register as cost engineers in China.

Mr Lai together with our Vice-Chairman, Mr Antony Man brought us the good news after their visit to the China Engineering Cost Association (中國建設工程造價管理協會) (CECA) at the end of April. An agreement was reached



with CECA to arrange the second registration in June this year. CECA also indicated that another registration would tentatively be held by the end of this year. For those who would like to register later this year rather than in June, they should consider to prepare the required documents at the appropriate time.

Signing the Supplementary Agreement for extending the validity of the Reciprocity Agreement between CECA and HKIS (21-24 June 2009)

The existing Reciprocity Agreement between CECA and HKIS will expire on 25 May 2009. The QSD Mainland Subcommittee is now working with CECA for an extension of the validity of the Reciprocity Agreement by way of a Supplementary Agreement. The signing ceremony will be held on 22 June 2009 in Beijing. The President and I will lead a delegation for the signing ceremony and will also pay visits to various related government departments as well as the Tianjin Engineering Cost Association. Subject to the confirmation of the relevant government officials and parties, the scheduled itinerary is as follows:

兩地建設工程合同法律實務專欄 內地建築工程違約的賠償損失問題

前兩次專題中我們介紹了內地工程合同的法律體系及其 適用方法,以及同位階法的衝突解決方法,這是對內地建設 工程合同管理的法律事務最基本框架的勾勒。在此框架下, 怎樣運用內地建設工程法律來解決工程建設中發生的問題則 至關重要。在建設工程中,任何施工延遲、施工瑕疵都有可 能引起有關違約的爭議。如何提前瞭解或者正確估算違約情 況下雙方所承擔的責任和風險,是每個項目工程管理人員都 應當關注的問題。本專題將著眼於內地建築工程合同中的違 約金和損害賠償金問題,在今後的專題中,有關香港法律下 的損害賠償金問題也會有所涉及,從而在該問題上為大家提 供一個比較性的視野,便於跨境實務的操作。

一、違約金

違約金屬於中國合同法規定的違約責任形式之一。合同 法第114條規定: "當事人可以約定一方違約時應當根據違 約情況向對方支付一定數額的違約金,也可以約定因違約產 生的損失賠償額的計算方法。"由此可見,中國合同法中的 違約金是當事人對損害賠償額的預先約定。

二、損害賠償金

損害賠償金是中國法律下違約責任體系的另一責任形 式。損害賠償金,可以劃分為懲罰性損害賠償金和補償性損 害賠償金。

1. 懲罰性損害賠償金

懲罰性損害賠償金,是作為法律的特例而存在的。 內地法律中主要體現在:今年剛剛頒布的食品安全 法第96條;合同法第113條第2款提及的《消費者權 益保護法》第49條,以及《商品房買賣合同解釋》 第8和第9條。當然,由於上述規定均不涉及建設工 程合同糾紛,筆者就不贅述。

2. 補償性損害賠償金

除了上述幾種懲罰性損害賠償金是作為法律的特例

而存在的以外,法律中的大多數損害賠償金都是補 償性的,建設工程合同所涉及的情況也大多如此。

合同法第113條對損害賠償金的約定為: "當事人 一方不履行合同義務或者履行合同義務不符合約 定,給對方造成損失的,損失賠償額應當相當於因 違約所造成的損失,包括合同履行後可以獲得的利 益,但不得超過違反合同一方訂立合同時預見到或 者應當預見到的因違反合同可能造成的損失。"

根據上述規定,補償性損害賠償金,通常由兩部分 組成,一是實際損失,亦稱直接損失;二是可得 利益損失,又稱間接損失。一方面,實際損失的數 額,靠訴訟或仲裁中當事人雙方舉證來確定;另一 方面,為防止非違約方漫天要價,可得利益損失的 賠償在實務中有所限制,即不得超過"違反合同一 方訂立合同時遇見到或者應當預見到的因違反合同 可能造成的損失"。

為了非違約方與違約方權利與義務的平衡,除了上 述可得利益損失的限制外,根據誠實信用原則, 如果非違約方能夠採取措施防止損失擴大而未採取 的,不能就擴大的損失部分獲得賠償。

三、違約金與損害賠償金的運用關係

1. 懲罰性損害賠償金的特殊性

由於懲罰性損害賠償金是作為法律的特例而存在 的,因此,但凡出現上述的特例時,均優先適用懲 罰性損害賠償金。

2. 違約金與補償性損害賠償金

如上所述,建築工程合同糾紛多數是以補償性損害 賠償金的形式而出現的。此時,我們需要考慮的就 是,在建築工程合同中如果約定了違約金的金額, 而補償性損害賠償金(實際損失與可得利益損失的 總和)與其不一致的情況下,當事人應當如何申請 賠償的問題。

首先,違約金與補償性損害賠償金二者不可以併 用,只能擇一適用。其次,違約金與補償性損害 賠償金不一致時,根據合同法第114條第2款,違 約金可以進行相應的調整。這一點也在今年5月13 日剛剛施行的《最高人民法院關於適用<中華人民 共和國合同法>若干問題的解釋(二)》("解釋 二")第27條得到了進一步確認:"當事人通過 反訴或者抗辯的方式,請求人民法院依照合同法第 114條第2款的規定調整違約金的,人民法院應予以 支持"。

那麼,違約金的調整有哪些情況呢?

第一,如果違約金小於補償性損害賠償金,當事人 可以請求人民法院或者仲裁機構予以增加(合同法 114條第2款)。這裏需要注意的是,(1)只有當事 人提出請求增加違約金時,法院或仲裁機構才會考 慮是否增加違約金的問題,也就是説,法院或仲裁 機構是不能主動增加違約金的。因此,當建築工程 合同糾紛產生時,如果一方當事人發現合同中約定 的違約金的金額少於其受到的實際損失和可得利益 損失的總和時,其應當特別留意提出增加違約金的 要求,否則,其損失將很難得到全部賠償。(2)解 釋二第28條特別強調: "增加後的違約金數額以不 超過實際損失額為限。增加違約金後,當事人又請 求對方賠償損失的,人民法院不予支持"。由此可 見,即使違約金可以增加,也受到實際損失的數額 限制,也就是説,在當事人要求增加違約金的情況 下,增加後的違約金是無法補償當事人的可得利益 損失的。在建築工程合同中,由於合同標的都比較 大,可得利益的數額也比較大,因此,在當事人約 定違約金數額時,應當儘量預計到因為違約而產生 的實際損失和可得利益損失, 並儘量將違約金的數 額約定為涵蓋實際損失和可得利益損失的數額,就 防止了之後調整違約金時,可得利益仍然無法得到 補償的情況。

第二,當違約金過分高於補償性損害賠償金時,當 事人可以請求法院或仲裁機構予以適當減少(合同 法第114條第2款)。實務中有幾點需要注意。

- (1) 與上述情況一樣,只有當事人提出請求減少違約金時,法院或仲裁機構才會考慮是否的少違約金的問題。
- (2) 那麼,什麼是"過分高於"呢?解釋二第29條第2 款表明,如果違約金超過造成損失的30%,可以認 定為"過分高於"。
- (3) 當符合了上述"過分高於"的情況時,法院用何 種標準進行裁決呢?合同法採用了"適當"二字。 通常情況下,提出減少違約金要求的一方多是違約 方,法律既要保護非違約方的利益,又要保證違約 方因為違約而支付一個非常不合理的數額。為了保 證雙方利益的平衡,法律採用了"適當"的尺度, 對違約金的金額進行適當的調整。解釋二第29條對 "適當"的尺度進行了進一步解釋:"以實際損失 為基礎,兼顧合同的履行情時況、當事人的過錯程 度以及預期利益等總和因素,根據公平原則和誠實 信用原則予以衡量"。也就是說,與違約金低於補 償性損害賠償金的情況不同,在這裏當事人的預期 利益是法院考慮的範圍。

內地建設工程合同糾紛中的違約金,與香港法律規定 的一樣,都是當事人對損失額的預先約定。但是,內地法律 並不要求當事人在約定該賠償數額時,該數額是一個合理數 額,只要雙方當事人達成一致即可。也正是因為如此,在糾 紛發生時,法律賦予了對違約金進行調整的可能性,防止違 約金約定時明顯不合理的情況下當事人的利益得不到平衡的 情況發生。這一點與香港的法律有明顯的不同,我們還將在 之後的專題中提及。

English Summary Gilbert Kwok, FHKIS, LLB(Chinese Law)

In this article, we are explaining in some detail, under Chinese Law, the two different types of compensation available to an innocent party, namely general damages and liquidated damages, as a result of the default of the other contracting party and the relationship between those two types of compensation.

The Purposes and Practice of Construction Insurance

The YSG CPD event "The Purposes and Practice of Construction Insurance" was successfully held on 22 April 2009 at the HKIS Surveyors Learning Centre. Mr Adrian King, Senior Consultant of Aon Hong Kong Limited, presented the seminar to some 100 members attending.

The seminar started with an illustration of the relationship between risk and insurance. Adrian explained that insurance was a contract that acts as a risk transferring vehicle. There is no doubt that all parties at risk need to be insured. In construction projects, the stakeholders usually include the employer, project financier, consultants, main contractor and sub-contractors. Under the current practice, only those parties named in the insurance contract will be insured. In the talk, Adrian examined the complexities and pitfalls in different types of insurances. His experience in numerous examples of real case situations and claims were also shared during the seminar.

The talk ended with a conclusion and Q&A session. In the Q&A session, the participants exchanged their views and Adrian gave his opinion on the topic. For details of the presentation, please refer to the HKIS website.





HKSAR Conditions of Contract for Civil Engineering Works - Practical use of Important Clauses and Special Conditions of Contract for Mega Engineering Projects

care of the works and third party liability, works programme, re-rating due to changes in quantities and



Critical Aspects in Project Planning

The YSG CPD Event 'Critical Aspects in Project Planning' jointly organised with the Association of Project Management (Hong Kong Branch) was successfully held on 18 April 2009. We had the pleasure of Ms Amanda Wong and Mr K H Fok to deliver a valuable presentation/workshop to the participants.

Ms Amanda Wong is a council member of the Association for Project Management (Hong Kong Branch) and currently works as an Associate in Evans & Peck. Mr K H Fok has worked in various positions in Civil and Foundation Engineering for over 20 years, successfully managed more than 50 construction projects, and currently works as a Senior Associate in Evans and Peck.



Amanda presented a comprehensive account of the definition of project management and its application. In essence, she mentioned the importance of the life cycle of a construction project, which involved different stages. The consideration of various objectives in different stages (eg design stage) in a construction project is essential to develop a project plan. In addition, she showed the participants an example of phrase plan for large construction project which is fruitful. Moreover, she mentioned the essentiality of developing a project plan before commencement of the construction work and how to achieve a workable project plan by considering different goals of various stakeholders involved in the construction project. She also emphasized that the project plan should be presented in a way that all project team members can understand it and should be able to use it.



Mr Fok adopted a completely different approach from the traditional CPD events which were usually presentations. Mr Fok divided the participants into small groups of 5 to 6 people. He than required the participants to discuss various objectives of different stakeholders in different stages of a private sector as well as Government sector construction project. After the discussion, Mr Fok required each participant to give a brief presentation on what their group had discussed. After each presentation Mr Fok further elaborated on how to possibly achieve these goals in a construction project. The result was fruitful. Most of the participants had given a well structured and detailed presentation. It was surprising that some of the presentations were even beyond Mr Fok expectations. Awesome! Moreover, Mr Fok informed the participants that different stakeholders may be involved between the private sector and Government sector construction project. Finally, Mr Fok emphasized the importance to consider various objectives of different stakeholders before development of the project plan for a construction project.

On behalf of the YSG, Mr C W Tang presented a souvenir and expressed sincere thanks to both speakers for their valuable time and effort in conducting such an informative seminar/ workshop.
