The QSD Annual Dinner 2009 was held on 5 June at the Happy Valley Racecourse. They took this opportunity to present the 2008 APC Best Performance Award to a new member. The Pacific Association of Quantity Surveyors (PAQS) established the PAQS - Iwata Foundation for promoting the professional development of young quantity surveyors. The QSD Council Co-opt Member, Ms Tzena Wong was awarded a highly commended certificate for being the first runner-up in the essay competition.

A joint mingle party was successfully co-organised by the YSG, the Young Members Committee of the Hong Kong Institution of Engineers and the Hong Kong Institute of Certified Public Accountants at Pi Club. The YSG also formed a big team to participate in the Stanley International Dragon Boat Championships 2009 and won a trophy.

The PFMD Council has published a Guide to Good Property Management Practices which is to set a professional standard in practices in property management. This will be a good reference guide to members in undertaking their daily property management activities and duties.

The BSD Council attended the Mainland China and Hong Kong Construction Industry Forum in April. During this forum, they shared the views on sustainable quality maintenance and management of city and housing.

Have We Done Enough to Help?

The name of the dish was Fish Poached in Water (水煮 魚), a famous Sichuan (四川) dish, but don't be fooled by the name. In the pot there was not water but broth, thick oil, and lots of chili, in which slices of fish were brought to boil. Appearance did not tell all either. The host of the lunch always wore a smile on her face, but barely one year ago, she had lost her beloved husband and only son in the tragic earthquake that permanently changed the landscape and lives of Sichuan (四川).

My visit to Sichuan from 8 April to 12 April was brief, but the experience was vivid. The roads leading from Chengdu (成都) to Beichuan (北川) were winding. The mountains, miles of them, were filled with vibrant trees and plants. The scenery was strikingly beautiful. That this heavenly place had been the centre of a devastating earthquake was beyond imagination.

The villagers showed little trace of grief but their determination to rebuild their homes. Reconstruction works were everywhere, although nobody would think that the place would ever be the same again, physically or emotionally.

Lingering in my mind was the question: "Have we done enough to help?"

Immediately after the earthquake on 12 May 2008, the HKIS, led by then President Yu Kam-hung, reacted quickly by mobilizing surveyors to offer whatever we were equipped to help. By way of monetary donation, HK\$100,000 was raised. The sum was not insignificant, considering the short time span within which it was raised. As a professional in-

stitution, our more important contribution would be the pool of expertise in construction planning and administration. A list of volunteers, comprising over 100 members, was quickly drawn up. The focus of assistance was soon shifted from disaster relief to re-construction. The re-construction works required meticulous co-ordination efforts at provincial and national level. The HKSAR Government took up a vital role and was responsible for the re-construction of a number of sites including Provincial Road 303 (Yingxiu 映 秀 to Wolong 臥龍 Section) and the Wolong (臥龍) Nature Reserve Project in Chengdu (成都).



On the part of the HKIS, "engagement" was the key word in order that the momentum of members participation in the re-construction works would be maintained. In conjunction with other professional institutes, the HKIS worked closely with the HKSAR Government in rendering technical advice (subject to certain terms) to ensure proper delivery of the projects for which the HKSAR Government was responsible. In February 2009, HKIS entered into a co-operation agreement with the Zhong Hua Construction Foundation (ZHCF) (中華建設基金會), through which ZHCF immediately tapped the expertise of surveyors who were registered on the HKIS volunteers list, while the HKIS was able to work on projects that ZHCF had sourced or initiated. I would like to mention specifically Prof Lau Siu-kwan, Mr Yu Kam-hung (both being Past Presidents of the HKIS) and Mr Cheung Hau-wai (Ex-director of the Buildings Department, HKSAR Government) for their selfless effort in setting up the Zhong Hua Construction Foundation (中華建設基金會) and for allowing HKIS the opportunity to collaborate with ZHCF on such a meaningful course.

The first project covered under the co-operation agreement was Water Supply Reconstruction Project in Tongkau Town (通口鎮供水復修工程). Pipeworks which had been completely damaged after the earthquake were relaid and re-connected. Ten (10) surveyors were enlisted. They volunteered their time and expenses to help co-ordinate the project and conduct prudence audits to ensure that the pipeworks were built to specification and handed over to the habitants of Tongkou Town (通口鎮), the first "entry point" (通口) boardering between Chengdu (成都) and Beichuan (北川).

During the Water Re-connection Ceremony on 11 April 2009, we were greeted by villagers, young and old, all filled with joy. The earthquake might have shattered buildings and homes, but evidently not their confidence and cohesion. Amidst laughter, one tended to forget the trauma that they had gone through, and come to terms with.

會長的話 RESIDENT'S MESSAGE



If anything, the earthquake has brought out the positive side of us Chinese, as a nation and as a people. Less than two weeks immediately after the earthquake, a young university graduate from Shandong (山東) was on her way to Beichuan (北川). Like many of her schoolmates, it was her first time ever away from home. Fate had it that she was on a trip to help re-build a city and many homes, but because of the imminent danger, fate might have it that she would never return home again. As she recalled, there were many sleepless nights during her first few weeks in Beichuan (北 川), partly because of the overwhelming shock and trauma, and partly because of the countless aftershocks that seemed to forewarn of another more devastating quake in their wake.

One would have thought that it had been too much for a young lady to go through within barely one year. Yes, she spoke and behaved maturely, not hiding her sense of care and responsibility, but there was not a single trace of uneasiness or fear. In fact, half-jokingly, when she first met us and introduced herself, she said she was the *Xiao Mei Nu* (小美女, Little Beauty) from Shandong (山東).

Compared with what our counterparts in the Mainland have done, the contributions from Hong Kong become trivial. Hong Kong people have been well known for our resilience. We have survived and bounced back from several crises at society level, political, financial and public health. Yet, none

of our hassles came anywhere near what Sichuan (四川) people have gone through. I could not help wondering, if, god forbid, Hong Kong had been struck by the same earthquake, could we have come back in the same way, with the same strength and resolve?

In the years leading up to and after Reunification in 1997, Hong Kong has been emphasizing our "contributions" to the Mainland, as if we are superior than other cities. This may be true only if we are ready to acknowledge that, in many other ways, we are less competitive. In terms of money and manpower, our contribution to the Sichuan relief and reconstruction may have been substantial. However, in terms of dedication, commitment and personal sacrifice, I have yet to come across a *Xiao Mei Nu* from Hong Kong.

My question is no longer "Have we done enough to help?" Rather, I would ask "Have we done enough to equip ourselves to contribute to the big family?"

「我們的援助是否足夠?」

「水煮魚」是四川的著名菜式,但不要被菜式的名字誤 導。湯窩裡的並不單是清水,而是滿滿的湯、厚厚的一層 食油、大量辣椒和魚片一起煲煮。外觀亦不代表全部, 午宴的主人常常掛著笑臉,但一年前的地震中,她失去了 丈夫和兒子。一場無情的災難徹底改變了四川的面貌和生 活。

我於4月8日至12日期間到四川探訪,行程雖然倉促,但經驗仍歷歷在目。由成都至北川的道路雖然迂迴曲折,但景色極為秀麗,令人無法想像到這個怡人的地方竟是一次毀滅性地震的中央。

村民們似乎沒有一絲悲傷,他們決心重建家園。工程無處不在,儘管人們不會相信,重建後的家園將與以往相同。

在我腦海裡揮之不去的疑問:「我們的援助是否足夠?」 2008年5月12日地震發生後,應屆香港測量師學會會長余 錦雄隨即呼籲會員提供協助,並於短時間內籌得約港幣十 萬元,這數目可不算少。作為一個專業學會,更重要的是 對建築籌劃及推行提出專業意見。超過100名會員加入了學 會的志願義工名單,而學會的協助工作亦從振災推廣至災 後重建。重建工作需要省市的大力協調,而香港特區政府 亦負責協調多個地區的重建工作,當中包括「省道303線 (映秀至臥龍段)公路恢復重建工程」及「臥龍保護區規 劃編制專案」。

凝聚學會會員力量極為重要,因此學會致力維持會員於重 建工作的參與過程。學會聯同其他相關專業團體,與政府 保持緊密聯繫,對政府負責的重建項目提供了專業技術意 見。於2009年2月,學會與「中華建設基金會」簽訂了合作 備忘錄,基金會隨即從學會的義務工作者蒐集專業意見, 而學會積極亦協助物色專業人士共同配合並參與基金會所 推行的重建項目。我謹在此感謝劉紹鈞教授、余錦雄先生 〔兩位均為學會前會長〕及張孝威先生〔前屋宇署署長〕 成立「中華建設基金會」所作出的貢獻,並容許香港測量 師學會一同參與富意義的重建項目。

合作備忘錄的第一個項目是「通口鎮供水復修工程」,把 地震後已完全損壞的喉管重新連接。大約10位義務測量師 負責統籌該計劃,並進行了實地檢察,確保喉管工程峻工 後,移交給通口鎮〔成都和北川的第一個通口〕的居民。

於2009年4月11日的峻工儀式上,學會的代表受到村民的 熱烈歡迎。地震雖然粉碎了村民的房屋及家園,他們的信 心和凝聚力並未有任何動搖。他們也許適應了以笑聲忘卻 地震的衷痛。

這次地震顯現了中華民族積極優越的一面。地震發生後僅 僅兩星期,一名山東省的大學生踏上往北川的路途。與其 他同學一樣,這是她第一次遠離家鄉。她們旅程的目的是 幫助重建城市和家園,但任務險阻重重,可能使她們永遠 不能回家。她還記得,最初的幾個星期在北川時,晚上均 不能入睡,首要原因當是忘卻不了地震傷亡帶來的苦痛; 另外的原因是當地發生無數餘震,恐怕是另一場更具破壞 性地震的先兆。

或許有人會覺得,這位年輕女孩於過去一年內所經歷的實 在太多。是的,女孩以成熟的表現回應,並顯出她的一份 責任感。但她卻沒有一點兒不安和恐懼。事實上,於第一 次見面時,她半開玩笑地向我們介紹自己是一位「來自山 東的小美女」。

與國內的同胞相比,香港對重建工作所付出的實在不算 多。眾所周知,香港人擁有頑強的逆境自強能力。我們已 經從社會、政治、財政和公眾健康的層面渡過了幾個危 機。然而,我們遠比不上四川人民的經歷。我不禁想,如 果同樣程度的地震在香港發生時,我們能否以同樣的方 式,以同樣的能力渡過難關?

在97回歸前後,香港一直強調對內地所作出的「貢獻」, 這假設了香港優於其他城市。儘管實際情況是這樣,我們 必先承認在很多範疇我們的競爭力遠遜其他城市。從資金 和人力資源方面說,我們於四川救災和重建的貢獻確實不 少。然而,就個人承擔及無私奉獻而言,我還未遇上到一 位「來自香港的小美女」。

我現在的疑問已不再是「我們的援助是否足夠?」,而是 「我們是否已經裝備自己,為我們的大家庭作出貢獻?」



The 5.12 Sichuan Earthquake has lapsed more than one year, yet many construction projects in the earthquakestricken areas are still going on in full swing, striving to help the victims to resume their normal life as soon as possible. At the same time, the HKIS 5.12 Sichuan Relief Work Committee has been working closely throughout the past year with the HKSAR Government and various charity organisations, hoping to contribute our professional experiences and support for the implementation of the reconstruction projects in Sichuan.

During 22 to 24 June 2009, a Working Group of the Committee led by Mr YU Kam Hung and accompanied by



Daniel Hui, Eddy Cheung and Danny Cheng, paid a visit to look at the Salvation Army's (SA) programmes to improve the medical facilities and irrigation water supply system, which were seriously affected by the earthquake at Deyang (德陽市) in Sichuan. This programme included construction of 157 new medical clinics at Mianzhu (綿竹市), 72 at Luojiang Xian (羅江縣) and 68 at Shifeng (什邡市) respectively; upgrading the irrigation water supply system with 2.7km long water channel and planting of several thousands of trees at Luojiang Xian (羅江縣). The visit was successfully arranged and provided members of the Working Group a better insight of how SA had well managed the development and implementation of their re-construction projects. Major Tommy Chan, Sichuan Earthquake Recovery Project Director of the Salvation Army, also expressed his great appreciation towards the support and advice given by the Working Group during the visit and looked forward to the co-operation opportunity with HKIS in future.

2009年內地與香港建築業論壇

以下為黃山先生於4月在成都舉行的「2009年內地與香港建 築業論壇」中所發表的演講內容,現轉載與學會會員分享:

2009 年內地與香港建築業論壇

- 可持續城市形態:防災減災與優質建設-可持續城市與房屋的優質維修及管理

隨著城市的高速發展,人類對生活素質的要求不斷提高。房 屋從基本的居所要求到現在的各種訴求起了不少變化。無論 在設計、採光、空氣流、防火構造、逃生及環保各領域等都 不斷改進和完善。但現存樓房往往暗藏著災害威脅。在香港 來說一般以火災和山泥傾瀉斜坡倒塌威脅最大。

災害的威脅也可源自不完善的管理,違章改建、加建或改變



用途,而成為災害的源頭。此外,由於不少舊樓房沒有統一 管理的問題,因而缺乏維修及保養,導致日久失修、破舊; 窗戶飛脫、混凝土剝落及簷篷倒塌,而造成傷亡的個案也見 不少。剛才説過人類對生活的要求越來越高,而舊有的設計 跟新的需求有所差距,不論在環境、衛生、休閑設施及綠化 等等都未如理想。較為普遍的有多層樓宇沒有升降機、供電 不足、光線及空氣流通不夠、排污系統不完善和設施未有照 顧人口老化的需要等等。而一些舊樓房在設計階段未完全考 慮維修需要,往往造成維修困難、長期滲漏、維修成本高昂 及對住戶做成不便。若未能及時進行有效的維修,可能會造 成衛生問題。譬如、長期積水會導致蚊蟲滋生及傳播登格熱 病,長期滲漏會有細菌滋生及混凝土剝落的危險。

另外,建築物老化,外牆殘破對城市的外觀及形象有著深遠 的影響。身為國際大都會及金融中心,必須有一個整潔的市 容及緣化的環境,以乎合國際大都會的標準及地位。這對旅 遊、經商及生活環境,尤期重要。物業的價值,會因物業的 生命周期及經濟用途而轉變。物業往往因缺乏維修和改善, 可能空置而喪失他們應有的更高價值。

面對種種問題,究竟有何良策?現時香港所做的有幾個方



面。一是在可行的情況下提升現存樓宇的標準。這包括立法 及提供守則去實行;譬如要求73年前落成的商住樓宇提升 消防系統以及對一些高危的場所如卡拉OK及電影院等提高 審批的要求。二是加強執法,譬如跟據現有法例的權力,加 強巡查及發出違章通知,並要求在指定時間內完成拆除或還 原違章建築等。

除了以上方法,亦可透過教育及宣傳以提高居民的防患意 識。不同的電台電視宣傳、展覽、講座及研討會等,加強人 們對災害的警惕,加深瞭解物業管理及適時維修的重要性, 引入新的法例或標準有助於提供優質生活。譬如新的無障礙 通道守則,提升了新建及現存樓房對老化人口和殘障人士設 施的標準,締造更好居住的環境。而加強推廣優質給水、能 源效益標簽、進行能源及二氧化碳排放審計等,也有助於提 高生活素質。

香港和珠江三角洲地區的空氣污染和煙霧的主要來源是華南 地區的車輛、工廠和發電廠。香港特區政府和廣東省政府現 正聯合致力減少區內空氣污染物的排放量,目標是盡快遏止 區內空氣污染惡化,長遠令珠江三角洲地區的整體空氣質素 達致理想的水平。另外,政府幫助有需要的人士改善樓房災 害威脅,亦推出多項有償及無償貸款及物料資助,進行維修 及改善樓房工程。

香港以往只著重個別有商業價值的舊樓房的改造,對整體社





區的文物建築保育考慮較少。隨著市民對保育的意識增加及 對集體回憶的訴求;加速了我們對古物古跡,社區生態,活 化及保育等重新思考及訂定新方向。在這方面我們必須多向 祖國及其他大城市學習。在未來的日子,香港測量師學會將 會更積極參與樓房的改造、活化和更新、推廣及宣傳物業保 養、維修、管理方面的工作,為提高生活質素出一分力。把 香港建設成為一個可持續、優質的全球化城市。

"The Devil of Common Parts" - CPD event on 4 June 2009

I would like to give my sincere thanks to our senior BS members Mr James Kenneth PONG and Mr Gary YEUNG. They were the guest speakers of the CPD talk concerning "Common Parts/Area" which was well received by about 200 participants. As a surveyor, we must be aware that there may be different kinds of common area within the same development. Besides Estate Common Area, there may be Car Park Common Area, Commercial Common Area and Residential Common Area. When determining whether a certain area/part is a common area/part of the building, one should:-

(a) Study the assignment and its plan. If it is within the "coloured pink" area, that area/part is not a common area/part; and the liability of maintenance goes with the ownership even though it is in conflict with DMC (s.34H & s.34C(2) of BMO);

- (b) If there is no ownership from the assignments, study the DMC and its plan. If the DMC is silent, the principle of **So John**¹ case applies;
- (c) In interpreting the wording of DMC, Jumbo King¹ principle applies. If both the ownership under assignments as well as the DMC is silent, and So John¹ principle is inapplicable, Schedule 1 of BMO applies. An area originally allocated as common area/part cannot be assigned further without the consent of all the co-owners (Jikan case²). This is in line with s.34I of BMO.

The most important reminder is **Legal advice should** always be sought whenever in doubt.



CPD Report

The demand for high quality large format aerial photographs in Hong Kong is continuously increasing due to their variety of applications by different government departments and the public. To maintain the quality, the Air Survey Unit in Photogrammetric & Air Survey Section (PASS), Survey and Mapping Office, Lands Department, takes the initial step. It was our honour to have Mr Lee Kwok-leung, Land Surveyor/Air Survey, PASS, to talk about this issue in a CPD event "Aerial Survey in Hong Kong", which was jointly organised by HKIS LSD, LSGI and LSGIAA, on 2 June 2009. This CPD attracted 60 participants including professional members and probationers of different divisions and LSGI students.

Mr Lee firstly explained to the audience the elements in flight mission planning, which included the terrain study of the area to be covered, the consideration of the air

traffic situation, climate, cloud cover and sun angle and also the understanding of the product specifications, aerial camera and the aircraft to be used. With the above items considered, it had to go forth to make decision on the flying height, designing of flight plans according to different flying heights and judgement of forward motion compensation adjustment. Aerial survey equipment are crucial and essential during the acquisition of primary data, and Mr Lee introduced to the audience the functions and specifications of some of them such as the aerial camera, GPS navigation computer, file magazine forward motion compensation device, gyro-stabilized suspension mount and navigation sight telescope. The processes in conducting aerial survey, film processing, film scanning and colour enhancement were thereafter discussed one by one and Mr Lee wrapped up his speech by presenting some applications of aerial photographs, samples of aerial photographs produced in different eras and a conclusion.

The CPD ended with an interactive Q&A session where the participants on one hand keenly raised interesting questions and on the other hand, exchanged their views and shared their understanding in some advanced technologies. The event was successful. Our sincere thanks to Mr Lee for delivering such an informative and interesting seminar and sharing his valuable experiences.







兩地建設工程合同法律實務專欄 內地建築工程合同的繼續履行和採取補救措施

在上一次專題中我們介紹了中國合同法的違約責任體系下的違約 金和損害賠償金制度。除了違約金和損害賠償金兩種違約責任形式以 外,繼續履行、採取補救措施也是建築工程合同糾紛中可能涉及的違 約責任形式。

一、繼續履行

在金錢債務(合同履行標的為金錢性質的給付)中,違約方應 當無條件地繼續履行。在非金錢債務中(合同標的為非金錢性質的給 付)中,違約方應當有條件地繼續履行。合同法第 110 條對非金錢債 務的繼續履行規定了三個限定性條件:

 一是法律上或者事實上不能履行。法律上不能履行,例如合同 違反了法律的強制性規定或者與社會公共利益相違背,該合同就不能 履行。另外,如果出現了當事人約定的不能履行的情況,非金錢債務 就不能夠繼續履行。典型的例子是,《建設工程施工合同示範文本 (GF-1999-0201)》通用條款第27.2 條規定了四種可以不繼續履行合同 的情況:(1)單方違約導致合同確已無法履行,雙方協定停止施工;
 (2)調解要求停止施工,且為雙方接受;(3)仲裁機構要求停止施 工;(4)法院要求停止施工。事實上不能履行,例如如果合同標的物 為特定物,買方特別指定的某一特定編號的物料,A 明星簽過名的某 一張限量版 CD,如果該特定物滅失,則債務人因為陷入了事實上的不 能履行而免除了繼續履行責任。

二是債務標的不適於強制履行或者履行費用過高。

三是債權人在合理期限內未要求履行。如果履行標的是水果、水 產等季節性商品,如果債權人在該商品保質期內未能夠要求履行,債 務人為防止商品變質造成的損失而將沒有交付的部分商品轉賣時,債 權人就不能要求債務人繼續交付該季節性商品。

在建設工程合同中,"勘察、設計的質量不符合要求或者未按 照期限提交勘察、設計檔拖延工期,造成發包人損失的,勘察人、設 計人應當繼續完善勘察、設計……(合同法第 280 條)";"發包人 未按照約定的時間和要求提供原材料、設備、場地、資金、技術資料 的,承包人可以順延工程日期,並有權…(合同法第 282 條)"。以 上規定均是合同法總則中"繼續履行"在建設工程合同中的具體化。

當繼續履行不能實現時,非違約方仍然可能獲得其他的救濟。合同法第 112 條規定,"當事人一方不履行合同義務或者履行合同義務 不符合約定的,在履行義務或者採取補救措施後,對方還有其他損失 的,應當賠償損失。"這就保證了在上述繼續履行不能的情況下,非 違約方能夠得到公平的補償。

二、採取補救措施

採取補救措施適用於瑕疵給付的情況。合同法第 111 條規定: "質量不符合約定的,應當按照當事人的約定承擔違約責任。對違約 責任沒有約定或者約定不明確,依照本法第 61 條的規定仍不能確定 的,受害方根據標的的性質以及損失的大小,可以合理選擇要求對方 承擔修理、更換、重作、退貨、減少價款或者報酬等違約責任。"可 見,補救措施的適用規則是,當事人的約定優先。當事人沒有約定或 者約定不明確時,根據合同法第 61 條的規定(見本專欄第一篇《內 地建設工程合同法律及其適用方法》)進行解釋。此時如果還不能解 釋的,則受損害方根據標的的性質和損失的大小來確定合理的補救措 施。

當然,與繼續履行一樣,補救措施與賠償損失也可以並存(合同 法第 112 條)。"如果因為施工人的原因致使建設工程質量不符合約 定的,發包人有權要求施工人在合理期限內無償修理或返工、改建(合 同法第 281 條)";"因發包人的原因致使工程中途停建、緩建的,發 包人應當採取措施彌補或者…(合同法第 284 條)"。以上規定體現 了建築工程合同中有關採取補救措施的具體化規定。

三、繼續履行與違約金

從實務的角度,我們從以下兩種情況進行分析:

- (1) "當事人就遲延履行約定違約金的,違約方支付違約今後,還應當 履行債務,(合同法第114條第3款)。"可見,繼續履行可以 與遲延履行違約金並存。當然,這僅僅是對遲延履行約定了違約 金的情況;
- (2) 對於就不履行合同所約定的違約金,由於這是當事人對不履行合同造成的實際損失的預先約定,當事人也已經對整個合同不履行的損失作出預算,因此,根據當事人約定違約金的意圖來看,此時違約金與繼續履行是不能並存的,非違約方要麼主張繼續履行,要麼主張合同沒有履行的違約金。當然,這種情況下,如果非違約方主張繼續履行,還要受到合同法第 110 條的限制(上述)。

另外需要注意的是,如果違約金的金額足以補償非違約方的損 失,並且等於或超過合同完全履行所帶來的利益,那麼非違約方一般 就不可主張違約方繼續履行。原因在於,違約金具有補償性而非懲罰 性,當違約方支付的違約金超過了合同完全履行的情況下所能給非違 約方帶來的利益,那麼違約金已經補償了非違約方的損失。在這種情 況下,如果違約方還要繼續履行合同的話,就相當於非違約方既享受 到了合同完全履行的成果,又獲得了違約金的補償,這對違約方而言 是不公平的懲罰。



How Hong Kong can play key role in developing global valuation norms?

A YSG CPD event, 'How Hong Kong can play key role in developing global valuation norms?' was held successfully on 10 June 2009 at the HKIS Surveyors Learning Centre. We were most fortunate to have Mr Nicholas Brooke, Chairman of Professional Property Services Limited, to speak in the seminar.

With the backdrop of the financial tsunami, the old era of real estate investment has changed. The present valuation model is no longer sustainable. It gives rise to serious questions about a whole approach to valuation practice.

In the new era, Mr Brooke thought it was essential to have a new platform for repricing of risk of values for all asset classes by adopting robust and transparent methodologies. Moreover, a single set of globally recognised valuation standards is suggested to be adopted so that valuation can be more easily understood by people in different countries.

As a trustee of the International Valuation Standards Council (IVSC), he introduced us the nature and functions of IVSC. IVSC is a cross-organisation and cross-region body. It develops necessary procedures and standards for performing international valuations acceptable to the world's capital market organisations and participants in order to meet the challenges of a fast changing global economy.

Hong Kong has initiatives to be a pan-Asia valuation platform, acting as a point of reference and providing guidance on best practices and innovative valuation approaches. At the end of his talk, Mr Brooke addressed other issues that surveyors have to think about.

On behalf of the YSG, Ms Evangeline Chan, presented a souvenir and expressed sincere thanks to Mr Brooke for his valuable time and for giving a great presentation.

Green Series - Introduction to BEAM and its applications in practice
