PRESIDENT'S MESSAGE

Presidential Address

It is my honor to have your support and trust to let me be the President of the Hong Kong Institute of Surveyors ("HKIS") for the term of year 2011-2012.

Founded 28 years ago, HKIS is now one of the respected professional institutions in Hong Kong and is widely recognized by International professional organizations as well.

I have always been bearing in mind that our success is based on the contributions of members who have shown the highest standard of integrity and professionalism to the public over the years; all past and current council members and volunteers who have devoted their valuable time to run the Institute; and all staff at our administrative office who have worked so hard for members under limited resources.

In spite of this, we are well aware of that there are numerous challenges in front of us.

While we are pleased to see that Hong Kong shall further move toward universal suffrage, we acknowledge that the influence of being a member of functional constituency, at the same time, shall be diminished. We should be clear that the success of surveying profession is backed by the public and therefore we could be able to get a membership at the functional constituency at such time.

As such, we must continue to reinforce and enhance the image of surveying profession in the society. I believe the below are the fundamental elements of success of HKIS as well as the surveying profession:-

- (i) we set the standard;
- (ii) we set the best practices;
- (iii) we recruit the best quality members;
- (iv) we attract the public's attention through our professionalism; and
- (v) we protect interest of our members and the public.

We need to promote all of the above and our scope of competency to the public including the community in the mainland China. I believe, our spokesmen, including but not limited to our Vincent Ho and Dr Lawrence Poon, shall keep very busy in the coming years.

Looking forward, we shall address to the following issues which are on the pipeline:

Having the number of members near 8,000, it is time
to start reviewing the Corporate Governance and
Governing Structure to pave the way for our future
growth. Under the review, we should focus on how to
encourage our young members to participate in council
work and nurture them to become future leaders. Our

founding President, Mr FY Kan will lead a working group with members including two Past Presidents, Mr Daniel Lam and Mr Francis Leung, to study the above important topics.

- Strengthening our administrative support would enhance our services to members in a timely and quality manner.
 To take the first move, the General Council has approved the recruitment of a suitable CEO.
- We must identify and decide our future office premises by the middle of this year and take necessary follow up action. Our Past President, Mr Tony Tse is now leading a working group to handle this mission.
- We need members' support to achieve our goals.
 Communication is a key to have members to stay united, and through communication, we can gain their support by better understanding about our work. I anticipate that we shall organize more member forums to gather members' views and to update the latest moves on various topics.

There is pressure to keep up the good work under the leadership of the Immediate Past President. As the President

of this council year, I will apply the wordings that the IPP used in the annual dinner: I am "cautiously optimistic" to the work in the year ahead. I am sure I am not alone. The team over the years have proof that our members, like you, are always supportive to each others.

May I take this opportunity to say thank you to my father, one of the founding members and Past President of HKIS, Professor Francis Lau. Communication Meeting with Architectural Services Department

A communication meeting with the senior directorates of Architectural Services Department (ArchSD) led by Director Mr K K Leung and Assistant Director Mr S W Fong was arranged on 7 December 2011 shortly after the election of the new BSD council with the attendance of Mr Andrew Kung, Mr Kenny Tse and I as the representatives of BSD and the Professional Building Surveying Consultants Association (PBSCA). This is an annual event set up by ArchSD which provides an informal platform to exchange views and ideas on surveying profession and matters of interest to the attending parties. We took the opportunity to relate the practitioners' concern on the unhealthy fee competition to ArchSD's projects/ consultancies and suggest adoption of two-envelope system in consultancy services tender,

aiming at a more quality-oriented service delivery by the out-sourced consultancy services. On the other hand, the Director expressed his wish to have more building surveying firms applying for registration in the AACSB list of Building Surveying firm so as to ensure sufficient supply of resources to handle the forth-coming consultancy works from ArchSD. I would like to encourage the newly established private building surveying consultant companies to register as I can see there is great demand for building surveying services both from the public as well as the private sector in the coming future. Being registered in the AACSB list not only renders the firm opportunities to bid for the government and other NGO works but also provides it a quality label in competing other large scale private or quasi-government projects.

How much do you know about our BSD Council?

In this issue, I would like to introduce our **Expert Determination Panel** which is led by our Council members
Mr Peter Wong and Ms Margaret Chan. Why should we set
up this panel? To answer this question, let's have a better
understanding on expert determination!

Water seepage disputes are one of the most common disputes in buildings. HKIS has been receiving requests from parties in litigation for appointment of expert pursuant to court directions. A number of our professional building surveying members have been involving in preparing expert reports as well as acting as expert witnesses.

Whilst expert witnesses in traditional litigation proceedings would be required to address on the causes, provision of remedial proposal does not usually fall within their scope and is not an issue before the court. The court would have greater concern on the liability and the corresponding damages, while normally the grieved party would need a solution to stop the water seepage problem. This is where expert determination should be considered as an alternative to litigation.

Expert determination has long been widely accepted and used as a form of Alternative Disputes Resolution (ADR) in other countries such as the UK and Australia. Nonetheless, it has not gained popularity in Hong Kong as other forms of ADR e.g. mediation and arbitration.

The features of expert determination were discussed in the case of *Mayers v. Dlugash* [1994] 1 HKLR 442. Kaplan J said at p.444:-

"Arbitration is a tried and tested method of dispute resolution where the parties do not wish to litigate their differences before state courts. Expert determination, although having been used for centuries, is perhaps not so widely known. The classic features of expert determination are:

- (a) The expert makes a final and binding decision.
- (b) The decision can only be challenged in the most exceptional circumstances such as where the

- expert answers the wrong question (see Jones v. Sherwood Computer Services Inc. [1992] 1 WLR 277; Campbell v. Edwards [1976J 1 WLR 403 and Nikko Hotel (UK) Limited v, NEPC (1991) 28 EG 86).
- (c) The expert can be sued for negligence in the absence of an agreed immunity (Arenson v. Casson Beckman Rutley [1975] 3 WLR 815).
- (d) The expert's determination cannot be enforced as an arbitral award."

In brief, expert determination is a private and confidential method whereby disputing parties by agreement appoint an expert to determine a matter of fact, valuation or law in a final and binding manner.

With our expertise on building defect diagnosis, we are ready to provide expert opinion on the potential causes of water seepage, and more importantly the solution for such. Expert determination on water seepage disputes therefore can provide an effective and efficient solution for the parties in dispute to resolve the water seepage, saving parties' costs and effort to go for full litigation.

We believe that expert witness and expert determination on water seepage disputes would be areas which our professional building surveyors should further explore. That's why we have the Panel to promote on this area of specialization.

To echo the social and market needs on expert witness, we are preparing a list of expert witness and adjudicator for water seepage disputes so as to provide a platform for the public to access to these professional services. Consultation on Regulation of Sale of First-hand Residential Properties by Legislation

A Report of the Steering Committee on Regulation of Sale of First-hand Residential Properties by Legislation was just published the Housing Bureau. GPD Council Member Dr Lawrence Poon is the HKIS representative in the Steering Committee. He offers comments and suggestions on enforcement. A series of pragmatic recommendations in relation to the regulation of sale of first-hand residential properties by way of legislation are now introduced by the administration. A public consultation exercise on the proposed legislation is now being conducted.

In the past few months, Dr Poon gave advice on the types of, and specifications for, property information in relation to sales, including saleable area and pricing information in any types of publicity including sales brochures, price lists, show flats, and promotional materials at all stages of sale. He came up with practical recommendations to the Steering Committee. Members may wish to note the public consultation document and offer views to the Bureau, if appropriate.

How to become a World City: Lessons from London

Details In the immediate years, Hong Kong has a real opportunity to join the ranks of New York & London and beat the race

against Singapore in becoming a World City, and confirm its status as the global IFC in Asia. Facts and figures show that the one Chinese city that can reach World City status is Hong Kong but it cannot get there without the full support of China, specifically by implementing a 'One-Country, One-Market' policy that would increase the porosity of talents coming to Hong Kong. Hong Kong has severely underperformed in the past decade; from 2000 to 2010, total GDP per capita of Hong Kong only grew by 25%, whereas that of Singapore grew by 87%. While Hong Kong has the IFC-BEST* attributes, the government must implement policies to support this initiative. 

We have submitted our views to the Chief Executive relating to the 2011 Policy Address, in particular on (a) Determination of land boundaries and (b) Establishment of Cadastre system for engaging the public to participate in management of land resources of Hong Kong.





For driving the development of spatial data infrastructure, we have organized the conference on Spatial Data Infrastructure in Hong Kong on 12 May 2011. This event had created a platform to foster collaboration in the industry.

The conference is co-organized by HKIS, the IT Division of the Hong Kong institution of Engineers, the Hong Kong Polytechnic University (PolyU) and the Chartered Institute of Civil Engineering Surveyors.

In 2012, LSD will continue to strengthen our relationship with our International counterparts through international conferences e.g. FIG, SEASC and ISPRS and so on. We shall also enhance our communication with the Mainland surveyors through various discussions, meetings and conferences.

We shall ensure that we have close cooperation with the academia and provide HKIS views through various channels including regular liaison meetings and the Advisory Committee Meeting of the Department of Land Surveying and Geo-Informatics (LSGI) of (PolyU).

We shall conduct series of Continuous Professional Development (CPD) sessions for surveyors at all levels are designed to enhance members' knowledge and to share our knowledge with counter-parts.

We shall have to amend our Rules and Guide for the APC/ATC for our Division. The Divisional Education Committee shall study various possible options to ensure that LSD is able to widen our scope in addressing the needs to application of membership in both professional grade and technical grade.

Supplement VIII to Closer Economic Partnership Arrangement (CEPA)

The Government reached agreement with the Central People's Government on the enhancement of economic and trade co-operation and exchanges between Hong Kong and the Mainland China on 13 December 2011 under the Mainland and Hong Kong CEPA.

It is mentioned in the Annex page 15 under the supplement VIII to CEPA as saying that it is to allow Hong Kong permanent residents to take qualification examination for land surveyors in the Mainland, and a certificate will be issued to those who pass the examination.

- Presentation ceremony for the HKIS Quantity Surveying
 Division Scholarship was held at the HKIS Surveyors
 Learning Centre in September. 14 donors were invited
 to present the scholarship to the 30 awardees of
 the University of Hong Kong (HKU), the Hong Kong
 Polytechnic University (HKPU) and CityUHK.
- A training course on the Standard Form of Building Contract 2005 edition was arranged in October / November 2011.
- 26 sessions of CPD (including site visit) had been arranged in the last Council year.
- The new APC/ATC Guidelines were being drafted. It would be finalized and issued soon.

New Measures for Residential Flat Sales

After almost one year of study, the government is finally proposing new regulations for the sale of first-hand residential property. While it is a welcoming time for the whole society to re-examine how best to balance the wishes of buyers, developers and agents, it might be worth a bit of time to take stock of the present situation.

For developers, every development project is a massive investment, and there is no threshold for mistakes. How keen this competition is among various developers is never clearer demonstrated by the avalanche of new flats put into the market during the recent rather gloomy period. While logic would presume waiting until better conditions thus achieving higher prices a more prudent choice, the very real fear against a shrinking market would drive developers to snap up as many purchasers as available before demand dries up.

In this competitive and versatile industry, marketing plays an indispensable role as its ability to transcend a residential flat into THE PERFECT LIFE is crucial in clinching a sale.

In normal circumstances, a well thought out site should involve the marketing and sales team at its most initial stages in informing the development crew members about the latest market trends and position. The naming of the property is the first cannon of this long battle, and we would no doubt notice the similarities of diction used at a particular period of time. These names, as always bear no indication of the location or the caliber of its clientele.

The design of the common area may have little direct relevance to the quality of the internal part of each flat, but its significance in weaving the Perfect Life façade cannot be stressed more. High-ceiling domed lobbies glittering with palatial crystal chandeliers, replicas of famous artwork are the first greeting which meets the eyes of residents and visitors, and its grandeur certainly reinforces a good feeling of refined taste and culture. Inside a flat, a connoisseur grade coffee machine may not cost much for the developers, but its presence would increase the flat's value in the residents' mind, and ultimately, the price of the property. Moreover, such provisions would often overshadow other issues that are more important for the purchasers in making their decision to buy.

Media promotion and sales brochures are two powerful tools in creating an image of the perfect life, and they are definitely employed to the developers' greatest advantage. Presently it is not unusual to see minimal, if any, indication of where the property is located in advertisements. Nor is it uncommon for artistic impressions to as prominent or even sole representation of the development or surrounding areas. Photos in sales brochures are often big close-ups of scantily clad women relaxing next to shimmering blue, happy families looking into the horizon and cute grinning babies looking right at the reader. These may not be the most relevant images informing the details of the development, but nevertheless a great opportunity to highlight the bliss of living in the development regardless of the shape and size of the swimming pool and how the interior of the flat is really like.

Last but not least, show flats are the ultimate experience to the aspirations in a person's quality of life. It is the final step to put an abstract idea into reality. Designed by the best decorators with the goal to impress and dazzle, practicality may not be the priority in the innovative displays of fixtures and furniture. In certain cases, precision in the dimensions may even be in doubt.

With the publication of a report on regulating the sale of first-hand residential properties by legislation, it is the best time for all parties in the industry to ponder and contribute their insights, or the end result of these proposals may not be what the authorities intended.

Surveyors with their expertise and professionalism should voice out their opinion. This short report will be of utmost importance to the future layout of the industry, and as major stake holders we have the right and the responsibility to make sure the final legislation is well thought out, productive to Hong Kong's economy and protective to both buyers and sellers in the market.

The Contractor waives the loss and / or expenses for the 1st 'Certain' (e.g. 90, 120, etc.) days of EOT granted by the Project Manager – What are the implications under the recent High Court case Brington Engineering Ltd. v Cheerise Asia Ltd. [Aug 2011]

Introduction

Loss and / or Expenses claims launched by the Contractors are very common in Hong Kong's construction industry, both for building, civil or E&M areas. Generally speaking, the General Conditions of Contract and Special Conditions of Contract in various contracts have respectively stipulated clearly and precisely the requirements for applying for such claim and the conditions also being inserted clearly and in express terms. There are some hurdles to make such claim to be successful, namely time bar for the notice, submissions of substantiations, etc.

With reference to the entitlement of loss and / or expenses, recently some of the Clients / Project Managers, in particular those fast-track projects in Macau, stipulated in the Special Conditions that **certain 1st days (e.g. 90 days, 120 days) ("1st 'Certain' days Exclusion Rule")** of the entitled Loss and / or Expenses under the General Conditions, the Contractor should agree, during the tender stage, to waive claiming for such 'certain' days. This shall inevitably reduce the total amount of Loss and / or Expenses to be entitled by the Contractors at the end of the day.

In this article, I shall go through the recent High Court Case in relation to this subject matter, which a contractor was citing to support their claims of loss and / or expenses recently (at which project I have been working as the inhouse QS consultant for the Architectural firm).

Brington Engineering Ltd. v Cheerise Asia Ltd. [Aug 2011]

Facts of the Case

- 3 buildings had to be demolished in Central
- Plaintiff was a building contractor
- Defendant was a Sub-Contractor for hoarding and demolition works
- Dispute was on "Alternative Design"
- Contract period Date of commencement: 21.9.2007
 Date of completion: 16.6.200
 (270 days including Sundays + Holidays)
- Liquidated and Ascertained Damage HK\$7,000 per day
- Practical Completion 7.11.2008
- Loss and / or Expenses clause ("L & E Clause"):

"Notwithstanding the Special Conditions of Contract Clause SCC-11 and General Conditions of Contract Clause 24, it is now agreed after negotiation what you shall not be entitled to claim any loss and / or expense, extended preliminaries and prolongation costs whether directly or indirectly incurred in respect of any matter for which an extension of time has been granted pursuant to Clause 23 of the General Conditions of Contract for the first 120 days. From the 121st day of the extension of time onward....."

- EOT granted by the PM [total 68 days]:
 - (a) 51 days Hong Kong Electric's obstruction to the works
 - (b) 17 days late possession of site due to ground investigation works, change of shoring materials, disruption of site regular progress due to neighbourhoods emotional actions, making good of existing brick walls, additional works at the site boundary

Hence, the original completion date was extended from 16.6.2008 to 23.8.2008 (total 68 days extended)

Held

The Deputy High Court Judge, Ms. Teresa Cheng, SC held that:

- Clause 7 of the Sub-Contract Letter of Award (the above L & E Clause) refers to Special Conditions of Contract Clause SCC-11 (regarding Main Contractor's claim for extension of time) and General Conditions of Contract Clause 24
- It is expressly provided there that the sub-contractor shall not be entitled to claim any loss and expense, extended preliminaries and prolongation costs incurred in respect of any matter for which an extension of time has been granted pursuant to Clause 23 of the General Conditions of Contract for the first 120 days
- The ground investigation works (EOT granted 17 days as refer to above) was completed within that first 120 days

• The Defendant had to pay the liquidated damages in the sum of HK\$532,000 (HK\$7,000 x 76 days delay), being from the extended completion date (i.e. 23.8.2008) till the Practical Completion Date (i.e. 7.11.2008) [i.e. 76 days], times the rate of HK\$7,000 per day

From the above case held by the Judge, although Ms. Cheng did not mention any dismissal of loss and / or expenses claimed by the Contractor. However, it was undoubtedly and obvious that there was no loss and / or expenses granted to the Contractor by the Judge, as per the decision made by her honour. This was simply, to my understanding, because the EOT granted by the Judge (i.e. 51 days + 17 days => total 68 days) was all fall into the "1st 120 days Exclusion Rule".

Please note that this case's dispute was on Alternative Design issue but not on loss and / or expenses issue. As a result, the Judge did not address a lot in her decision regarding loss and / or expense. In relation to los and / or expense, it was a bit simple in this case that the 1st 68 days EOT granted, though not clearly specified by the Judge, should likely entitle loss and / or expenses pursuant to the Conditions (though I do not know what Conditions that particular project was adopted, as not mentioned in the case, most of the Conditions adopted in Hong Kong contain similar grounds for entitling loss and / or expense). As a result, the "1st 120 day Exclusion Rule" barred any loss and / or expenses being entitled by the Contractor for that 68 days.

The scenario becomes more arguable and complicated if relating to - when should be the start date of the "1st 90 day Exclusion Rule"? Should it be calculated from the 1st EOT day granted by the Project Manager / Architect, irrespective whether it was entitling loss and / or expense or not (e.g. grounds like inclement weather – only entitling EOT but NOT loss and / or expense), or should it be calculated from the 1st day of EOT granted that MUST entitling loss and / or expense?

The author has an interesting case in relation to when to commence the "1st 'Certain' day Exclusion Rule" recently and shall share with the readers in a later date.

The Re-establishment of DD Boundaries, a Fact Finding or a Law Bidding

On 29 November 2011, we received great honour to have Mr Leung Shou Chun MBE, HKIS Past President, to share with us the seminar on "The Re-establishment of DD Boundaries, a Fact Finding or a Law Bidding". The talk was well attended by over 70 members across different grades from different divisions.

In the beginning, the speaker delivered a message that the DD Sheet must be subject to interpretation by the expert, i.e. the land surveyor, and discussed the nature of DD Sheet, such as the errors and quality. For elaboration, Mr Leung explained with the citation from Land Court Reports, Newland Survey Report, Tate Survey Report and other various articles written by previous colonial land and survey officials.



Afterwards, he talked about the validity of the Block Crown Lease, including the DD Sheet, as a proper contract from the contractual spirit point of view and discussed about the interpretation of DD Sheet with the aid of different kinds of evidence. Throughout the speech, Mr Leung made use of interesting comics and real sample cases to illustrate his conception for the attendants' ease of understanding.

During the Q&A session after the speech, there was a comprehensive discussion among the attendants and our honorable speaker, and undoubtedly, everyone on the floor was enlightened on DD boundary survey, in both technical and legal aspects.
