Invited by a group of younger surveyors, I attended two social events – the Joint Institutions Drinking Party and the Surveyors Band S!R Concert 2012. Some may consider these social events to be targeted to our younger members, but they are for all members who want to connect with fellow members within the HKIS, as well as with professionals from other institutions. As these kind of events provide a friendly and relaxing environment, I am sure you will find them enjoyable. I look forward to seeing you at one of our future events.

Other than the social events, there are two events in September that are worth every surveyor's participation. By the time you read this message, the Joint Institutes' forum for the 2012 Legislative Council Election: Architectural, Surveying and Planning Functional Constituency (FC) on 4 September 2012 will have been held. This would be a prime opportunity to talk to the FC candidates before the voting day on 9 September. Besides, we should not forget the HKIS Annual Conference with the theme, "Development, Supply, and Utilization of Land in Hong Kong," which will be held on 15 September 2012.

Considering that mediation is getting more popular in dispute resolution, the HKIS Dispute Resolution Committee, which is chaired by Sr Daniel Ho, is going to organise a 40-hour mediation training course in October 2012 for members who are interested in being listed on the HKIS/HKIA joint panel of mediators and the HKIS panel of mediators. Please keep an eye on the registration if you are interested.

In 2010, the Institute launched a sponsorship for writing reference textbooks that are more relevant to local practice for the surveying industry and students. The institute is delighted that the first title published under the institute's sponsorship, Hong Kong Legal Principles: important topics for Students and Professions, second edition" written by Mr Stephen Mau, shall be published soon.

Apart from sponsoring the writing of reference textbooks, the HKIS has, from time to time, supported relevant research projects. The General Council recently approved the budget for the following projects: 1) a PDD Research Project –

Social Value of home ownership and residential stability – implications for long term land use planning; and 2) a QSD Research Project – Case Studies and a Survey of BIM Applications in the Hong Kong QS Profession.

The General Council has resolved to nominate Sr Ong See Lian as an Honorary Fellow at the coming Annual General Meeting. Sr Ong See Lian, Past President of the Royal Institution of Surveyors Malaysia and the Past Global President of the Royal Institution of Chartered Surveyors, has played an active role in surveying-related institutional works and training young surveyors all over the world. We look forward to our members' endorsement of the nomination.

Aims and benefits

The course recognised by the Hong Kong International Arbitration Centre (HKIAC) (subject to approval) aims to provide participants with 40 hours of mediation training (Stage 1) comprising lecture and practice in accordance with HKIAC Stage 1 requirements leading to Accreditation of General Mediators, and Assessment (Stage 2) based on successful performance as mediator in 2 simulated mediations based on the standard of HKIAC Stage 2 Assessment for General Accredited Mediators.

Participants who satisfactorily complete the course will be eligible for inclusion in the HKIS Panel of Mediators for contribution to mediation service under Joint Mediation Helpline Office Ltd and to apply for admission as a member on the HKIS and HKIA Joint Panel of Mediators for contribution to mediation service under the Standard Form of Building Contract (Hong Kong), and subject to approval become an Accredited Mediator of HKIAC. Certificate of Completion will be awarded to participants who have attained 40 hours attendance.

Course contents

Topics shall include and not limited to preparation for mediation, fundamentals of negotiation, different models of mediation, overview of mediation, roles of a mediator, sequential approach to mediation, mediator's functions, mediation techniques and practice sessions.

Colin J Wall BSc (Hons), FRICS, FHKIS, FCIArb, MACosteE, MAE, QDR, RPS(QS), Chartered Arbitrator, HKIAC and CIArb General Accredited Mediator

Colin J Wall, Managing Director of Global Mediation Services Ltd (GMS) and Commercial Mediation & Arbitration Services Ltd (CMA), is a practising mediator and has been organising and teaching commercial and construction mediation training courses for over 23 years. Colin has received intensive mediation training in the USA and elsewhere and is an experienced and active mediator. He is a Qualified Dispute Resolver of the Academy of Experts, a member of CEDR's panel of mediators and a Distinguished Neutral of the International Institute of Conflict Prevention and Resolution, a HKIAC Accredited General Mediator and a member of mediation panels in Italy, Singapore and the USA. Colin is also Co-President of the UIA Forum of Mediation Centres, a Past-Chairman of the Hong Kong Mediation Council, and a Past-Chairman of the HKIAC Mediation Group.

New APC and Revision Workshops

Members may be aware that after the EGM on 18 July 2011, a new APC scheme ("the New Scheme") took effect on the same day. The New Scheme recognizes importance of professional knowledge in specific areas and, as such, probationers undergoing the APC will have to attain a satisfactory standard in this respect. There are two parts under the New Scheme. Part I is a combination of: (i) 12 months' experience; (ii) 20 hours pre-qualification structured learning ("PQSL") for cognate degree holders [40 hours PQSL for those who are not] within 12 months before the Part 1 written assessment; and (iii) a written assessment of four papers. Probationers who pass Part 1 may proceed to

Part 2 if they have accumulated a minimum of 24 months of structured training. Part 2 is the submission of a critical analysis followed by an oral assessment.

During the transition period, candidates who enrolled prior to 2011 will be allowed to sit for the APC written examination which is to be held on 4 October this year. To help candidates with the APC written examination, the Education Committee of GP Division and the Young Surveyors Group had arranged seven APC Revision Workshops, which covered the entire syllabus. 

Before leaving this topic, I wish to thank the GPD Education Committee, the GPD APC Panel, and all the speakers, Sr Louie Chan, Sr Thomas Tang, Sr Edward Au, Sr Joseph Ho, and Sr Lawrence Pang.

The HKIS GPD Land Supply Working Group

In 2007-08 Policy Address, the then-Chief Executive announced to evaluate/ take on New Development Areas (NDAs) as one of Hong Kong's ten major infrastructure projects for economic growth. The NDAs shall provide quality living space in the Northern New Territories. The original planning study on the Northeast New Territories (NENT Study) was first commissioned in 1998. Several potential areas in Kwu Tung North, Fanling North, and Ping Che/Ta Kwu Ling were identified as suitable NDAs. The government recently revisited the need for strategic development areas in the New Territories and recommended proceeding with some of the NDA developments to address long-term housing needs and provide employment opportunities.

The Civil Engineering and Development Department (CEDD) and the Planning Department (PlanD) had jointly commissioned the Northeast New Territories New Development Areas Planning and Engineering Study (the NENT NDAs Study) in June 2008 to establish a planning and development framework for the Kwu Tung North (KTN), Fanling North (FLN) and Ping Che/Ta Kwu Ling (PC/TKL) NDAs to meet long-term objectives.

Public participation is crucial for the projects. Various public engagement activities have been carried out to incorporate the public's views into the planning and design of the NDAs.

The government has now prepared the Preliminary Outline Development Plans (PODPs) of the NDAs and has proceeded with the Stage Three Public Engagement to collate views on the PODPs to enhance the development proposals for formulating the Layout Plans.

In response to the PODPs, the HKIS GPD has set up a Land Supply Working Group (LSWG) to focus on the proposed NDAs and to respond to government's consultation by giving recommendations for ways that could help motivate the private sector resources to enhance land supply instead of simply relying on the government. The LSWG, convened by Sr CK Lau with members from different sectors, including Sr Charles Chan, Joseph Ho, Andrew Fung, Tony Wan, Edward Au, and Selene Chiu. They had conducted meetings to review the Government Land Supply Program, New Town Resumption Experience, and NENT NDA and Land Resumption procedures.

The NENT NDAs will offer chances to promote social and economic developments in Shenzhen and Hong Kong. It will also address the housing and employment aspects resulting from population growth by provision of approximately 533 ha of developable land. HKIS LSWG will solicit views from members and submit responses and comments to the government at various appropriate stages.



Joint Guidance Notes (JGNs) for Surveyors acting as Experts in Commercial Rent Reviews in Hong Kong Now Undergoing Legal Scrutiny

The document is being finalized. The JGNs are Joint RICS and HKIS Guidance Notes and not a Statement of Standard Practice. They are designed primarily to assist those who are appointed by the HKIS President, or directly by the parties, to act as experts in any rent review dispute. JGNs are intended to assist the parties concerned, and related parties, by making them aware of the procedures and issues that are involved. The JGNs are not intended to provide guidance to those acting as arbitrators, in which case other specific procedures will be relevant. A surveyor may also be called upon by the related parties to a Lease to determine matters in dispute, such as assessment of service charges or valuation in connection with an option to purchase. The JGNs are not intended to cover all such matters, but set out the basic principles in general terms.

When procedures for specific professional tasks are recommended in the JGNs, they are intended to embody 'best practices'. That is, procedures which, in the opinion of the RICS and the HKIS will meet a high standard of professional competence. The person appointed must exercise his professional expertise and judgment.

The JGNs are consistent with the standard practices and procedures adopted by RICS and HKIS. The standard practices and procedures have been carefully considered and revised to deal with common problems that have been encountered in the determination process, to facilitate procedures for the benefit of both the appointed Expert and parties to a rent review dispute.

The JGNs are based upon the laws and practices in Hong Kong.

When members are appointed to act as Experts, they are vested with substantial powers and the ability to determine the financial position of the parties to the dispute, particularly in view of the limited circumstances in which the courts will set aside the determination. The laws continue to evolve, so members have a professional duty to keep their knowledge of them up-to-date. The JGNs are relevant to professional competence in that surveyors should be up to date and should acquaint himself/ herself of the Notes within a reasonable amount of time of promulgation.

Vetting Panel for Real Estate Valuers and Business Valuers for Public Disclosure Purposes

As reported earlier, Vetting Panel procedures for Real Estate Valuers and Business Valuers for Public Disclosure Purposes were being reviewed. The Vetting will be on the recommendation of the Panel for Real Estate Valuers and Business Valuers for Public Disclosure Purposes ("Vetting Panel"). The GPD Council has resolved to conduct an annual review of the list of property valuers for undertaking valuations for incorporation or reference in listing particulars, as well as circulars and valuations in connection with takeovers and mergers ("the List"). Annual return in relevant form and declaration by members on the List shall be submitted to the HKIS. A declaration is to confirm that the subject member has fulfilled the necessary requirements for him/ her to be included in the List (including employment by a firm providing valuation services). The submission timing will be by the end of November each year. Announcements/

updates to the List will be made by the end of January in the following year. Updates to the List will be made by the end of July each year for new applications and/or applications for reinstatement to the List.

Recruitment of APC Assessors

The new APC scheme is now in force. The first Part II APC Assessment (i.e., the professional interview) will be conducted as soon as possible, which is likely later this year. Under this new scheme, the GPD Council will have to re-recruit assessors and provide training/briefing sessions to them beforehand. We anticipate that quite a number of assessors are required for the coming Part I and Part II APC Assessments. Consequently, we wish to invite members, especially senior members, to join the assessment panel that is about to be formed. Members will be informed of the arrangement in due course.

Reciprocity Agreement with the Chartered Institution of Civil Engineering Surveyors (Geospatial Engineering)

I am pleased to inform you that we signed a reciprocity agreement (RA) with Chartered Institution of Civil Engineering Surveyors (ICES) for three years between Land Surveyors and Geospatial Engineers on 3 August 2012.



The Signing Ceremony was held at the SLC in the presence of members from ICES and HKIS. Mr Andrew Keung, Chief Representative for Southeast Asia of ICES, and Sr Serena Lau, our president, signed the RA.



We are excited that the HKIS has entered the RA with ICES in the area of land surveying specialties – Geospatial Engineering Stream – in two years' time after the signing of the RA between HKIS (Quantity Surveying Division) and ICES (Commercial Management Stream). The RA marks a closer collaboration between the two organizations, and through the RA and other activities, we hope to foster the industry's development and communications around the globe.



With immediate effect, a LSD corporate member and/ or a LSD associate member of the HKIS in good standing who possesses one year's experience of post-qualification professional practice relevant to ICES (Geospatial Engineering Stream) and is able to pass a professional competence interview on his/her suitability for admission conducted by ICES may be elected as a member or technical member of ICES (Geospatial Engineering Stream).

Likewise, corporate and/or technical members of ICES who have one year of relevant post-qualification professional experience in land surveying in Hong Kong and have passed a professional competence interview on their suitability for admission conducted by the HKIS LSD may also be elected.



In order to ensure the quality and competence of members, both HKIS and ICES have established respectively a very stringent professional and technical assessment standard for the election of members. The RA offers an alternative exposure to members of both professional bodies to communicate and exchange with the practitioners in Hong Kong and worldwide.

The joint BSD/PFMD CPD event on the "Voluntary Building Assessment Scheme" was successfully held and received an overwhelming response from members, with a total of 65 participants joining this event. Thanks go to Jonathan Lee and Daniel Hui, who helped organize it. There is another coming CPD event coming up on 13 September 2012 – the "Seminar on the HKQAA Sustainable Building Index (HKQAA SBI)". We are proud to invite Ms Jorine Tam, Assistant Director of the Hong Kong Quality Assurance Agency, to be our honourable guest speaker. Funded by the sustainable development fund and launched in November 2011, the HKQAA SBI aims to enhance the quality and value of buildings by improving their property management quality. Ms Tam will share with the audience the HKQAA's key building sustainability concepts and introduce the newly-launched HKQAA SBI. So don't miss it.

Further to the introduction of the "Lifts and Escalators Bill," the EMSD is now drafting its relevant Code of Practice and Guidelines. Attention will be drawn to the "Responsible Persons' Guidebook for Lift Installation" (only the Chinese Version), which was updated on 24 May 2012 with the salient points given as follows:

● 按照《條例》第2條的規定,自動梯的負責人指:

自動梯的擁有人;或 任何其他對該自動梯有管理權或控制權的人。

但不包括任何只使用或操作自動梯、或進行有關自動梯工程的人。自動梯的擁有人可按照其需要,明確及清晰地賦予其全部或部分自動梯管理權或控制權予所聘用的自動梯負責人,及向該負責人提供足夠資料以便其能有效執行與自動梯有關的工作。

除自動梯的擁有人外,任何其他對自動梯有管理權或控制權的人,即負責管理或控制自動梯的人,包括機構及有關員工,以及受聘的物業管理公司及其代表員工〔如大廈管理人員〕,同樣被視為該自動梯的負責人。自動梯的負責人須按獲自動梯的擁有人賦予的職權,履行《條例》所載負責人的相關責任。自動梯的負責人可按照其需要,委任其僱員負責執行與升降機有關的全部或部分管理工作,並各有關員工提供清晰指引,以履行《條例》的要求。

如自動梯屬大廈或建築物的公用部分,而大廈或建築物又設有業主立案法團〔簡稱為「法團」〕,按《建築物管理條例》〔第344章〕,法團有責任履行自動梯擁有人的責任。 法團可委任合適的代理**〔如物業管理公司或工程顧問〕**代為履行《條例》所載關於負責人的責任。沒有法團的大廈或建築物,自動梯的擁有人將按大廈公契條文界定。

● 根據《條例》及《一般規例》的規定,自動梯的負責人須:

確保自動梯及其所有相聯設備或機械保持於妥善維修狀況及安全操作狀態。

為滿足以上要求,自動梯的負責人可直接或透過代理〔如物業管理公司或工程顧問〕聘用:-

註冊自動梯承辦商為其自動梯按法例要求進行定期保養工程。為有效監察承辦商的工作,自動梯的負責人應確保註冊自動梯承辦商所進行的自動梯工程已詳細記錄在工作日誌內,並加簽確認承辦商已完成有關工程。

註冊自動梯工程師按法例要求為其自動梯進行定期檢驗,以確定自動梯及其所有相聯設備或機械處於安全操作狀態。

若註冊自動梯工程師在完成檢驗後,發現該自動梯並非處於安全操作狀態,會在完成該項檢驗後的 **24小時內**,以書面通知自動梯的負責人及解釋不發出證書的原因。而該註冊自動梯工程師亦須以指定表格向機電工程署署長報告檢驗結果。自動梯的負責人在得悉自動梯出現破損或未能符合法例要求時,應立即安排註冊自動梯承辦商進行修正工作。

確保註冊自動梯承辦商為自動梯進行保養工程,及每隔不超 逾一個月為自動梯進行定期保養工程。

確保有效的「准用證」時刻展示於自動梯的層站毗鄰的顯眼 位置。

當知悉有嚴重的自動梯事故時,包括有人死亡或受傷、主驅動系統發生故障、自動梯的任何制動器、梯級鏈,驅動鏈或安全設備發生故障而引致的嚴重事故,須在知悉該事故後的**24小時內**,用指明表格以書面形式將該事故通知機電工程署及當時負責該自動梯的註冊承辦商。

負責人可於保養合約中列明註冊自動梯承辦商需代為執行上 述條例要求。自動梯的負責人可考慮與註冊自動梯承辦商制 定緊急聯絡方法,以便有需要時可盡快聯絡。

備存不少於最近三年規例指明的某些文件、「工作日誌」記錄。

當自動梯因涉及上文之嚴重事故,而自動梯的運作未能在該 承辦商獲悉有關事故的 4 小時內恢復時,負責該自動梯的註 冊承辦商須在自動梯的當眼處展示以指明表格填寫的告示通 報使用者,載明事故類別包括暫停運作的原因。

The greatest challenge facing in the youth generation is that of apathy. People at large have turned into human machines. Their means of contact with fellow humans are electronic devices. Human factors have faded away in the sands of time. They have lost track of our fellow human beings. We have lost that care and love the early societies shared. They believe in numbers and statistics more than we believe in goodness of human heart. They have suppressed their feelings of empathy. Suspicion has been embedded into their subconscious. They have let the media machine fill their souls with mechanical ideologies and numbness into feelings of empathy.

The media usually promotes sensational news by showing the most gruesome of the contents, and the awareness to deceive the vulnerable.

Because of the complexity of professionals' role and public demanding, clients and / or the public at large must rely on their judgment and expertise. Professional expertise must be applied with honesty, integrity, professional scepticism, self-regulated, and avoidance of misinterpretation.

The talk will not attempt to arrive at a definitive account of what the youth generation is today, but instead will share the situations on the era we are living through and the challenges we are facing. Professionals have to be honest about how care will be paid for and what might alleviate the potential strains. Professionals need to temper abstract political theories and technical arguments with a "nuts and bolts" understanding of how issues play out in the changing world.

Technical Visit to the Central-Wan Chai Bypass and Island Eastern Corridor Link

Although it rained heavily on 16 June 2012, 30 HKIS members were warmly received by the representatives of the Land Survey Section of the Consultant's Resident Site Office led by the Senior Resident Land Surveyor, Mr TN Wong, during their Technical Visit to the Central-Wan Chai Bypass (CWB) and Island Eastern Corridor Link.

We were first given an introduction and background briefing to the CWB project at the Community Liaison Centre in Central. Following that was a presentation of the technical specifications of Contract Number HY/2009/15, the Central-Wan Chai Bypass-Tunnel (Causeway Bay Typhoon Shelter Section), with particular attention being drawn to the land surveying profession's involvement, such as control establishment, deformation monitoring, the checking of contractor's works, etc. With the Consultant's kind arrangement, our members were able to travel to the Temporary Public Cargo Working Area (TPCWA) to have a closer view of the TPCWA and Causeway Bay Typhoon Shelter workfront from the Engineer's Representative's Office and perimeter walkway. In the meantime, the Consultant's representative unfailingly explained to our members what they saw and answered any questions they had.

Due to inclement weather, we missed the chance to take a boat tour and view the site closely from another side, but all of us agreed that this visit was very fruitful and are looking forward to visiting once again during the next construction phase.





Boundaries – What the Law Says

"Boundaries – What the Law Says" was successfully held on 21 June 2012. It was our great pleasure to have Sr Edmond Cheung Wai-man, Senior Land Surveyor at the Survey and Mapping Office of the Lands Department, sharing the results of his intensive research on various court cases that were related to the scope of land boundary surveying.

Sr Cheung first gave a brief introduction to the judicial system in Hong Kong, including Common Law, Equity Law, and Case Law. For better illustration, he then presented us with a series of court cases (in both Hong Kong and England) related to land boundaries, along with his analysis of the rationales behind the judicial decisions. Sr Cheung also shared his views on the rules of land surveying and how judges apply the rules. His knowledge inspired over 130 members from the different divisions and the seminar ended after an interactive Q&A session.

Sharing on the Site Visit in Science Park in August 2012





Introduction

Bridge is included in the definition of a 'building' in Section 2 of the Buildings Ordinance (BO). As a footbridge is a bridge used by pedestrians, it is straightforward to consider a footbridge as a building. In this article, I shall look at a few issues related to private footbridges within the context of the BO.

Footbridges outside lots

A footbridge may span two sites. It may also extend from a building to a plot of land on a street. In these two situations, the footbridges are outside the lots. One may wonder why footbridges, like most civil engineering structures, fall within the ambit of the BO.

Under BO Section 41(1), a building is exempt from the provisions of the BO if it belongs to the government. In determining so, one usually has to make reference to the status of the land on which the building stands. Cases in which the footbridge is situated over a street that is government land would qualify, but there is no record of this kind of street in the Land Registry.


Under a lease, a grantee may be required to construct a footbridge outside the lot. Invariably, the grantee would be required to maintain the footbridge and be responsible for matters arising from it until the government wants it back. Even so, there is usually no lease or tenancy in respect of the land on which the footbridge sits. As such, until its reversion, the footbridge will technically belong to the grantee. Hence, the BO applies to the situation, and formal prior approval and consent from the Building Authority (BA) are required for its construction.

When a footbridge falls within the ambit of the BO, the BA has to issue an occupation permit (OP) before the footbridge can be put to use. Very often, an OP would be issued to include both

the footbridge and the parent building. As the OP touches and is concerned with the land, it would be registered against the title of the lot. As such, the OP would contain the footbridge, which is outside the lot. This may look odd, as the description of the footbridge in the OP invariably reads something like "A footbridge spans Lot X and Lot Y over Road Z". On the other hand, the lot description of the parent building would be something like "within Lot 1234". Obviously, the lot description of the parent building is not suitable for the footbridge, as the latter is not within the lot. I would personally prefer a separate OP to be issued for the footbridge for the sake of clarity. In addition, when the footbridge reverts to the government, a new OP would not be issued for the parent building, as there is no new building (i.e., the OP would contain the footbridge forever). Furthermore, an OP containing the footbridge may give an impression to individual owners of the parent building that they own the footbridge. This is definitely not the case.

Footbridge containing a commercial area

In Hong Kong, there are some footbridges that contain commercial areas, but project over public streets. One may wonder if such footbridges contravene BO s. 31(1) (under which, no building can be erected on, over, under, or upon any portion of any private or public street) and if the commercial area is excluded from the gross floor area (GFA) calculation.

In this case, the footbridge is actually within part of the site. The part of the site occupied by the footbridge is demarcated not only by the usual two-dimension boundary, but also by a space defined by upper and lower limits by way of principal datum. The site is, hence, defined three-dimensionally. Consequently, this part of the site is over a street. Nevertheless, the footbridge is within the site and there is no issue with BO s. 31(1). In addition, the commercial area within the footbridge counts toward the gross floor area calculation. By the way, if part of the footbridge is provided to the public for passage, this part can often be exempt from the GFA calculation. A typical example is the footbridge at Citygate across North Lantau Highway.

I have to stress that the abovementioned example may not be the only way in which a commercial area can exist within a footbridge that projects over a street. There may be other circumstances in which the same can occur. Anyway, reference has to be made to the relevant special conditions in a lease.
