
Visit by the Qianhai Development Authority (前海管理局人力資源處來訪)

香港測量師學會周年研討會 - 專家探討香港土地發展、供應和使用

香港測量師學會於 9 月 15 日假座港麗酒店舉行一年一度周年研討會。研討會以「香港土地發展、供應和使用」為主題,探索香港土地未來發展的路向。出席的嘉賓及參加者逾200 人。

是次研討會邀得香港特別行政區政府運輸及房屋局局長張炳 良教授擔任主禮嘉賓並發表開幕演辭。

香港測量師學會會長劉詩韻測量師表示:「土地發展、供應和使用的問題,並非單靠任何建築技術、設計可以解決的。它涉及層面包含民生、房產市場等各類元素。測量師的工作便是用宏觀及理性角度檢視問題,從中平衡各方需要達到較理想的發展效果。通過舉辦跨界別研討會,較能具體及實際找到共識,有利香港持續發展。」

Promotion of the BS Profession

The BSD recently commissioned a structured public promotion programme with a view to elevating the awareness and recognition of the public of the building surveying profession. This was particularly important in advance of or in parallel with the implementation of the MBIS in the second half of the year. We plan to launch a series of publications and interviews in various media to foster more public attention on and understanding of the role of building surveyors. Members may note a recent profile of BS in the Hong Kong Economic Times (香港經濟日報). Besides, we will hold a road show, workshops, and seminars for the public and private building owners to brief and advise them on how to effectively handle the MBIS and our role in the matter of building safety. We wish that the events will help boost the image and identity of building

surveyors as "building doctors" and as experts in building maintenance and the repair, renovation, and revitalization of existing buildings, building controls, and the overall development and project management works.

Needless to say, we have not forgotten the pivotal support of new blood in sustaining the continued development and growth of the profession. School visits will be an important part of the promotional campaign. We are reviewing how to make better use of the e-media to let the divisional council reach members in a more accessible way so that members can be updated in a timely manner on the latest news, moves, and developments in our profession. Should you have any suggestion on other areas of improvement in this respect, please feel free to let us know.

BSD Scholarship for Secondary School Students

Invitation for nominations for the second year HKIS Building Surveying and Eddie Lee Memorial Education Foundation Scholarship for Secondary School Students has been tendered to about 400 secondary schools. We hope this event will echo our promotion of BS.

Sustainable building design

How much do you understand the building setback requirement in the SBD guidelines under PNAP APP-152? In a meeting between various professional institutes, the Buildings Department recently clarified that the setback requirement of building at a development site will also apply to all streets that abut the site, are less than 15m in width, and are not the only ones fronting the main facade of the building, as described under B(P)R 18A(3)(i)&(ii). Our definition of a "street" is any passage that has a width of 4.5m for the purpose of the SBD Guidelines. It does not matter if the street is for vehicular traffic or for purely pedestrian use.

Hence, a site with its secondary frontage facing a narrow street or lane of just 4.5m in width under the purview of B(P) R 18A(3)(i)&(ii) may also have to fulfill the requirement and set back the building by 5.25m in order to allow an overall width for a 15m wide street in the future. This may have a significant impact on small scale redevelopment sites in urban areas. The loss of podium level floor space below 15mH, in particular the ground floor area, may sometimes render the re-development financially infeasible.



The Buildings Energy Efficiency Ordinance

Members are reminded that The Buildings Energy Efficiency Ordinance (BEEO) will come into full operation on 21 September 2012.

Through mandatory implementation of the Building Energy

Code, the BEEO regulates energy efficiency standards of the key building services installations of prescribed buildings (except for units in industrial and residential buildings). Those installations include air-conditioning, electrical, lighting, and lifts and escalators.

CPD events

On 15 August 2012, a joint CPD with PFMD with the topic, "Voluntary Building Assessment Scheme," was held. To support the "Mandatory Building Inspection Scheme" (MBIS) and the "Mandatory Window Inspection Scheme" (MWIS), the Hong Kong Housing Society (HKHS) was commissioned by the government to implement the Voluntary Building Assessment Scheme (VBAS) with the objective of encouraging building owners to properly manage and maintain their buildings on their own initiative. Building owners were encouraged to appoint VBAS assessors to conduct their VBAS assessments. The speaker, Mr Augustine Chow of the HKHS, introduced the details of VBAS, its benefits and mechanisms, how to become a VBAS assessor, etc, to our members. A CPD on the APC Series - Design and Planning of Building Services was held on 17 September by Mr Nelson Ho. Mr Ho has shared his experience on how to properly design and plan of building services for the efficient operation of a building. I believe that our fellow probationers benefited a lot after attending the CPD.

The new Assessment of Professional Competence

The new Assessment of Professional Competence in Building Surveying officially took effect on 1 September 2012. This new APC regime is a unified training and assessment programme for both professional members (MHKIS) and technical members (AMHKIS) in building surveying. Candidates in different pursuits will follow different paths to qualification. The new *Rules and Guide to the APC* has specified a new mechanism for training and assessment while the parameters of the core competences of building surveyors have been updated. The roles and duties of counsellors have also been revamped.

In order to let members obtain a better understanding of this new system, our Divisional Education Committee (DEC) has organized several briefing sessions. The first briefing session was held on 28 August for all professional members as well as for probationers and students. The second one was held on 4 September for officers and trainees of the three largest local government employers, viz. ArchSD, BD and HD, while the third one was held on 24 September for all serving and potential counsellors and assessors.

New Development Areas in the North East New Territories (NENT)

Land is a scare commodity and also one of the most valuable assets in Hong Kong. A shortage of land supply in recent years has aroused much concern from the community.

In the past, development of new towns in the New Territories and reclamation were the main measures to address the land shortage problem. Other methods, including rezoning, urban renewal, and land resumption, have also been adopted to cater for housing, social and economic needs at different times. In recent years, the pace in the provision of developable land dropped drastically. One of the main reasons is the strong public's aspiration to protect and preserve Victoria Harbour as a special public asset and form of natural heritage conservation.


However, the surge in property prices and shortage in office supply has already urged the need for a steady long term land supply programme in Hong Kong. More land is required to accommodate the anticipated population growth, cope with public's rising aspirations for a quality living environment, and sustain economic development. In this regard, the government announced, in its 2011-2012 Budget, to conduct relevant studies and public engagement exercises to explore options for enhancing land supply by expanding land usage, and building up a land reserve in order to pool a sufficiently large area to ensure steady supply.

As indicated by the then Chief Executive in his previous two Policy Addresses, the government would aim to ensure a sufficient land supply in order to maintain a stable environment for the healthy and sustainable development of the property market. The proposed New Development Areas ("NDAs") in the North East New Territories ("NENT") are the prime land supply projects that are expected to ensure a medium to long term land and housing supply.






Proposed Land use in Kwu Tung North New Development Area



Proposed Land use in Fanling North New Development Area Land use






Proposed Land use in Ping Che / Ta Ku Ling New Development Area

The Planning and Development Study on the NENT, commissioned by the Planning Department and completed in 2003, identified Kwu Tung North, Fanling North and Ping Che/Ta Kwu Ling as suitable NDAs (i.e. the Three-in-One NDA Scheme) and confirmed their feasibility based on the findings of various planning, engineering and environmental assessments. But in view of the slow growth of Hong Kong's

population and housing demand in previous years, the NDA proposals were shelved, pending a comprehensive review of the need for strategic development areas in the "Hong Kong 2030: Planning Vision and Strategy" ("the HK2030 Study").

In 2008, the government carried out a planning and engineering study ("the P&E Study") on the NDAs in the NENT. The overall objective was to establish a planning and development framework for the Three-in-One NDA Scheme to meet long-term housing, social, economic and environmental needs, as well as to formulate an implementation programme. The P&E Study includes a three-stage public engagement. The Stage One Public Engagement, which was conducted from mid-November to December 2008, consulted the public at an early stage to generate discussions of key issues relating to the development of the NDAs. Stages Two and Three of the exercise will engage the public on the Preliminary Outline Development Plans ("ODPs") and Recommended ODPs, respectively. Taking into account the views received and results and recommendations of the technical assessments, the government formulated the recommended outline development plans (RODPs). At that time, the GPD Land Supply Working Group studied the proposals and forwarded a comprehensive response to the Stage Three Public Engagement.





Response of the HKIS GPD

1. Hong Kong Needs Long Term Planning of Development Lands

The NENT NDAs represent important sources of long term land supply for Hong Kong. The HKIS is aware that different views have been expressed in the community from different stakeholders, including the affected owners and occupiers.

Hong Kong does need to cater to the increasing demand for land for housing, employment, and other uses, which demand comes from the existing population and antrcipated growth. The long term planning and implementation of various large scale development areas, including the NENT NDAs, Hung Shiu Kiu, and Yuen Long South, are important for serving the people of Hong Kong.

2. Proposed Density and Flat Supply

The proposed development density in the three NENT NDAs (on average, 284 persons per hectare) is low when comparing to existing built up areas which on average would be close to 400 persons per hectare as revealed in the reclamation consultation document. The total flat supply would be in the order of some 53,800 for a total land area of about 533 ha. In the light of the planned availability of MTR and the very significant costs for resumption and infra-structure, the development density should be increased so as to make better use of valuable development lands to meet with the needs of Hong Kong. The new areas would also need critical mass of population to make the same lively and sustainable.

3. The Conventional New Town Approach

For the purpose of implementation, the government proposes to resume all the private lands in the NENT NDAs. The scale of resumption is very large, as the private lands amount to some 265 ha, or about half of the total development area.

The government uses the term "Conventional New Town Approach" to describe the resumption arrangement. However, it was noted that development of various new towns in the past were through both reclamation and resumption. The previous new town approach was

inclusive of land exchange and issue of land entitlements rather than pure resumption.

At the beginning of the year, the government stated in the Reclamation Engagement Digest that resumption "will cause local resentment if residents wish to maintain their rural lifestyle or are not satisfied with the compensation or re-housing arrangement. The land acquired can only be used for designated purposes, resulting in low flexibility in land use".

The proposed wholesale resumption excluding other options is a fundamental change in government policy as private developers/owners would not have the opportunity to apply for land exchange for development no matter their land holdings comply with the proposed town planning zoning for commercial and/or residential uses for example. This is another area which does not align with previous new town development practices.

The government suggests that this approach would ensure an orderly implementation of the NDAs. It, however, made no comparative information/assessment available from the government to indicate the timing and delivery of the development lands in its proposal as against the land exchange approach with initiatives from private owners. Whether the resumption approach could actually speed up the land supply in the NDAs could be uncertain due to the possibilities of some owners challenging the legal basis of resumption and thus delaying the implementation.

There are dissenting views relating to the resumption of private lands from existing owners and then selling development rights of them to other owners. The protection of private property rights is fundamentally important and it is possible to preserve these rights, whilst at the same time, serving the public needs. Had the NENT NDAs been implemented the way the government proposed, this would set a precedent for similar development areas in the future.

The land exchange arrangement has been an important source of land supply for several decades. If the underlying consideration for the exclusion of land exchanges in this exercise is to avoid the "perception"



of possible collusion between the government and the business sector", and if such an idea further develops, then land supply in Hong Kong would be much restricted as a result.

4. Resumption versus Land Exchange

The existing planning regime has been directing market forces for land assembly in the New Territories. Land exchange applications can then be made to reflect planning intentions and/or approvals.

Within the NENT NDAs, land assembly exercises have taken place that would have relied upon the public-private partnership concept. If the proposed resumption of the whole NENT NDAs were to be implemented, this could then mean an end to private land assembly in similar development areas and possibly other areas.

We urge that the government make an impact assessment of how this policy change would affect the private land exchange and housing production. As well as the cost implications of the government land supply through such route.

For implementation, further thoughts should be given to the land exchange option. Relevant negotiations of land exchange could commence as and when approved town plans are available. This should facilitate early availability of development lands and there is no need to wait until the completion of the resumption and clearance exercise. Opposition from relevant land owners would be reduced, if not removed entirely, and the initial capital layout of the government in terms of compensation can be reduced significantly.

5. Compensation arrangement

Details of the compensation arrangement have yet to be announced and the government has only indicated that this could be better than the Choi Yuen Village case. Exgratia payments were used in the Choi Yuen Village case to facilitate the resumption. These ex-gratia payments were intended to attract affected parties to accept the settlement instead of pursuing the statutory route of compensation.

We look forward to seeing the review results of the exgratia payment arrangement and the rationale behind the same. Such review should include the types of ex-gratia payment to be paid to occupiers like squatters on private and/or government lands which in turn would have impact onto market behavior. At the same time, it would be useful if there is another review of the section 12 (c) of the Lands Resumption Ordinance so that the market value of the lands reflecting the development potential can be fairly included in compensation assessment.

6. Professional Input from members of the HKIS

It can be foreseen that large scale resumption would take place in the NENT NDAs at least to implement public sector development, including infrastructure. Affected parties, including owners and occupiers, would need the professional services of private sector surveyors to assist them in the resumption process and compensation matters. Our Institute would be pleased to discuss with the relevant government officials the engagement arrangements of the private sector surveyors, so as to facilitate the process.

New GPD Fee Scale

WG on the new GPD Fee Scale will soon hold a meeting with the Acquisition Section of the Lands Department to discuss the adoption of a fee scale by the government. Regarding the fee scale in relation to the Competition Ordinance that was enacted on 14 June 2012, according to legal advice HKIS is an exempted body under the Competition Ordinance thus the fee scale/charges as set by HKIS would not violate the said Ordinance. However, the Council was brought to notice that if a fee scale was jointly set by two parties with a view to monopolize the market, such an act might have violated the Ordinance.



Construction costs for Land Premium Negotiation in the Valuation Liaison Meeting

As reported earlier that discussion with the government is in progress. A revised pro-forma for the calculation of construction costs prepared by RLB has been submitted to the Lands Department after a working session with it on 14 September 2012. The WG advised that this pro-forma was intended to be uploaded to the HKIS website for the use of those members engaged in such a premium assessment. RLB has yet to confirm the subscription service arrangement by the private sector. Members will be kept informed of the progress.

Recruitment of APC Assessors

The GPD has sent out invitation letters to senior members for their assistance in conducting the Assessment of Professional Competence (APC), General Practice Division (GPD) 2012, to act as assessors under the new APC Scheme.

Members may be aware that the new APC scheme is now in force. Under this scheme, all candidates are required to attend both the Part I (written test with four subject papers) and the Part II (professional interview) Assessment. During the transition period, the Part I Assessment for this year will still remain in the old format (i.e. one written assessment paper in which candidates are required to answer questions on specific areas within a time limit, normally three hours), and be conducted in an examination hall, while the Part II Assessment (i.e. the interview), would be conducted in the new format starting in December 2012.

Candidates who have completed their first year of training can sit for the Part I Written Assessment. As for candidates who have passed the Part I APC Written Assessment and have already completed two years of training, they will be eligible to attend the Part II Assessment in the same year. The Part II interview panel consists of a chairman and two members. The interview will take approximately 60 minutes. Candidates under the new APC Scheme are required to submit a Critical Analysis and a project (in written form) for their interviews. The interview panel shall make a recommendation after interview to the Institute if it accepts the candidate as a professional member.

In order to maintain professional standards at an acceptable level, the Institute require a large number of assessors, so members' support and participation are much appreciated. All members who have attained a minimum of seven years of PQE can act as APC Assessors under the new APC Scheme. Interested members shall complete the confirmation slip attached to the invitation letter (which was dispatched to members on 24 September 2012) and return it to Miss Katherine Kong of the HKIS by 5 October 2012. A briefing cum training session will be arranged for all registered assessors in October 2012. Members may also note that if they wish to apply for senior membership within the Institute, the hours devoted to the assessment will be counted as CPD hours subject to the guidelines of the Mandatory CPD scheme.

Please note that the **Supplement to the Code of Measuring Practice** has recently been revised and adopted by the HKIS for issue on 1 October 2012.

All HKIS members are bound to follow the Code of

Measuring Practice (*March 1999 Edition*) together with this revised Supplement to the Code of Measuring Practice (*1 October 2012 Edition*).

(Amendments are in bold)

Supplement to the Code of Measuring Practice

Preamble

This supplement is entitled "Supplement to the Code of Measuring Practice" ("this Supplement"). This Supplement should be read in conjunction with the Code of Measuring Practice published by The Hong Kong Institute of Surveyors in March 1999 ("the Code") and shall form part of the Code.

Saleable Area

Saleable Area shall include Balcony and other similar features such as Veranda and Utility Platform. The area of such features shall be measured from the exterior of the enclosing walls but excluding the full thickness of such enclosing walls which abut on the unit.

Saleable Area shall not include the items specified under Ancillary Accommodation. These items shall be separately measured and stated.

Ancillary Accommodation

Unless otherwise specified by members in their reports, the following items of Ancillary Accommodation shall be measured as follows and stated separately under Ancillary Accommodation:

Cockloft: the area of a cockloft shall be measured from the interior of the enclosing walls and shall include the internal partitions and columns within such cockloft.

Stairhood: the area of a stairhood shall be measured from the exterior of the enclosing walls and shall include the internal partitions and columns within such stairhood.

Bay Window: the area of a bay window shall be measured from the exterior of the enclosing walls or glass windows of such bay window and from the point where the bay window meets the wall dropping to the floor level of a unit excluding the thickness of such wall.

Yard, terrace, garden, flat roof, roof, air-conditioning plant room and lift lobby (including those expressions which describe the area between the lift and the unit): the area of such items shall be measured from the interior of their boundary lines, and where boundary consists of a wall, then it shall be measured from the interior of such wall.

Air-conditioning Platform

This item is neither Saleable Area nor Ancillary Accommodation.

Superseding

This Supplement shall supersede any other Supplement(s) previously issued.

Clarification

If members of The Hong Kong Institute of Surveyors have any doubt on the interpretation of the Code and this Supplement, they should seek clarification from the President of the Institute in writing.





in the New Territories range from 3 to 5. For urban areas, the plot ratios are usually 8 to 9 and for non-domestic developments, the plot ratio may go up to 15. Therefore, there is room for increasing the development density in the proposed new development areas if those areas are well supported by collective public transport networks such as the MTR.

NEWS

1. Ratio of public housing to private housing

Currently, over three million people in Hong Kong live in public housing, including flats sold under the Home Ownership Scheme, which is also a kind of subsidised housing. This amounts to almost 50% of the total population in Hong Kong. I considered it appropriate for the percentage of public housing in the new development areas in the Northeast New Territories to be 50% or a shade over it.

2. Increase in development density

At present, the plot ratios for most developments

3. Provision of job opportunities

Apart from supplying additional housing, the proposed new development areas must provide local job opportunities for people living there. The residents of Tin Shui Wai, who have to commute long distances to their jobs (assuming that they work) is a lesson to be learnt. The government should also expand the variety of jobs available so that people living in the new development areas could choose from industrial, clerical, or retail work. The government could also consider encouraging organisations or corporations such as banks, the Jockey Club, or airlines to set up back offices in these new areas. Tung Chung is a good example of this.



Chairman's Message

With the recent release of CEPA Supplement IX, Sr Stephen Lai, Chairman of the HKIS CEPA Committee, arranged a meeting with the Development Bureau on 22 August 2012. We met with Mr Helius Ng, Team Leader (Mainland Affairs), and Kelvin Lo, Principle Assistant Secretary (Works) of The Development Bureau, both of whom are the new officials in charge of CEPA issues after Mr David Tong left. Stephen kicked off the meeting with a brief summary and updated us on the latest progress of the mutual recognition between HKIS members and their Mainland China counterparts, including the professional qualifications of both parties. This was followed by each divisional representative presenting his/her own report on the respective progress made and the difficulties encountered. I again expressed my frustration about not being able to open a dialogue with the China Property Management Institute. Both Mr Ng and Mr Lo raised deep concerns about the hurdles we encountered and promised to assist us in overcoming them in any way they could. Our last request to the Development Bureau was our desire to restart the Annual CEPA Meeting in Beijing, which has been put off for years.





We invited Ir Dominic Lau and Ir Brian Leung of the Energy Efficiency Office, EMSD, to deliver a briefing on the Buildings Energy Efficiency Ordinance (Cap. 610) (BEEO) on 11 September 2012. The enactment of the BEEO is an important initiative for reducing the total energy consumption of buildings, which represented about 90% of Hong Kong's total annual electricity consumption in 2010, by enhancing building energy efficiency. The BEEO was gazetted on 3 December 2010 and became fully operational on 21 September 2012.

Under the BEEO, there are two subsidiary regulations: the Energy Audit Code (EAC) and the Building Energy Code (BEC). The EAC only applies to commercial buildings and the commercial portion of a composite building. The BEC covers a much wider

area (e.g. commercial buildings, the common areas of industrial buildings, residential buildings, composite buildings minus their residential or industrial units, hotels & guesthouses, educational buildings, community buildings, municipal buildings, hospitals & clinics, government buildings, airport passenger buildings, and railway stations). But it doesn't apply to small buildings, buildings with main electrical switches under or equal to 100A, historical buildings, Building Service Installations with specific operational & technical natures (such as fire protection, life safety, industrial undertaking, etc.), and buildings that will be demolished or redeveloped within 12 months.

Ir Brian Leung shared with our members those salient points under the BEEO, in particular the administrative procedures and introduction of Registered Energy Assessors. His speech received an enthusiastic response from the floor. Members are highly recommended to familiarize themselves with this new BEEO and its subsidiary regulations. We were also told that the EMSD intends to tighten the BEC requirements in a bid to align with international practices and technologies.

The HKIS was invited by the Development Bureau to suggest ways in which our members can contribute to and participate in the development of Qianhai. Surveyors in Hong Kong are widely recognized both locally and internationally as experts in real estate development. I strongly believe that with our relevant experiences in China and compliance with international standards, our professional members can play advisory roles in the various stages of Qianhai's development. At the startup stage, we can provide in-depth expert opinions on security, functions, space management, and human resources planning for single and/or multi-development projects. At the consolidation stage, we can contribute our experiences and expertise on green management, energy savings, air quality improvements, environmental education, sustainable development, and control. At the expansion stage, we can provide a platform for education, ideas, and good practice exchanges for green management initiatives and help Qianhai showcase its emergence as a world class green/sustainable cooperation zone.

The Organizing Committee of the 2012 Quality Property Facility Management Award (QPFMA) has been set up and is currently busy preparing for its launch, which should be announced by late October or early November. Again, the 2012 QPFMA is jointly organized by The Hong Kong Institute of Surveyors and The Hong Kong Association of Property Management Companies. Its main objective is to arouse greater public recognition of the industry and to pursue the betterment of business and the living environment by way of management excellence. I will keep members informed of its progress in due course.

Visit to Zero-Carbon Building

On 20 September 2012, some General Council Members and Divisional Council Members, including seven QSD Council members, viz. Vice Chairman Sr Keith Yim; Honorary Secretary, Sr KL Wong; the Past QSD Chairman, Sr Dr Paul Ho; Council Members, Sr. Dr Sandy Tang, Sr Thomas Tse, and Sr Jesse Wong; and I visited the Zero-Carbon Building. This project, located at 8 Sheung Yuet Road in Kowloon Bay, was developed by the Construction Industry Council in partnership with the government and is the first zero-carbon building in Hong Kong. The project comprised a threestorey building and a landscaped area with a total site area of 14,700 square metres. During the guided tour, we visited the exhibition and education areas, the eco-office, the ecohome and multipurpose hall in the building; the eco-plaza, the outdoor exhibition areas, Hong Kong's first urban native woodland, and the eco-café in the landscape area.

Highlights of the month

YSG Study Tour 2012 - Wuhan - 12 to 16 September 2012



A delegation of 25 members participated in the YSG Study Tour this year. The group experienced a direct high-speed rail journey from Shenzhen North Station to Wuhan Station in just 4 hours and 13 minutes. We visited a number of organizations in the government and academic sectors, including the State Key Laboratory of Information Engineering in Surveying, Mapping and Remote Sensing at Wuhan University (武漢大學測繪遙感信息工程國家重點實驗室), the Wuhan Urban and Rural Construction Committee (武漢市城鄉建設委員會), and the Wuhan Land Resources and Planning Bureau (武漢市國土資源和規劃局). On the third day, we visited three private state-of-the-art development projects in the city: the Hualou Jie Project (武漢濱江花樓街大型綜合項目) by Hutchison Whampoa Property (WH), the 1.5-km long "Chu River Han Jie" (楚河漢街) shopping avenue by the Wanda Group, and Shui On Land Limited's Wuhan Tiandi (武漢天地) developments. We also visited two famous tourist spots: the Yellow Crane Tower (黃鶴樓) and Red Cliffs (赤璧古戰場) on the fourth and fifth days.



The above visits provided us with a comprehensive overview, as well as a first-hand experience of, the rapid developments in the Wuhan metropolitan area. With its superb location in Central China and at the node of the high-speed railways network, along with its solid foundation in heavy industry and high-end technology, Wuhan has significant development potential in the coming decades.

Credits must go to our great Study Tour Organizing Committee led by Ms Mandy Ko. I would like to sincerely thank The Foreign and Overseas Chinese Affairs Office of Wuhan Municipal Government (武漢市人民政府外事僑務辦公室) and the Liaison Office of the Central People's Government in the HKSAR for their superb arrangements of the official visits. Special thanks go to Prof Xiaoli DING of the Department of Land Surveying and Geo-informatics at the Hong Kong Polytechnic University and Mr Winson Chen and Sr Martin Leung, our former YSG buddies, for connecting us to the relevant parties in Wuhan.

青年組武漢交流團 2012

香港理工大學土地測量及地理資訊學三年級學生 何智聰

身邊每位同學也選了不同地方作為他們的暑假旅遊勝地, 例如台灣、韓國等,但我卻選擇了由香港測量師學會青年 組舉辦的武漢交流團為我人生最後一個暑假添上了不少色 彩。

本人就讀香港理工大學土地測量及地理資訊學三年級。諷刺的是,讀了差不多兩年,仍對這科的認知一頭霧水。正當檢查學校電子郵件便發現香港測量師學會青年組舉辦的武漢交流團廣告,我二話不説便下了報名這個決定。首先,我希望參加這交流團能對我加深對測繪學的認識以及明白到將來投身測繪界是怎樣的一回事,亦能加深了解當地中國不同部門的運作及對中國文化的了解。不出所料,這次交流團不負所望,更使我獲益不淺。

在行程中的第一天,我們便去參觀武漢大學的測繪遙感信息工程國家重點實驗室。他們的技術真的使我們擊節讚賞。我完全沒想到測繪及遙感技術能應用在考古方面上,他們使用這種技術去保育敦煌莫高窟。再者,他們更研發了無人駕駛小飛機去收集三維空間數據用作保護文化遺產,真的令人嘆為觀止。此刻使我這隻井底之娃能大開眼界,明白測繪遙感技術除了用於建築工程外,仍能在保育文化上達到一定的成效。

另外,行程中的第二天便拜訪武漢市城鄉建設委員會及武漢市國土資源和規劃局。當中,正正能讓我充份了解中國

當地政府部門的主要工作及重點工程與其成果。與此同時,我們亦能看到武漢市在空間信息工程的建設上非常發達,他們的空間數據資源充足,能協助其他部門如測繪、交通等等作空間數據支援、全球衛星定位等服務。

此外,我們亦到訪中國武漢市其中三個分別由和記黃埔、 萬達及瑞安房地產發展的房地產項目,包括花樓街商住項 目、萬達楚河漢街及瑞安武漢天地,使我們明白中國內地 房地產的發展及建築格局,對中國武漢社區建設特色的認 知及其房地產的項目工程管理流程,亦能清楚了解香港與 中國武漢在社區建設特色上的異同。

除了學術交流,是次交流團也充份讓我們了解中國文化特色,我們前往赤壁回顧三國歷史,感受其三國文化的氣息。同時,我們亦參觀天下江山第一樓之黃鶴樓,細味樓內的詩詞歌賦以及代入當時詩人登上高樓遠眺的情景。

總括而言,是次學術交流團使我獲益不淺,不但能使我在 測繪及遙感、空間信訊的技術和知識上能得以根深柢固的 作用,從而使我更清楚了解自己就讀科目以及測量專業的 認知。加上,透過參過一些中國文化古蹟及建築,能加深 我對中國文化歷史上的見解,當然不少得藉此機會與隨團 廿多位來自不同背景、不同組別的團友交流,從而使我個 人成長能得以全面發展。



Visit to a Precast Products Factory in Dongguan

The QSD CPD Sub-Committee organized a factory visit to Dongguan Orientfunds Construction Material Products Co., Ltd. ("Orientfunds") in Dongguan on 14 July 2012. The factory covered a total floor area over 80,000m2 and boasted its own concrete batching plant, rebar bending and concreting yards, tile fixing yards, and storage areas. Its overhead gantries and tower cranes were fixed to mobilize its precast façade products.

Mr Benny Lee, Sales & Marketing Manager of Orientfunds, was kind enough to guide over 30 members throughout the factory visit. He also arranged an informative seminar in his office.

As presented in the seminar, the use of precast façade products can reduce the use of timber formworks on site and lower construction costs if the products are typical in shape. The use of precast façade products can also reduce the time for completing each floor cycle and eliminate the plastering and tiling works on site so that the overall construction time can be reduced. The quality of the precast façade products under factory-controlled conditions could be better than those cast-in-situ products on site.







As a result of this factory visit, our members gained some valuable knowledge on some environmentally friendly precast facade products. Everyone enjoyed the visit and the lunch organized by the QSD very much. I would like to thank Mr Benny Lee for sharing with our members his knowledge of the production and testing process of precast façade products, as well as the benefits of using precast facade products in the construction industry.









Visit to a Pre-mixed Plaster and Mortar Factory and Laboratory and an LED Lighting Showroom

The QSD and YSG jointly organized a site visit event to a premixed plaster and mortar factory on 11 August 2012. On 25 August 2012, the QSD organized another visit to an LED lighting manufacturer's showroom.



The plaster and mortar factory, "Eastern Pretech (HK) Ltd.," is located in Yuen Long and covers an area of over 60,000 square feet. It is a well-known local pre-mixed plaster and mortar supplier that offers a wide range of pre-mixed products to the Hong Kong and Mainland China markets. The objective of this visit was to introduce the pre-mixed plaster and mortar products and their applications to our members.



The site visit included a short presentation of different types of plaster and mortar, their components, and usage. Then we visited the factory production line to observe the systemic and automatic manufacture and packaging of plaster and mortar.

Moreover, the company representative demonstrated some laboratory tests to show the characteristics of the different plaster mixes. Finally, we enjoyed a delicious lunch together in Yuen Long's Tai Wing Wah Restaurant.



On 25 August, 2012, we visited the office of one of Hong Kong's popular LED lighting brands, "Optiled Lighting International Ltd.," in Kwun Tong (website: http://www.optiled.com/index.asp). During the visit, the company representative introduced us to the history and development of LED lighting, the advantages of and obstacles to using

this technology, and the cost and energy comparisons between LED lighting and compact fluorescent lightbulbs. He also provided an example of how to calculate the life cycle cost of LED lighting.







Later, Optiled's sales manager showed us different types of

LED products, including LED lamps, fixtures, and accessories. We shared our experiences on how to choose a suitable LED light and promote LED lighting to our clients.



Our members enjoyed both of these visits because they taught us so much about construction technology.

Lift Technology and Maintenance System - Visit to Service Headquarters of a Lift Company

The QSD CPD Sub-Committee organized a visit to the Service Headquarters of Otis Elevator Company (HK) Limited ("Otis") on 8 September 2012. A welcome speech and an introduction by Mr Simon Lo, Director of New Equipment & Contract Logistics Center of Otis, were given to more than 40 members who joined the visit. The visit included an introduction to the historical development of the vertical transportation industry and technical presentations on the latest lift technologies, such as a destination despatching system, which helps improve building traffic, and an energy-efficient flat belt technology with a regenerative drive system, which could help save energy use by up to 75%.



In addition, a tour of the Otis Center was organized for members, who were treated to a real life demonstration of Otis maintenace dispatches through their emergency hotline operations. The tour also included a visit to their product showroom, where members could touch and feel many real Otis products. We learned that a large portion of elevator/escalator maintenance works was done at the center, including maintenance planning, remote monitoring, and spare parts preparations. This was new us because we previously thought that all maintenance works were conducted on the job sites.

As a result of this visit, our members gained some valuable knowledge of the latest developments in Hong Kong's vertical transportation industry and the relevant codes development. Everyone enjoyed this visit and actively took part in the presentation sessions. I would like to thank Mr Lo and his team for spending their valuable time with us.

Permeable Pavers

BACKGROUND

Due to concerns over environmental sustainability, ecofriendly and green products have been receiving more public attention. BEAM Plus encourages the use of pervious materials for hard-landscaped areas. Permeable paving is the most popular material for this purpose. It is a term used to describe paving methods for roads, parking lots, and walkways that allow for the movement of water and air through the paving material into the subsoil.

TYPES OF PERMEABLE/PERIOUS PAVING

There are three main types of permeable paving used outside of Hong Kong:

(a) In-situ-cast homogeneous porous pavement





Porous Asphalt (PA)

Porous Concrete (PC)

(b) Grass pavers







Open Cell type

Open Joint type

(c) Porous block pavers





CHARACTERISTICS OF DIFFERENT PERMEABLE PAVINGS


In Hong Kong, only the grass pavers and porous block pavers are available in the market at present. The following table compares the characteristics of the different types of pavers:

POTENTIAL ADVANTAGES OF THE PERMEABLE PAVERS

According to various foreign publications, the permeable pavers system possesses the following benefits:

• Allows for vital water and air to penetrate to the rooting zones of trees/plants for healthy growth.



- Eliminates standing water/ponding from the pavement.
- Reduces excessive run-off during heavy rainfall.
- Traps pollutants in the soil for their gradual degradation while avoiding direct wash-off to seas/rivers, which would cause pollution problems.

- Relieves the heat island effect.
- Maintains an ecological-environmental balance.


DESIGN CONSIDERATIONS FOR PERMEABLE PAVERS

- For the permeability to properly function, the surface should be free of contamination by organic materials to avoid clogging.
- For best maintenance practices, periodic vacuuming and low-pressure washing is recommended to clear out voids in order to extend the pavers' functional life. However, this maintenance method is not common, if available, in HK
- According to suppliers, the infiltration rate of permeable pavers will decrease annually, but should stabilize with age (3-6 yrs).
- Some areas are not suitable for applying this type of paving, for instance, roads for heavy traffic, sloping areas, places with subgrades of low permeability, and places with a high probability of grit/soil blocking the pavers' pores.
- When applying permeable pavers to certain types of subgrade base, the construction of a storm water disposal system may be required.

SPECIAL PRECAUTIONS IN USING PERMEABLE PAVERS

(A) Porous Block Pavers

- (a) To ensure that the subgrade is permeable enough (California Bearing Ratio CBR>5% & infiltration rate>13mm/hr), it is recommended to excavate trial pits to test the permeability unless the supplier has the expertise to advise on the suitability of the subgrade.
- (b) In principle, installing subsoil drains may solve the problem mentioned in Sub-paragraph (a), but this may make the project not viable in terms of cost.
- (c) The supplier may recommend laying a geotextile under the block pavers to minimize uneven settlement. It is important to ensure that the permeability of the geotextile and that of the pavers are compatible and similar; otherwise, the permeability of the system is defeated by the less impervious geotextile layer.
- (d) The problem of staining or interstitial blocking of the pavers may occur. The specialist maintenance equipment for porous pavers, like a vacuum (suction) brushing machine, is not yet common, if it is available, in HK now.



(B) Grass Pavers

- (a) It is recommended to apply the open cell grass pavers to low/light vehicular traffic roads.
- (b) It is prudent to provide a flat pedestrian route alongside the grass paver area for the safe passage of pedestrians. An uneven surface will cause discomfort and perhaps injury to them. If the pavement develops many holes because grass cannot grow in a healthy manner, there is a genuine danger of pedestrians, especially the young and the elderly, twisting their ankles and hurting themselves.

- (c) Pavers with smaller slots for grass infills would likely create smaller problems than those with larger slots. Apart from the above, warning signs alerting people of uneven paving should be displayed.
- (d) Noise nuisances are likely to be generated when vehicles pass through the grass pavers. If the road is close to a residential area, the tenants living on the lower floors will be more affected by the noise. For drivers, they may complain that the road is not smooth enough for their vehicles.
- (e) Surface water drainage discharge, if not quick enough, would drown the grass areas with water and mud after periods of inclement weather.

(C) All types of Permeable Pavers systems

- (a) Generally speaking, it is not advisable to lay pavers on those surfaces near the top of slopes/retaining walls, as excessive subsoil water pressure behind may have an adverse effect on the stability of the slopes/ retaining walls unless a geotechnical assessment is done to confirm that there would be no safety problem.
- (b) A longer warranty period guarding against premature staining, discoloration, and other functional deficiencies is recommended.

CONCLUSION

In conclusion, permeable pavers do have specific environmental merits. However, the abovementioned technical considerations/limitations must be considered thoroughly before pavers are applied in a project.
