PRESIDENT'S MESSAGE

Presidential Address

Fellow members, good evening!

Thank you for coming to the Annual General Meeting of the Hong Kong Institute of Surveyors 2012. First of all, on behalf of all members, I would like to express my sincere gratitude to Sr Serena Lau, the Immediate Past President, for her excellent leadership, the members of the General Council and Divisional Councils for their immense efforts and valuable time spent on the Institute's affairs, and the HKIS Secretariat staff for their excellent support. Without their commitment and efforts, the Institute would not have experienced such success over the past council year.

Members of the past councils had put in a lot of effort to develop many major projects. We shall continue to build upon the solid foundation they left behind. One of the major projects is our new office premises. I would like to thank the Working Group for its efforts, from selecting the new location to the design, tendering, and monitoring of its fitting-out works. Now we are entering the construction stage and the fitting-out work should be completed by the end of January. The new office will be in full operation by early February.

Apart from the office relocation, the Institute shall continue to map out its future in a number of areas, including its corporate governance and governing structure, the possibility of direct membership, the feasibility of setting up an HKIS foundation and closer communications/ sharing/collaboration among the divisions. Working groups for the respective areas have been formed and will continue with their tasks.

Although the Institute is a Hong Kong-based Institute, our vision has always been global. Over the past few years, the Divisional Councils, the CEPA Committee, the Mainland Affairs Committee and the Mainland Forums have tried their best to make use of every channel to communicate with various leading international surveying organizations, world-renowned professional surveying and valuation institutes, related professional bodies and government departments on the Mainland to gain recognition for Hong Kong surveyors and explore opportunities for our members. We have entered into a number of reciprocity agreements with these organizations to keep up our international and regional profiles.

Growing presence in China - In view of the rapid development of many real estate projects in China, there are many opportunities for surveyors there. More members are now working on the Mainland. In order to have closer links and better communications with our Mainland counterparts and authorities, I propose looking at the feasibility of setting up a representative office in Beijing in the coming year. The HKIA has had a representative office in Beijing since 2006 and it has proven very useful.

It has long been one of the Institute's objectives to enhance its image and status, as well as that of surveyors in Hong Kong. Over the past council year, the Strategic Planning Committee resolved to make "Sr" the abbreviation of "Surveyor". I am glad to see members' acceptance and application of it. I am also glad to see an increasing public awareness and recognition of the Institute and surveyors after years of effort made by our members. We have also responded to the government's policy and public consultations promptly.

In the incoming council year, we shall continue to promote the Institute's image and the surveying profession, as well as start working on issues related to the identity guidelines on the use of our logo and its elements with the aim of conveying a consistent physical presentation of the Institute to the public.

Your recognition of our works and participation in our events and activities are highly appreciated. I trust that with your

continued support and inputs, we will be able to face any new challenge ahead in the incoming General Council.

The holidays are approaching. May I wish all of you a Merry Christmas and a healthy and prosperous New Year.



香港測量師學會 CEPA 代表北京訪問實錄

香港測量師學會代表團一行 11 人,由高級副會長兼 CEPA 委員會主席賴旭輝測量師率領,於 11 月 27 日至 30 日赴北京,拜訪國家住房和城鄉建設部,並與相關的 專業對口單位會面。訪京期間亦拜訪了國家人力資源及 社會保障部、國土資源部、商務部、中國資產評估協會 及中國土地估價師協會等。此外,代表團亦得到北京市住房和城鄉建設委員會的接待,與北京物業管理行業協會及北京物業服務評估監理協會的代表進行會議。代表團亦到訪了清華大學,與相關學者進行學術交流。



香港測量師學會代表團

學會此行目的主要瞭解相關行業的最新法規和政策、進行專業學術交流、尋求合作機會、以及增進內地與香港測量業界的交流。學會代表團除了高級副會長賴旭輝測量師外,也包括各組別的代表。此外,中聯辦教育科技部傅芃芃博士及國務院港澳事務辦公室交流司教科文處程遠先生亦協助了代表團悉心安排行程,程遠先生亦隨團參與會議。

11月 28 日早上,代表團抵達國家住房和城鄉建設部 (住建部),與計劃財務與外事司巡視員鄭淑玲會面。會上,學會高級副會長賴旭輝測量師介紹了各組別與內地相關對口單位的專業資格互認及專業人員註冊情況。鄭巡視員亦向代表團講解了行業的最新法規,以及專業人員註冊的管理辦法。學會規劃及發展組理事梁家棟博士測量

師向鄭巡視員表示,得悉中國工程諮詢協會與學會規劃及發展組的專業相近,希望住建部可協助聯繫該會。鄭 巡視員表示與該會熟絡,並隨即致電該會,並安排於11 月30日早上約見。

拜訪住建部期間,代表團亦會見了中國建設工程造價管理協會及中國房地產估價師與房地產經紀人學會的代表。學會工料測量組主席何國鈞測量師表示,於 10 月下旬,國家住房和城鄉建設部公佈了第四批造價工程師(香港)初始註冊的人員名單, 65 名香港地區申請獲得批核,有關的頒証儀式將於 12 月 12 日於深圳舉行。至今,香港地區共有 144 名會員成功註冊為內地造價可國等地產相與測量師表示,學會高級副會長賴旭輝測量師表示,學會國內地產相便師與房地產經紀人學會舉辦了兩次互認等,成功通過考核並獲取內地資格的香港產業測量師或為則量資產評估師及土地評估師進行專業資格互認,,並加強中港兩地的專業發展及融合。

小休過後,中國建設監理協會及中國物業管理協會的代表亦參與會議。學會建築測量組副主席龔瑞麟測量師表示,現時通過與中國監理工程師協會的資格互認協議,已有 228 名香港建築測量師獲取了內地監理工程師註冊資格。但由於相關註冊規定的限制,目前只有 2 位能成功註冊為內地註冊監理工程師;亦因為工商登記的限制,香港建築測量師未能於內地設立工程監理企業,而只可以以諮詢服務的形式或業主身份在內地從事相關工作。

學會物業設施管理組主席郭岳忠測量師則向中國物業管理協會的代表介紹了組別的概況,就香港物業設施管理測量師於內地的發展作出專業交流。該會秘書長柴勇表示,與香港物業管理測量師不同,中國物業管理師的培訓及註冊是分別獨立處理的,這制度的差異亦窒礙了雙方進行資格互認的可行性。郭主席期望以及柴秘書長亦認同日後兩會進行更多聯繫和實質合作,與該會於國內合辦培訓講座及研討會等,推廣行業資訊。



及後,代表團拜訪了中國資產評估協會,與該會副秘書長韓立英及其他協會代表會面,學會產業測量組副主席何展才測量師介紹了香港的產業測量專業在商業評估業務的發展,及介紹了學會現有的物業評估準則及商業評估準則,以及學會將於 2013 年出版之綜合資產評估準則;韓副秘書長則介紹了內地估價行業的概況。雙方希望日後加強合作,為兩地的商業評估專家提供一個知識交流的平臺;何展才測量師承諾安排日後有關的交流。學會亦期望可按相關規定,研究探討雙方進行資格互認的可行性。

另外,學會規劃及發展組理事梁家棟博士測量師於同日(30日)上午到訪中國工程諮詢協會,約見了該會副會長兼秘書長唐萍及副秘書長陳杰等,探討規劃及發展組與該會合作的空間。期間,雙方同意稍後簽署合作備忘錄,以加深兩會的連繫及開展合作。

代表團隨後到訪清華大學土木水利學院,與土木工程系 馬智亮博士及建設管理系系主任方東平教授等進行學術 交流。學會規劃及發展組上任主席曾正麟測量師向清華 大學的代表介紹了學會的規劃及發展組別。雙方亦討論 於清華大學設立規劃發展碩士或補充課程的可行性,並 研究學位承認問題。馬博士表示,現時學院與一些國際 組織和本港一些專業學會有著密切的聯系,並開辦了一 些非學位課程。馬博士補充,此非學位課程合作模式及 審批程序較開辦本科課程簡單直接。雙方並同意日後保 持連繫,為開展規劃及發展相關的非學位課程再作深入 探討。

Executive Summary

HKIS CEPA Visit to Beijing

A 11-member delegation, led by Senior Vice President and Chairman of CEPA Committee Sr Stephen Lai, paid a visit to Beijing from 27 to 30 November 2012. During the stay, the delegation met with representatives from the Ministry of Housing and Urban-Rural Development and relevant counterparts. Delegates also met representatives from the Ministry of Human Resources and Society Security, the Ministry of Commerce, the Ministry of Land and Resource, the China Appraisal Society, the China Real Estate Valuers Association, and the Tsinghua University. The purposes of the visits were to understand relevant regulations and mainland policies, to foster professional knowledge exchange, and to explore further cooperation opportunities so as to enhance the development of the surveying profession between Hong Kong and on the Mainland.

Briefing Session for APC Assessors

The GPD Education Committee held a briefing session with some 50 GPD APC Assessors on 5 December 2012. The session was intended to introduce the new APC scheme and, at the same time, brief assessors about its operations.

As members may be aware, under the new APC Scheme,

only two projects (including a "Critical Analysis") shall be included in the final submission. Candidates will have more preparation time comparing with the arrangements of previous years. Accordingly, we expect the quality of the final submissions will improve.



During the briefing session, topics on the assessors' role and presentation materials, skills, etc., of the candidates were discussed. The meeting provided an opportunity for communication amongst assessors so that they could synchronize with the HKIS's expectations under the new APC scheme. They enthusiastically offered different opinions and suggestions to help smooth operation of the new APC scheme. The briefing was useful and constructive.

Launching of the New Valuation Standards

Members may recall that the GPD had set up a Valuation Standards Panel (the "Panel") in 2010 to conduct a comprehensive review of the valuation standards. The intention is to maintain the best professional standards when preparing valuation reports. Convened by Sr Joseph Ho with members Andrew Chan, Charles Chan, Chiu Kamkuen, Russell Austin, David Faulkner, Lau Chun Kong, Simon Lynch, Lawrence Pang, Tony Wan, and Samuel Young, the Panel had reviewed the two HKIS valuation standards that existed at that time - the HKIS Valuation Standards on Traderelated Business Assets and Business Enterprises and the HKIS Valuation Standards on Properties. Both were first published in 2005. The Panel proposed that a unified and concise set of valuation standards, which is mandatory for members to comply with, should be prepared to cope with changes in business valuations and financial reporting purposes.

Since publication of the two existing standards, there have been significant changes in the International Valuation Standards (IVS) published by the International Valuation Standards Committee (IVSC), of which the HKIS is a Valuation Organization Member. The HKIS is committed to securing a set of common valuation standards that are acceptable worldwide. Therefore, we should, whenever possible, adopt new or updated standards and requirements set by the IVSC.

On the above basis, the Panel had completely revamped the two existing standards and finished updating the draft document in November 2011. That was followed by several rounds of panel and GPD Council discussions, consultations with members and regulatory and professional bodies. A new version of the valuation standards, "The HKIS Valuation Standards 2012 Edition" (the new "Standards"), was eventually endorsed by the HKIS General Council in October 2012. The document will be published on 1 January 2013. The new Standards will immediately supersede the aforementioned two valuation standards after publication.

Hard copies of the new Standards will be available for sale at the HKIS Secretariat at \$200 per copy. A free downloadable web version will also be available on the HKIS Website (www. hkis.org.hk) with effect from 1 January 2013.

Members are reminded that a grace period of three months for adopting the new Standards will elapse on 31 March 2013. With effect from 1 April 2013, all HKIS general practice practitioners are bound by the new Standards. Members must adopt and abide by the new standards when preparing their valuation reports.

New Arrangements for Collection of CIREA Membership Fee

The HKIS in liaison with CIREA is taking steps to revamp the arrangements for collecting future membership fees. In order to maintain a proper membership record, since payment of membership fee is a pre-requisite for maintaining active membership status, both institutes have, in principle, agreed to collect subscriptions from their members direct with effect from the next financial year. Therefore, from April 2013 onwards, HKIS members who have obtained CIREA

membership will receive membership renewal notices from CIREA direct. It has been agreed that the CIREA membership fee level will follow the existing guidelines/ arrangement. It will be charged at the equivalent amount to the RMB at the first transaction date in January every year. A MOU will be signed with CIREA to confirm this arrangement. Members will be kept informed on progress in due course.

Change of Office Bearers

Sr Edward Au was elected as the HKIS Hon Secretary at the HKIS Annual General Meeting held on 14 December 2012. Subsequently, GPD, at its council meeting held on 20 December 2012, elected Sr Jason CW Chan as the new GPD Hon Treasurer.

Consultation Paper on Adverse Possession

The Adverse Possession Sub-committee of the Law Reform Commission) released a consultation paper on 10 December 2012 that made preliminary proposals for the reform of the law on adverse possession. The paper is available at the following link:

http://www.hkreform.gov.hk/tc/publications/adversepossession.htm.

The preliminary recommendations of the Sub-committee were made against the background of a deeds registration system, as opposed to a title registration system (a proof of ownership) of conveyancing in Hong Kong.

The paper points out that the existing deeds registration system gives no guarantee of title, as the Land Titles Ordinance (Cap 585) has not yet been implemented. Even if a person is registered as the owner of a property, there may still be uncertainties or defects in his/her title to the property. Hence, title to land is relative and depends ultimately on possession. The LSD considers that to be a major reason why landowners should conduct land boundary surveys of their properties to protect their rights to their land.

The Sub-committee considered the case law and made recommendations on its various aspects. Its paper contains a thorough description of the problem of surveying and land boundaries in the New Territories. It recommended that the government step up its efforts to address the boundary problem in the New Territories. The Sub-committee also considered that the land boundary problem is best handled together with (and in the context of) the implementation of the Land Titles Ordinance. The LSD agrees that the government should look into this matter and find a workable solution.

A Task Force was appointed by the LSD Council to look into the details of the recommendations made by the Subcommittee, in particular the aspect related to the solution to the problem of land boundaries in the New Territories. The Task Force will also explore possible refinements to the recommendations, as proposed. If you have any comment on the paper, you are welcome to forward it to the LSD Council for consideration.

二十八日早上,由國家住房和城鄉建設部,計劃財務與外事司鄭淑玲處長主持,分別會見了中國建設工程造價管理協會、中國房地產估價師協會與房地產經紀人學會代表、中國建設監理協會及中國物業管理協會代表。

在與中國物業管理協會秘書長柴勇的小組會議上,我握要介紹了學會物業設施管理組過去一年的發展概況,及就物業管理行業在香港的發展作出專業交流。其中我特別詳細展述了香港特區政府正在進行物業管理行業與從業員的規管及立法進程。

柴勇秘書長對此重大發展表示歡迎。因為與香港物業設施管理測量師不同,中國物業管理師的培訓及註冊是分別獨立處理的,這制度上的差異正正亦窒礙了雙方進行資格互認的可行性。雖然制度上的障礙有代香港物業管理發牌的立法確立後才能有望解決。但雙方認同日後兩會需要進行更多聯繫,多辦一些培訓及交流研討會等等多作實際合作。



二十九日,除前往拜訪國土資源部及中國土地估價師學會外。代表團亦到訪了北京市住房和城鄉建設委員,拜會了物業管理處安世錦副處長,而北京市物業管理協會會長周呈及北京市物業服務評估監理協會會長黃耀華亦參與會議。在雙方各自介紹學會及行業發展現況後,本人亦趁機邀請安處長及周會長於明年三月份組團來港,參與二零一二年度優質物業設施管理大獎頒獎禮及研討會,並得到處長及會長欣然答應。同時,雙方亦原則上同意明年進行互訪。

Please be informed that Sr Dick Kwok, Sr Edmond Cheng, and Sr Charles Hung will represent the PFMD at the General Council of the HKIS for the 2012-13 year.

Being invited by the BEAM Society, the HKIS was asked to send a representative as their nominated director. I am glad that the HKIS has entrusted me to assume this nominated directorship for the year 2012-14. In view of the public's rising green awareness and the implementation of more green initiatives for existing buildings, I will contribute my

knowledge and experience in the capacity of PFM surveyor to the BEAM society. Another recent appointment has also been appointed a Green Building Facility Member under the HKGBC. The Green Building Facility represents expert groups that provide volunteer services to green building initiatives in the various committees of the Hong Kong Green Building Council.

Members' attention should be drawn to the enhanced version of the BEAM Plus assessment method for green buildings: BEAM Plus Version 1.2 for New Buildings and Existing Buildings, which has already come into effect and will become mandatory starting 1 January 2013. This enhanced version addresses some of the issues raised in the report, "Roadmap for Green Building Labeling System Hong Kong," and the aspirations of stakeholders for passive design. It also includes minor amendments to other aspects. The new version aims to improve building performance by encouraging passive design, which allows a building to better respond to the local climate by maximizing the comfort of its occupants, while minimizing the use of active mechanical systems and their associated energy consumption. In brief, the Energy Use Aspect of BEAM Plus Version 1.2 will provide two alternative routes for building assessment. Route 1, the original route, will assess the Building Active System based on the current BEAM Plus Assessment criteria. Route Two will replace the three current credits with the following four key criteria to determine the performance of building passive designs: 1) Site Planning/Building Orientation, 2) Building Fabric, 3) Natural Ventilation, and 4) Daylight. For more information about the rollout of BEAM Plus Version 1.2, please visit the HKGBC website at www.hkgbc.org.hk and the BEAM Society Limited website at www.beamsociety.org.hk.

The CPD event on "Saleable Area – Measurement, Rationale and Development" was successfully held with 88 members participating. Thanks go to Dr Lawrence Poon, our honorable guest speaker. Dr Poon was one of the members of the Steering Committee on the Regulation of the Sale of First-Hand Residential Properties by Legislation. Another upcoming CPD event will be held on 10 January 2013, and Dr Mei Yung Leung, Assistant Professor, Department of Civil and Architectural Engineering, City University of Hong Kong, will deliver her recently completed study on

"Facility Management for the Elderly in Public and Subsidizing Housing". This is an interesting report that will give you some invaluable insights into housing for the elderly. So don't miss it.



Chairman's Report for Year 2011 -2012

His report is briefly summarized as follows:

Mainland Affairs

- Arranged a site visit for Shanghai Construction Consultants Association during their visit to Hong Kong on 15 June 2012.
- Participation in the 2012 Mainland and Hong Kong Construction Industry Forum in Chongqing from 17 to 19 June 2012.
- Meeting with Representatives from Qianhai Authority on 27 September 2012.
- Visit to China Engineering Cost Association (CECA) in Beijing from 30 October 2012 to 1 November 2012. During this visit, we met the QSD members in Beijing Forum and discussed with CECA on the various matters relating to the future co-operation between HKIS QSD and CECA, and the furtherance of the existing Reciprocity Agreement.
- Under the reciprocity agreement with CECA, 65 members successfully registered as cost engineers in the last Council year, making a total of 144 members registered as cost engineers in the Mainland. International Affairs

- Durban, South Africa. HKIS had 3 delegates attended the Congress. Sr TT Cheung was elected the Administrative Vice Chair, the third highest-ranking officer of the ICEC, for 2012 to 2014.
- Discussed the possibility of establishing future collaborations with representatives from the Association for the Advancement of Cost Engineering International (AACEI), Ghana Institution of Surveyors (GhIS), and the Association of South African Quantity Surveyors (ASAQS) during the 8th ICEC World Congress.
- Attended the 16th Pacific Association of Quantity Surveyors (PAQS) Congress from 7 to 10 July 2012 in Brunei Darussalam. HKIS had 14 delegates (including the President) attended the Congress. Sr Dr Professor Anita Liu and Sr Dr Paul Ho received the PAQS Service Excellence Award in recognition of their long and outstanding service in the PAQS and their active involvement in its affairs. New Technology

 A Building Information Modelling (BIM) Sub-Committee had been set up in the last Council year with preliminary targets to 1) keep members updated on the development and use of BIM, 2) arrange seminars and workshops on BIM, and 3)



arrange visits to organizations to share their experience in BIM. The Sub-Committee had organized 8 Training Classes and CPD events on BIM software and the use of BIM in the Construction Industry in the last Council year.

- A joint project had also been run with the Hong Kong Institute of Building Information Modelling to study how a BI Model should be built up to suit the generation of quantities for pricing.
- Arranged a visit to Singapore Institute of Surveyors and Valuers (SISV) and attended the BIM Conference organized by SISV in Singapore from 8 to 10 November 2012. HKIS had 23 delegates attend this Conference. We had five speakers from Hong Kong, viz. Sr Thomas Ho, Sr Sunny Choi, Sr Joe Wu, Sr Anthony Tam and Ir Francis Leung.

Publications

- Six practice notes covering the core subjects of Tendering;
 Cost Control and Financial Statements; Valuation for
 Interim Payment Certificates; the Valuation of Variations;
 the Handling of Contractual Claims; and the Settlement
 of Final Accounts were launched on 20 October 2012.
 The practice notes were prepared jointly with the
 Association of Consultant Quantity Surveyors (ACQS) and
 the Hong Kong Construction Association (HKCA) and
 are intended to provide some basic guidelines to help
 quantity surveying practitioners apply a consistent and
 professional standard of service.
- The research on QS Service Fee Scale led by Sr Dr Sandy Tang was completed. The final report would be completed by end of December.
- The review of the Standard Form of Building Contracts 2005 Edition (SFBC) was completed. A new edition of the SFBC would be published in year 2013. The Nominated Sub-contract and Nominated Supply Contract would also be amended accordingly.
- The standard Form of Contract for large scale repair and maintenance works had been completed. This standard form was the co-effort of the QSD and BSD and it would be launched in year 2013.
- The review of the SMM4 was underway and it was expected that corrigenda would be issued in year 2013.
 QSD would also explore the need for drafting SMM5 and/ or a version for measurement using BIM.



Launching of the QSD Practice Notes

Education and APC Assessment

- With the introduction of the new APC System in July 2011, the QSD had revised the Divisional Rules and Guides for the APC assessment. The old APC assessment would co-exist with the new one until 2014. APC Workshops were arranged in June 2012 to introduce the new grouping of the core and elective competencies, and 17 Road Shows to private QS consultancy firms, universities, and contracting companies had also been held to introduce the new APC System to the candidates in year 2012.
- The HKIS Diploma Presentation was held on 13 July 2012 at the Happy Valley Stand of The Hong Kong Jockey Club. During this presentation, 101 members of the QSD obtained their diplomas.
- A briefing session for the assessors of the QSD Assessment of Professional Competence was arranged on 11 October 2012 which was attended by over 120 assessors. After the briefing session, a dinner gathering was held.
- Accreditation approval had been granted to the surveying undergraduate degree courses to HKU, PolyU and CityU and to the HKU surveying Master degree course. Accreditation application had been received from IVE on the surveying diploma courses in October 2012 and pending QSD review and approval.
- A PAQS Accreditation visit to Massey University, New Zealand for a Bachelor of Construction (Quantity Surveying) Degree course was held from 22 to 23 February 2012.


Care of Our Members

CPD Report - Half Day Lesson on Turning Waste Glass into Bricks

The HKIS QSD organized visits to two waste recycling centres for members to understand how disposed glass bottles are recycled into paver blocks on 24 November 2012. Twenty-seven of us gathered at the Luard Road Rubbish Collection Point, where we were briefed by an enthusiastic lady, April Lai, with a passion for saving the environment. Ms Lai is the coordinator of "Green Glass Green" (www.greenglass.org. hk), which is a project initiated by some dump truck drivers who collect used glass bottles for recycling. She told us that due to the lack of a government policy to recycle glass bottles, plenty of them still go to the landfill every day. She continues to lobby bar owners nearby to give their waste glass bottles to her for recycling.

Our second stop was to Tiostone Environmental, which had a small factory in Tuen Mun that made paver blocks from these used glass bottles. We were guided around the facility by Mr Dixon Chan, Director of Tiostone. He described the manufacturing process that produces the "Eco-paver" block. He said these paving blocks were comprised of mostly recycled materials such as glass sands, coal ash, and recycled aggregates to replace the natural sands, cement, and aggregates traditionally used in bottle manufacturing. Other than Green Glass Green, several large corporations and housing estates also contributed waste glass to the factory.

Mr Chan also told us that the costs of these Eco-paver blocks were almost half of those for traditional paver blocks, but each block was priced differently due to the different color additives and coatings. The Eco-paver blocks were mainly used in highway maintenance and private development projects. As they could help developers achieve LEED/ BEAM credits, such as recycling materials and SRI, the blocks have seen more recent use in private developments.





The day ended with an on-site, side-by-side comparison of clay and Eco-pavers laid along the pedestrian paths leading to the Gold Coast Beach Carpark. During this visit, our members learned to think twice before treating glass bottles as rubbish. More innovative uses for these bottles can reduce the burden on our landfills and environment in the future.
