# 會長的話 RESIDENT'S MESSAGE

By the time you read this message, the HKIS will have relocated to its new premises in Rooms 1205-07, 12/F., Wing On Centre, 111 Connaught Road Central, Sheung Wan. Once again, I would like to express my gratitude to the Working Group for their efforts in arranging the relocation smoothly over the past year.

While we continue with our relocation, we have not stalled on the progress of our projects:

The General Council endorsed *The HKIS Valuation Standards* 2012 Edition (The Standards) in late 2012. The Standards has been updated with the latest changes and developments in the valuation practice internationally. The Institute officially launched *The Standards* effective from 1 January 2013 with a grace period of three months for adoption. From 1 April 2013 onwards, all members of the HKIS must comply with *The Standards*. In the meantime, the *Standard Form of Maintenance and Renovation Contract and Standard Property Management Agreement* are being finalized. Many thanks go to those members for their immense efforts on these projects. They will help the Institute set the standard and offer examples of the surveying profession's best practices to the public.

As mentioned in my last Presidential Address, we have observed a rapid increase in the number of real estate projects in China. This, in turn, has provided a lot of opportunities to surveyors. During the meetings with the Development Bureau in late December and January, the bureau encouraged the professional Institutes to set up a representative office in the Mainland, and we believe that it may be a solution to facilitate our closer communications with our Mainland counterparts and authorities. A proposal was then submitted to the Institute's Executive Committee regarding the feasibility of setting up a representative office in Beijing. The proposal will be further discussed in the coming HKIS Retreat, which is scheduled for 2 February 2013.

The HKIS signature is our important asset. It marks the efforts and achievements made by its office bearers, council members, and members throughout these 29 years to make HKIS a reputable brand. Therefore, it is of utmost importance to protect our brand and signature. The office bearers are now reviewing the proposed identity guidelines. The guidelines will provide our members and staff in the secretariat with a clearer idea and direction when applying the identity elements with the aim of projecting our professional image through the use of our signature and brand elements.

As a member of the community, the Institute is always concerned about public affairs relating to our profession. One of its responsibilities is to provide professional views to the government as well as to the general public for their

consideration. The 2013 Policy Address was delivered by the Chief Executive of HKSAR on 16 January 2013. In response on the same day subsequent to the Policy Address, the Institute issued a media release with its professional views on issues related to its field. A letter was also sent to the office of the Chief Executive to convey the Institute's concerns on the related issues of the Policy Address.

To facilitate a better understanding of the Policy Address amongst building professionals, a joint forum for members of the six professional institutes, namely The Hong Kong Institute of Architects, The Hong Kong Institution of Engineers, The Hong Kong Institute of Landscape Architects,

The Hong Kong Institute of Planners, The Hong Kong Institute of Surveyors, and The Hong Kong Institute of Urban Design, was held on 28 January 2013 at the Joint Professional Centre. Members shared their views on the Policy Address during the forum.

Taking this opportunity, I would like to seek your continuous support and participation for the Institute's future and ongoing projects. Your inputs are vital to the success of our profession, industry and community.

當你收到這一期學會通訊時,學會辦事處應該已遷至上環干諾道中 111 號永安中心 12 樓 1205-07 室。在此,再一次感謝工作小組過去一年間為學會辦事處的搬遷所付出的努力。

雖然我們忙於搬遷的事宜,然而我們並沒有放慢腳步,仍在 以下項目上取得進展:

學會理事會在 2012 年底確認了《香港測量師學會評估準則(2012 版本)》(《評估準則》)。《評估準則》根據國際評估實務的最新轉變及發展而作出更新。《評估準則》已於 2013 年 1 月 1 日正式生效,並將提供3個月的寬限期。由 2013年 4 月 1 日起,所有學會會員必須遵守《評估準則》內所訂的內容。與此同時,在會員的努力下,Standard Form of Maintenance and Renovation Contract 及《標準物業管理協議》的編製已接近完成,並快將推出。以上項目協助學會為社會訂定標準及向大眾展示最佳實務的例子,在此向參與編製這些文件的會員致以感謝。

在 12 月周年大會時曾向各位提及,我們觀察到中國內地有許多房地產項目正急速發展,給測量師提供大量契機。在 2012 年 12 月底及 1 月份與發展局的會議上,局方鼓勵多個學會在內地成立辦事處,我們認為這可能是其中一個與內地伙伴及相關單位加強溝通的一個方案,我已向執行委員會提交建議書,建議就成立北京辦事處進行可行性研究。建議將會於 2013 年 2 月 2 日學會退修會作一步討論。

香港測量師學會的會徽是我們的重要資產。它標誌著過去 29 年的學會執行理事、理事會成員及所有會員的努力及成 就,使致香港測量師學會這個品牌得到社會的認同。因此, 保護我們的徽章及品牌非常重要。執行理事現正審視《識別 指引》初稿。該指引將為學會會員及秘書處職員在使用會徽 及品牌元素時提供清晰的指引,期望透過使用會徽及品牌元 素的一致性,保護學會的專業形象。

學會作為社會的一份子,我們一直關注與專業範疇相關的公共事務。學會其中一個責任是向政府及大眾發表專業意見,供他們考慮。2013 施政報告已於 2013 年 1 月 16 日由香港特別行政區行政長官發表。同日,學會發佈了一則新聞稿,向公眾表達我們對施政報告的專業意見。我們亦將意見以書面形式發送至行政長官辦公室。

為了使建築業界的專業人士對施政報告有更多的了解,香港建築師學會、香港工程師學會、香港園境師學會、香港規劃師學會、香港測量師學會及香港城市設計學會六個學會於2013 年 1 月 28 日在專業聯合中心舉辦了聯合論壇。會員在論壇上就施政報告發表了意見。

藉此機會,我再次誠意邀請會員,繼續支持及參與學會的項目。有你們的投入,才能推動我們的專業、行業及社區發展,並邁向成功。■■

# Press Conference on the "Proposed long-term strategy to handle Unauthorised Building Works"

BSD Spokesmen, Sr Vincent Ho, Sr Andrew Kung, and Sr David Chan, held a press conference on 10 January 2013 to present our proposed long-term strategy on how to handle Unauthorised Building Works. The conference received good media coverage on the following day. President Sr Stephen Lai also forwarded the strategy to the Secretary for Development on 17 January 2013, so we hope our ideas and proposals can be further explored by the Administration.

A brief English translation of the associated Press Release is appended herewith:

We note that the current control and definition of Unauthorized Building Works (UBWs) may have been slightly overdone with the result that there is now a tendency to unnecessarily control construction and cause a nuisance to homeowners. In this context, we would like the government to thoroughly review its UBW enforcement policy so as to minimize the anxiety that owners face. The BSD held a press conference on 10 January 2013 to deliver its proposal to the government on its UBW enforcement policy.

The UBW problem has been an issue for decades. Recently, it became a controversial topic that aroused widespread public discussion and concern. It is a pity that society and the government has not come up with a comprehensive UBW-handling strategy. After great efforts and limited resources were committed to dealing with UBWs over the last decade, over 400,000 of them remain. Therefore, we opine that both the government and society should view this issue from a new angle and adopt a long-term strategy to resolve it.

According to the Buildings Ordinance (BO), a UBW can be roughly categorized into two types:

- Building works that were carried out without first having their building plans approved under the BO. It does not matter if they had complied with the building designs and standards approved by the Regulations.
- 2. Exempted works under the BO that were carried out, but which contravened the current regulations.

Even with the implementation of the Minor Works Control System (MWCS), there are still a lot of works that were unauthorized. Hence, the BSD proposes that the government implement a new set of timely and pragmatic enforcement policies that should include:

- A review and categorization of the nature of a UBW by focusing on tackling those UBWs that constitute an obvious or imminent danger to life or property and those constituting a serious hazard or environmental nuisance, while handling other UBWs flexibly.
- 2. The formulation of a set of building safety and health standards that are independently suitable for the addition and alteration works to existing buildings.
- 3. The formulation of a comprehensive evaluation system to regulate existing UBWs and allow for a certain degree of rectification work, when appropriate, to be carried out to correct any sub-standard work after evaluation and recognition by a registered building professional.

We advise that our proposal on UBW policy could be implemented via or together with the ten-year planned inspection under the Mandatory Building Inspection Scheme (MBIS) so as to ensure the overall safety and health standards of buildings while the associated rectification works could be implemented under the MWCS.

# Workshop on "How to avoid the traps when carrying out mandatory inspections and repairs"

On the evening of 22 January 2013, we organized a workshop in The Hong Kong Federation of Youth Groups Building in North Point for some Owners Corporations (OC) in order to introduce the Mandatory Building Inspection Scheme and Mandatory Window Inspection Scheme. We also advised them on how to avoid the "traps" set by "cowboy" consultants.

Sincere thanks go to our YSG members for their attractive drama, which reinforced the main theme of the workshop, and Sr Vincent Ho and Sr Kenny Tse for delivering the presentation. We introduced the concept of "3-6-9" to the OC in order to present a balanced view while preparing the tender for a consultant to carry out a mandatory building inspection and any necessary repair work recommended in a Registered Inspector's report. We also gave advice on how to assess the performance of a consultant. The face-to-face interviews after the presentation were also well-received by the OC, and these interviews lasted until the end of the event. The tips offered by the workshop and the sample agreement of engagement for professional services will be

offered to the OC. Subject to administrative arrangements, members may receive broadcast news on the relevant materials presented by the workshop.







# Professional Service for the Development of Qianhai

We met for an entire day with the Shenzhen Project Management Engineers Association (深圳市監理工程師協會) on 11 January 2013. This was the first meeting of our joint working group to implement the collaborative agreement framework signed on 9 December 2012. The group established the mode of future cooperation and the targets to be achieved. The main target of the working group

# Formation of Working Group on "Consultation Paper on Adverse Possession"

The GPD Council has resolved to form a working group. It will be convened by Sr Louie Chan with members Sr Jim Lam, Edward Au, Ringo Lam, and Patrick Lee. Recommendations on Adverse Possession will be sent to The Law Reform Commission by the end of March.

Meanwhile, we note that the LSD has also formed a working group on this matter. The GPD will keep in touch with the LSD with a view to submit a joint proposal to the Commission.

# Nomination of GPD spokesmen and GPD GC representatives

At its meeting on 14 December 2012, the GPD elected Sr Dr. Lawrence Poon, Tony Wan and CK Lau as the division's spokesmen. The meeting also confirmed Sr Francis Ng, KK

Chiu, and Dr Lawrence Poon as GPD representatives to the HKIS General Council.

# **Progress of the Land Supply Working Group**

The convener of the Working Group, Sr CK Lau, attended LegCo's Development Panel meeting on the Northeast New Territories (NENT) New Development Areas (NDA) on 8 December 2012. More than 100 representatives from various groups/ political parties were present and their views were diverse. Some political parties objected strongly to land exchange proposals with existing owners/ developers in the

NENT NDA. Compensation and the relocation of occupants (including the re-housing and re-location of farming activities) were the major concerns.

The working group, now re-named as Land Policy Panel, will meet again and discuss the situation on land supply and, when appropriate, take further action.

# **APC Structured Learning Programme**

Some members may recall that after the EGM on 18 July 2011, a new APC scheme ("the New Scheme") took effect on that day. The New Scheme recognized the importance of professional knowledge in some specific areas and, as such, probationers undergoing the APC will have to attain the requisite standards. The GPD Education Committee convened by Sr Louie Chan with members Sr Edward Au, Joseph Ho, Thomas Chan, and Lawrence Pang re-vamped the GPD APC Rules and Guide in accordance with the resolution.

There are two parts under the New Scheme. Part 1 is a combination of: (a) 12 months of experience; (b) 20 hours of pre-qualification structured learning ("PQSL") for cognate

degree holders (or 40 hours of PQSL for non-degree holders) within 12 months after a probationer completes Part 1 of the written assessment; and (c) written assessments on four papers. Probationers who have passed Part 1 may proceed to Part 2 if they have accumulated a minimum of 24 months of structured training. Part 2 is for the submission of a critical analysis followed by an oral assessment.

To help candidates prepare for the APC written examinations, the Education Committee will arrange 12 modules of APC Revision Workshops to cover the entire syllabus of Part 1 of the APC written examination. Details of the arrangement will be announced shortly.



# **APC** passing rate

The GPD had conducted the APC Part II oral examination in December. The passing rate was 56%. We wish to extend

our congratulations to all successful candidates.

# **CIREA subscription arrangement**

Arrangement for future membership fee collection will soon be concluded with CIREA, which drafted an MOU to that effect. Payment information from 2004 to 2012 will be exchanged in order to facilitate future collections.

It was proposed that with effect from 1 April 2013, the HKIS and CIREA will collect subscriptions from their members direct.

# **Valuation Standards Panel**

The HKIS Valuation Standards 2012 Edition was finalized. The revised valuation standards took effect on 1 January 2013 with a grace period of three months until 31 March 2013. The web version is currently available on the HKIS website for free download, while the hard copy is available for sale to members at HK\$200 each.

Two CPD events for the revised valuation standards will be held in February 2013. Meanwhile, the DVD version will be distributed to regulatory bodies and other professional institutes. Members should note that it is mandatory to comply with the updated standards.

# The Significant Role of Official Statistics: some reflections and insights

# Serving the community

With the mission of contributing our professional expertise to serve the community, we have provided views on various areas for the development of public policies in 2012. We worked closely with the HKIS Office Bearers and Divisions to express our views on how to achieve a better Hong Kong. We submitted our views to the Chief Executive and Financial Secretary in relation to the 2011-2012 Policy Address, with particular focus on: (a) the determination of land boundaries and (b) the establishment of a cadastre system to encourage the public to participate in the management of Hong Kong's land resources.

We have to push harder in 2012-2013 to amend the Land Survey Bill for the enactment of legislation to determine land boundaries in order to administer leased and unleased land, control land use, and formulate policies for planning and land development. The standard and control of relevant professional should be applied to all land boundary surveys instead of the limited scope as required in LSO today. We shall urge the government to consider establishing a publicly accessible cadastre system in Hong Kong to facilitate more efficient public access to the relevant land boundary

information. It would be best that the proposed system ride on an advanced spatial data infrastructure via the internet.

### **International and Mainland Affairs**

The LSD joined various international and Mainland events in 2012 to promote the HKIS, exchange ideas, and establish new relationships with our fellow land surveyors in other parts of the world.

In 2013, the LSD shall continuous its active participation in international events e.g. FIG WW and SEASC. We shall further strengthen our connections with our counterparts on the Mainland and in Macau and Taiwan.

Two major land surveying conferences, namely: 第八屆京港 澳測繪技術交流會 in May and 第七屆海峽兩岸測繪發展研 討會 in November will be held in Hong Kong in 2013. As one of the co-organizers of the events, the LSD shall take the opportunity to introduce its latest developments to its guests. More importantly, your participation is vital to the success of each event. We shall keep you informed of the progress and the key dates of the paper submissions and registrations.



# **Education and Membership**

We have maintained a good relationship with academia and have attended regular liaison meetings and the Advisory Committee Meeting of the Department of Land Surveying and Geo-Informatics (LSGI) of the Hong Kong Polytechnic University (PolyU). I am glad to have strengthened our partnership with the LSGI to provide a good start for young people to shape their futures as land surveyors in Hong Kong.

We also seek every opportunity to gain mutual recognition with other professional bodies in Hong Kong. A Reciprocity Agreement between the Chartered Institution of Civil Engineering Surveyors' (ICES) Geospatial Engineers and our Land Surveyors was signed at the HKIS's Surveyor Learning Centre. A Corporate Member (Member or Fellow) of the HKIS in good standing who is also a member of the Land Surveying Division may be elected as a Member of the ICES (Geospatial Engineering stream) subject to: (a) one year's post-qualification professional practice relevant to the ICES (Geospatial Engineering stream) in circumstances that will enable a Member or Fellow of the ICES (Geospatial Engineering stream) to confirm the professional activities undertaken and (b) a professional competency interview conducted by the ICES.

We also care about the development of our local members. Hence, we have taken the lead to talk to the government about our members' concerns over the standard of land surveying services in Hong Kong, in particular those for mega construction projects. Measures have been discussed and agreed to between the government and the HKIS for a competent, professional land surveyor to be present for large scale construction projects or when the project requires our expertise to assist in complicated works control.

# **Continuous Professional Development (CPD)**

A series of Continuous Professional Development (CPD) sessions for surveyors at all levels were conducted to update members' knowledge and for everyone to share his/her knowledge with counterparts in 2012. We shall continue to work in 2013 to provide more CPD sessions to our members, as well as to probationers, so that they can maintain their CPD with respect to our mandatory CPD requirements and the APC Assessments.

# **Consultation Paper on Adverse Possession**

The LSD shall work with the GPD to examine the details of the recommendations made by the Sub-committee on the items brought to our attention. The LSD Task Force will also explore possible refinements to the proposed recommendations. If you have any comment on the paper, you are welcome to forward it to the LSD Council for consideration.

# **Chairman's Message**

Happy New Year! I wish you and your family a healthy and prosperous 2013.

After the closing of the nomination period for QPFMA 2012, I am pleased to note that a total of 174 nominations were submitted, which far exceeded the numbers of QPFMA 2010. This is exciting news for kicking off the new year. It reflects the wide recognition of the awards and demonstrates the eagerness of the practitioners to pursue excellence, professionalism, and service quality. It also echoes with our main theme this year, "Championing innovative service through quality management 服務顯創意管尚優質". The vision of QPFMA is to stimulate greater public recognition of the industry and reward those who demonstrate contemplative performance in terms of bringing comfort, safety, and security to their users and occupiers, whilst complying with the legal requirements and maintaining a respect for the environment.

This year, we will put additional emphasis on the performance of green management operations and how they can be implemented innovatively. To cope with calls to expand the award categories, we have extended the coverage as follows:

**Residential Category**: Large scale/medium scale/ small scale, Tenant Purchase Scheme & Public Rental Housing, Home Ownership Scheme & Private Sector Participation Scheme

**Non-Residential Category**: Shopping Centre Management, Office Building Management, Industrial Building Management, and Institutional Facility Management.

The Finalists' presentation to the Judging Panel cum QPFMA 2012 Conference will be held on 9 March 2013, while the Award Presentation & Dinner Reception will be held on 26 April 2013. I will keep members posted of any update in the coming months.

I joined the 10th Anniversary of the Professional Green Building Council (PGBC) on 28 December 2012 at the Zero Carbon Building, which was an excellent choice of venue to celebrate and embrace the PGBG's achievements over the past decade. I am so grateful to be associated with the PGBG for the past four years and to work with groups of professionals from the different disciplines, all of whom shared the same passion for promoting green buildings in Hong Kong. Mrs.

Carrie Lam, Chief Secretary for Administration and the Guest of Honour, endorsed the contributions of the PGBC to the green building movement. The Council's staunch support has been most invaluable. The PGBC, which was established in 2002, is a professional alliance of architects, engineers, landscape architects, surveyors, and town planners. One of its biggest achievements was its introduction of a green building award in 2006, which is the first of its kind in the region and now has been increasingly recognized at the local and regional levels.

Recently, I joined a retreat organized by the BEAM Society, Ltd. (BSL) with the other directors. During a discussion of Technical Review, I expressed my great concern over fulfilling the requirements of a BEAM Plus Existing Building (EB), which is extremely difficult, if not impossible. To my understanding, there have been only a few applications submitted so far for EB, so the BSL has to address this problem. In my opinion, the whole EB manual does not cater to the various designs, facilities, and space constraints encountered by the EB projects. For example, even if a client wants to replace its aged air-cooled chillers with water-cooled chillers, which could achieve substantial savings in energy consumption, it may not be able to proceed due to the structural and space constraints of the building. However, the emerging market should be in the EB category by virtue of the existing buildings in Hong Kong accounting for almost 90% of all electricity consumption and 60% of all greenhouse gas emissions. For EB, we should put more emphasis on green management operations and continue to make energy consumption more efficient rather than put its focus on building designs and infrastructure aspects. I sincerely hope that if the EB manual caters to the aforementioned aspects, I anticipated more EB applications being filed and, ultimately, a long term improvement in the overall carbon mission figures.
