

Dear Members,

I joined the Hong Kong SAR Trade Delegation to Fujian on 23-25 January. The delegation was led by the Chief Executive, the Hon CY Leung. About 140 Hong Kong delegates from the government, professional institutes, trade associations, and universities joined this group. The purpose of the visit was to promote trade and Hong Kong's financial and professional services. The delegation met with representatives of the Government of Fujian Province and the Xiamen Municipal Government. It also visited foreign and local enterprises in Fujian, which is opening up further opportunities for trade and plans to build a new airport in Xiamen. Professional services and management expertise are much needed for the continued economic development of Fujian.

Hong Kong's population is facing an aging problem. We need a sufficient supply of manpower and talent to drive the economy. Our profession also needs to attract high quality students to study surveying and enter the profession after graduation. The Institute participated in the Education and Careers Expo 2014 on 13-16 February to promote the surveying profession to students and youngsters who are entering the job market. I delivered a talk to the Expo attendees and showed them the career prospects for a surveyor. Furthermore, the HKIS Building Surveying and Eddie Lee Memorial Education Foundation awarded scholarships to ten secondary school students on 15 February. I wished the awardees a very bright future in their educational and career developments.

To celebrate the HKIS's 30th Anniversary, we have organised a series of events. One of the signature events is the Surveyor Luncheon. On 21 February, we invited the Director of Lands, Ms Bernadette Linn, JP to deliver a talk on "Land administration: Challenges for Professionals and Laymen Alike". The event was very well attended and the talk was very informative, especially on the latest developments in the Pilot Scheme for Arbitration on Land Premium.

於 1 月 23 至 25 日期間,我參加了一個由行政長官梁振 英先生率領的香港特別行政區經濟代表團到訪福建,這 次代表團包括政府、專業團體、工商界及大學之代表, 一行約 140 人。是次訪問團主要目的是推動兩地經貿 合作,代表團會見了福建省和廈門市人民政府代表。此 外,亦參觀了福建市的海外及本地企業。此行有助業界 開拓更多機會,進一步加強經貿合作。廈門亦將計劃興 建新機場,可見福建正需要大量專業及有管理經驗之專 才去支持經濟持續發展。

香港人口持續老化,社會需要有充足的專才去推動經濟發展。測量專業也需要鼓勵及吸引更多有潛質的年輕人修讀測量專料,於畢業後投身測量專業。於 2 月 13 至 16 日期間,學會參與了 2014 教育及職業博覽,向學生及將投身社會之年輕人介紹測量專業。我亦出席並擔任教育及職業講座之講者,向大眾介紹測量專業之前景。此外,於 2 月 15 日,學會建築測量和李樹城紀念教育基金,頒發獎學金予 10 名成績優異的中學生,我在此祝賀各獲獎者在學習和將來事業發展上,前程一片光明。

為慶祝學會的 30 週年,我們已計劃舉辦一連串慶祝活動。其中一個重要的活動是測量師午餐會。於 2 月 21日,我們很榮幸邀得地政總署署長甯漢豪太平紳士擔任主講嘉賓。是次講題為"土地管理:對專業人員和外行人的挑戰"。午餐會反應熱烈,特別在最近期之補地價仲裁先導計劃議題上,各出席會員均獲益良多。

《計劃簡介》

Surveyors Luncheon Talk



Land Administration: Challenges for Professionals and Laymen Alike

Reported by Sr Tony Wan & Sr Sindy Chan

A luncheon talk titled, "Land Administration: Challenges for Professionals and Laymen Alike," was successfully held on 21 February 2014 with more than 100 participants at the World Trade Centre Club Hong Kong. This was the second in a series of six luncheon talks organised as part of the activities to celebrate the 30th anniversary of the HKIS.

The GPD was greatly honoured to have the presence of Ms Bernadette Linn, JP., Director of Lands, as the speaker at this surveyors' luncheon. In her speech, Ms Linn highlighted the challenges encountered by the Lands Department concerning land administration issues and effective communication to the general public.

Ms Linn also commented on the Pilot Scheme for Arbitration on Land Premium proposed during the Chief Executive's recent Policy Address. It is a new government initiative intended to facilitate early agreements on land premiums, so as to speed up the development process and housing supply.

Arbitration on land premium involves a lot of complicated issues. Ms Linn briefed the attendees on the feasibility of introducing an arbitration mechanism and the various comments made to the proposed scheme from the public.

Ms Linn mentioned that the framework is currently being worked out and intended to announce its details in the middle of this year. Its contents include whether the scheme would be voluntary or mandatory, the threshold of a premium for which a dispute should go to arbitration, the number and selection of arbitrators, etc. On top of that, Ms Linn encouraged surveyors to provide more professional opinions on this subject.

At the end of the luncheon, we had a harmonic and enthusiastic Q&A session to express our views on the land administration policy to Ms Linn. Attendees appreciated this kind of lively interaction and communication between the government and the HKIS.







Tram Party

A tram party was organised on 17 February 2014 as one of the activities for celebration of the 30th Anniversary of the HKIS.

A total of 45 members including the President, Sr Simon Kwok, Vice President Sr Edward Au and Honorary Secretary, Sr Thomas Ho, joined in the two-hour event which began at 7.00 pm from Whitty Street Tram Depot in Western District, Hong Kong.

Interview with Past HKIS President
Francis Ng (1999-2000)

What Francis said

I am honoured to have the opportunity to 'wrap up' my thought about the Institute after I left the post in late 2000.

Over the past 13 years, I constantly received feedback on the streamlined process initiated by the administrative office and effect of decisions made during my tenure. I heard appreciation from some past presidents that meetings were conducted in an amicable, effective, and smooth manner.

I recall that thorny issues that popped up then were no less than in recent years. For example, at that time, the government was setting up a 'housing managers registration' system. There were constant dialogues with the then-Housing Bureau on the HKIS involvement. On the accommodation aspect, the Institute's lease at Prince's Building was coming to the end. Consideration was being given to seek alternative premises or purchase accommodation on an "one-off" basis. The Institute eventually decided to rent an office nearby. Also, we helped to secure a ten-year tenancy for the "Professional Learning Centre" at the LDC site, The Centre.

My presidency was a few years after the change of sovereignty. Frequent contacts with the Mainland counter-parts were made. I had ample opportunities to give talks to universities and elaborated on the Institute's mission to the relevant bureau/departments.

Some past presidents may agree that the monthly message was not easy to write, given our various work commitments and time constraints. However, I did enjoy writing essays at the back page of *Surveyors*

Times on topics I liked (e.g. Chinese poems, Putonghua pronunciation, playing around with words, rationing certificates, used bus/train tickets, travel stories, etc.).

HKIS has been successful in taking a leading role in the Hong Kong property market. Our efforts and contributions are well-respected by the general public. The Institute maintains high professional standards as various divisions work together smoothly. There is, however, always room for improvement. Promotion of the surveyor's role to the general public is a neverending task. We need to give constructive advice on consultation documents and maintain various standards. We should be open-minded and forward-looking. I also hope that new-comers will gain more knowledge and skills from their predecessors and be aware of the importance of upholding ethics, be considerate, modest, and be responsible professionals who are prepared to serve.

Biography of Francis Ng BBS, FHKIS, FRICS, RSP (GP)

Francis joined the then-Crown Lands & Survey Office (now the Lands Department) as a Student Estate Surveyor in December 1971. He qualified as a professional surveyor in mid-1973. He remained working with the Lands Department until 2009, when he got retired as the Deputy Director/Specialist.

Presently, he is an Adjunct Professor at the City University of Hong Kong and also works as the Principal Consultant in Lawson David & Sung Surveyors Ltd.

For information, Francis was the President of the HKIS from 1999 to 2000. He was Chairman of the General Practice Division from 2009 to 2013.

專訪:潘根濃測量師 Interview with Sr Kenneth Poon

或多或少是受其土木工程師父親之影響,潘根 濃測量師 (Kenneth Poon) 很早已對建築產生 興趣,並於中學畢業後直接選修工料測量, 轉眼間,便當上工料測量師幾十年了。其兒 子 Linus 告訴我,當初他的大學選科不是測量 系,而是法律系。因為其後在修讀的途中發現 自己的性格和興趣比較適合修讀建築系,所以 最後才轉科至工料測量。再加上父親在日常生 活上都灌輸了有一些關於建築材料價格的知 識,令 Linus 更加確定自已對工料測量的興趣 的灌輸(有意或無意地),很自然地畢業幾年後 的今天, Linus 亦已考獲 MHKIS 資格,成為 專業工料測量師了。

Kenneth 覺得測量本身這個專業可接觸的層面 非常之廣闊、工種很獨立清晰。每一門測量專 業(產業、建築、土地、工料)對個人的性格要 求並不一樣。產業測量師需要較強的社交能 力;建築測量大部份畢業生均在政府工作,

用。而且越來越多人真正知道測量這行業的分 工定位,既有工科的技術要求,也包含商業思 維元素,所以近年本科收生水平也不俗。

至今對 Linus 印象最深刻的經驗為天馬艦政府總部駐地盤工作,因為建築真正的實務是在工地裡,所有文件合約、價格及行政等都不能脱離地盤的實務運作,對常在寫字樓工作的顧問工料測量師來說,駐地盤是難得的經驗累積機會。而 Kenneth 則覺得在 1986 年首次接觸國內(北京) 的一項工程是他的職業生涯中的一個很重要的轉折點。其實整個香港測量業界對近二、三十年國內建築業體制的發展有重大的影響,從中央規劃模式、定額造價,到引進營商概念、使土地具價值及產權的確認,採用市場招標模式,標準合同條款等,一步一步的確立今天中國市場的運作方式,亦因此令到香港的專業測量師有更大的空間去發揮所長,向外拓展這種專業服務。



最後問及兩父子在同一間公司的工作情況, Kenneth 表示會盡量避免大家負責同一單工 程,以免影響 Linus 自己的個人處事手法。父 子兩代會否因年紀及成長時候的文化不同在思 考溝通上有很大的差異呢? Kenneth & Linus 均表示工作上的爭論很少,因這行業的運行早 已成熟,可爭論的地方較少。Kenneth 則表示 發覺新一代在溝通方面比較多用電郵、智能電 話等的電子模式,少用一些傳統的方式如面對 面或電話直接聯絡。其實有時一些誤會和問 題,冰冷的文字未必可表達作者的原意,而接 收者也可能有不同的理解。所以 Kenneth 建議 除 email 外也多用電話或會議直接溝通去確保 訊息的清楚表達,減少麻煩,其實這少許工序 是很有其價值及功用的。筆者在此也希望此文 也不是冰冷的,大家可感受到測量師們對自己 工作的熱誠吧!

Influenced by his civil engineer father, Sr Kenneth Poon developed a great interest in construction when he was young. This tradition was broken when Kenneth's son, Linus, chose law as his undergraduate field of study. But the genes Linus inherited made him eventually follow in his family's path due to his character and the day-to-day irrigation of "Construction Material Price knowledge" by his father!

Kenneth mentioned that the aspects a surveyor can face are very broad. Different divisions inside the surveying practice require different skills and personalities. He suggested that teenagers, especially during their summer holidays, try to explore their interests and capabilities through summer placements or

training programs. With an ever-changing global economy and business environment in recent decades, surveyors now play an increasingly important role in new positions like securitisation and compliance. A surveyor is not just a construction industry professional, but business-oriented, too.

Linus told me that site experience is invaluable for fresh graduates, since contract management and cost administration cannot be eliminated from real construction operations. Only with this "real exposure" can we visualise the 3D world from that contained in previous 2D textbooks. Kenneth added that surveying has been invaluable to China's development for at least 30 years in terms of macro planning, fixed prices, property rights, tendering in market price, standard contract clauses, etc. All these factors provide very good opportunities for Hong Kong practitioners to utilise their talents in the huge China market.

Although Kenneth and Linus are working in the same company, they do not work on the same project in order for each to gain more independent experience. However, younger generations like ours would prefer more electronic ways of communication, which Kenneth thinks may sometimes not be as effective as traditional methods like direct phone calls or face-to-face discussions in the traditional industry of construction. Sometimes misunderstandings and conflicts can be solved directly and simply. So, nothing is definitively outdated or useless!

Home Affairs Department's new measures to support building management and maintenance

On 20.2.2014, the Home Affairs Department announced that two new measures would be launched in April this year, namely the "AP Easy" Building Maintenance Advisory Service Scheme and the Building Management Professional Advisory Service Scheme (Phase II) to further provide owners' corporations (OCs) and owners of old buildings with free professional advice and support services to enhance their building management and maintenance works. The HKIS is one of the three professional institutes offering free advice. BSD will work with PFMD in the "AP Easy" Scheme.

The "AP Easy" scheme is intended to show the incorporated owners (IOs) how to appoint a competent and appropriate project consultant (the AP) and give them the basic knowledge to monitor the consultant's performance. In order to be fully independent from the consultancy agreement between the consultant and the IO, we cannot get involved in the actual assessment of a building's conditions and details of its repair works - not even the specific cost aspect that should be handled by the consultant. We are also not supposed to be involved in the works supervision stage of the repair works.

We will provide 25 teams of volunteers for this scheme. Interested members are advised to e-mail me for further information.

Details With the enactment of the Buildings (Amendment) Ordinance in June 2011 and subsidiary legislation including the Building (Inspection and Repair) Regulation ("B(IR)R") in December 2011, Mandatory Building Inspection Scheme ("MBIS") has came into force since 30 June 2012. Under the MBIS, owners of buildings aged 30 years or above (except domestic buildings not exceeding three storeys) are required to appoint a Registered Inspector ("RI") to carry out the prescribed inspection of the common parts, external walls, and projections or signboards of the building upon receipt of a notice (once every ten years)

served by the Building Authority under Part IIA of the Buildings Ordinance.

Buildings Department of the HKSAR Government has published a Code of Practice for the MBIS ("MBIS COP") in 2012. The MBIS CoP specifies the technical standards and procedural requirements for the RI to carry out building inspections, but it does not elaborate on inspection planning, professional judgement, defect diagnosis, and special construction methods and features commonly found in aged buildings.

Pursuant to section 5 of the B(IR)R, the inspection of surviving buildings involves examinations and assessments with reference to the standards used at the time when the buildings were built. It becomes crucial to understand the legislation, designs, materials, codes of practice, and practice notes that prevailed when the buildings were built.

In this connection, Building Surveying Division of The Hong Kong Institute of Surveyors has published a Professional Guide to Building Inspections ("PGBI") – Volume 1: Pre-1980 Residential & Composite Buildings in Hong Kong.

Sr Dr Daniel Ho and Sr Dr Edward Yiu who were the academic researchers of the PGBI will share with members about the main contents of the PGBI on inspection preparations and understanding of the various design codes which prevailed at the time when these pre-1980 buildings were built. Sr David Chan will also participate and share his 30+ years of practical experience in building inspections.

Chairman's Message

As you are aware, the Council for Sustainable Development (CSD) launched a public engagement process titled, "Waste Reduction by Waste Charging – How to Implement?" on 25 September 2013. This exercise aimed to encourage stakeholders and the general public to participate in the development of a feasible mechanism to implement municipal solid waste (MSW) charging and to consider the difficulties involved (given the related recycling facilities needed) with a view to reducing community waste at its source and promoting sustainable development in Hong Kong. The public engagement process lasted until 24 January 2014.

Waste Reduction by Waste Charging How to Implement?

In view of this, the HKIS forwarded its comments to the CSD on the "Proposed Municipal Solid Waste Charging Scheme".

- 1. In principle, we support the proposal, as it can generate incentives for Hong Kong to reduce its solid waste. However, to ensure a fair and equitable scheme, the proposed charging mechanism must cover all kinds of buildings and calculate the fees according to the amount of waste generated (the "polluter pays" principle).
- 2. To ensure an effective reduction of waste, the proposed scheme must not be a standalone strategy of the government. Recycling at the source is still considered the most effective way to reduce solid waste. The government needs to inject more resources and effort into assisting the community to implement source separation and, equally importantly, to conduct research and development on the adaptive reuse of recycled waste.
- 3. It was noted that there will be an amendment to the Waste Disposal (Designated Waste Disposal Facility) and Waste Disposal (Refuse Transfer Station) Regulations, which would pave the way for the expansion of the three waste disposal sites. In the short run, we consider that such an expansion is inevitable, but we would like to advise that the government should also consider effective long term measures, such as the construction of a waste incinerator, to deal with solid waste that cannot be recycled.
- 4. Property and facility managers used to encounter difficulties in which recycling collectors were uninterested in waste with nominal economic value. This problem will become more severe if the volume of waste is enormous and the point of collection is remote. To encourage collectors to recycle "less attractive" waste, the government may need to offer assistance and incentives such as research and development for an economical adaptive reuse of the waste.
- 5. The provision of temporary storage areas for recycled waste and containers is another common problem, particularly for ageing and standalone buildings with limited common areas. The proposed solution for this problem is threefold. First, the government should

provide incentives, such as bonus GFAs, to encourage the provision of recycling facilities in any new building design. Second, government departments should be more flexible in allowing owners' corporations and property management companies to convert part of the common areas in their buildings to provide recycling facilities. Last, for ageing and standalone buildings, as well as rural village houses, more locally designated recycling points should be provided to facilitate recycling.

- 6. If the new charging mechanism operates on an individual household basis and each household needs to purchase designated garbage bags, this arrangement may make many households uncooperative and result in them leaving waste in the common areas of a building. This may cause management fees to escalate to strengthen security patrols and/or the installation of a surveillance system to enforce this mechanism. Disputes may also arise between households and property managers. Perhaps the government should offer incentives to help resolve and mediate such disputes, such as financial subsidies for the installation of additional surveillance equipment.
- 7. If the charging mechanism is based on a per building basis, such an arrangement should be much simpler and easier to implement. However, as different households generate different amounts of solid waste, coupled with the possibility of vacant units, it may not be an equitable way to apply the "polluter pays principle". Besides, this arrangement may not offer any incentive to households to reduce and recycle waste at its source. In order to assist in the sale of designated garbage bags and the calculation of the amount of waste generated, the overall refuse handling fee for the whole building may have to increase, which would, in turn, raise the management fee. The government may need to provide an overall waste charge rebate to "reward" buildings that normally generate high volumes of recycling waste on a pro-rata basis for reducing their waste generation.
- 8. To minimise the administrative efforts and the possibility of increased management fees, as well as to prevent any mischaracterisation of the proposed charging scheme as another tax, all charges collected under the new scheme should be separated from the annual government budget and pooled into an individual environmental protection fund. The fund may, thereafter, be used to subsidise the research and development of further recycling efforts, such as devising new methods to reuse solid waste. The fund may also offer financial incentives to support the

- recycling projects of individual buildings like providing recycling facilities and installing surveillance equipment.
- 9. To arouse the community's awareness of environmental protection and the importance of the three principles of reduce, reuse, and recycle, the government should help educate the community. This could be in the form of producing educational videos and literature. To help owners' corporations and property managers resolve the problems encountered when setting up recycling arrangements in their buildings, the government can help organize regular discussion forums, workshops, and seminars to provide updates of the most advanced recycling technologies and methods.
- 10. Prior to the full implementation of the new legislation, there should be a smooth transitional period to allow the community to adapt to the new charging arrangements. A trial scheme should be arranged during this period for different kinds of buildings to observe and resolve any difficulty encountered. Then the scheme can be refined to ensure its fair and equitable implementation on a regular basis.

New Engineering Contract (NEC)

The QSD Task Force met with the Task Group on NEC Collaborative Contracts of the Construction Industry Council (CIC) on 12 February 2014 at Pinsent Masons' Office. The purpose of the meeting was to exchange views on the draft frequently asked questions (FAQs) issued by the CIC's Task Group. The meeting was convened after we issued our comments on the draft FAQ to the CIC in December 2013.

While the NEC was custom-drafted for engineering works, the QSD Task Force expressed concern over the applicability and suitability of using it on building works projects given the substantial differences in the scope and nature of the works between these two sectors.

As we were given to understand that the Development Bureau has issued a directive to all Works Departments (including the Architectural Services Department) that all works contracts to be tendered in 2015 shall use the NEC as much as possible, the QSD shall maintain close dialogue with them to express its comments and views in relation to the implementation of the NEC on a regular basis.

2014 Pacific Association of Quantity Surveyors (PAQS) Congress, Hong Kong

The Secretary for Development, Mr Paul Chan, has accepted to be the Guest of Honour of the Congress. Key note speakers include eminent academia from the United Kingdom, Government officials from Hong Kong and senior executive from statutory organization.

The call for registration to attend the Congress will commence in March 2014. Members who are interested in attending the event must register as soon as possible to take advantage of the early bird rate. Since Hong Kong

What is adjudication? Is adjudication cost always irrecoverable? Under what circumstances can it be recovered? A recent Court case: The Board of Trustee of National Museums and Galleries on Merseyside v AEW Architects and Designers, Ltd. and PIHL Galliford Try JV [2013] EWHC 2403 TCC

What is adjudication?

Adjudication, pursuant to "Arbitration in Hong Kong – A Practical Guide, 2011," involves an independent and impartial third party (an "adjudicator") making a binding decision on a disputed matter for the disputing parties. This is an inquisitorial, but not adversarial, process that saves time. Usually, the adjudicator has relevant experience in the matter being disputed and is selected jointly by the parties as an expert, but not necessarily as an arbitrator. Costs are usually shared equally by both parties. The adjudicator's decision is usually compulsory, binding, and implemented immediately after it occurs, though it is subject to review by an arbitrator or the courts.

According to "Wikipedia", adjudication is a legal process in which an arbiter or judge reviews evidence and arguments, including legal reasoning, set forth by the opposing parties or litigants to come to a decision that determines the rights and obligations of each party. In the UK, adjudication has become a common practice in recent decades and has replaced arbitration in some cases. The relevant legislation in the UK is the 1996 Housing, Construction and Regeneration Act (1996, Chapter 53). In Hong Kong, adjudication is a hot topic and many leading practitioners have discussed it recently. All agree that legislation is an important step for adjudication to gain in popularity here.



Adjudication costs

As for the relevant costs and expenses of adjudication, this is generally and equally shared by the parties, but it is not mandatory. The relevant Conditions of Contract may make it clear who is liable for such costs. For instance, in *Bridgeway Construction, Ltd. v Tolent Construction, Ltd. [2000] TCC*, the subcontract between Bridgeway and Tolent incorporated the CIC Model Adjudication Procedure, but with amendments. Two amendments were relevant to the issue of costs. A new Clause 28 stated:

The party serving the Notice to Adjudicate shall bear all of the costs and expenses incurred by both parties in relation to the adjudication, including but not limited to all legal and expert fees.

A new Clause 29 stated:

The party serving the Notice to Adjudicate shall be liable for the adjudicator's fees and expenses.

As a result, it is clearly stipulated under the relevant contract that the party that serves the adjudication notice shall be liable for those related costs and expenses in adjudication, including, but not limited to, the adjudicator's fees.

If the contract keeps silent on the matter of each party's costs and the adjudicator's fees., the Housing Grants Construction and Regeneration Act has also been silent on such subject matter. The Act, however, states that the adjudicator is entitled to receive reasonable fees. The Act also makes each party jointly and individually liable for the adjudicator's fees and the wording used implies that payments may be made before the issues are determined.

Paragraph I.25 of the Act states:

The parties shall be jointly and severally liable for any sum which remains outstanding following the making of any determination on how the payment shall be apportioned.

However, there is seldom a contract or statute that dictates that one must have guidance before deciding if the cost of adjudication is recoverable. The following case provides a clue to this question.

The case

The Board of Trustee of National Museums and Galleries on Merseyside v AEW Architects and Designers, Ltd. and PIHL Galliford Try JV [2013] EWHC 2403 TCC

Facts

- The AEW Architects and Designers, Ltd. ("AEW") was the designer of the Museum of Liverpool for the client – the Board of Trustees of National Museum and Galleries on Merseyside ("Client").
- 2. PIHL Galliford Try JV ("Contractor") was the main contractor for the development.
- 3. The case concerned allegations of professional negligence relating to AEW on design.
- 4. A series of design changes were encountered followed by significant remedial works.
- AEW joined the Contractor in the proceedings, mindful that the Contractor had committed contributory negligence (pursuant to the 1978 Liability [Contribution] Act) for failing in certain aspects of its design, materials, and workmanship, which all overlapped with AEW's duties.

- 6. AEW made a very late admission of liability right before the trial.
- 7. The Client, AEW, and the Contractor all called factual witnesses to support their respective cases, but AEW decided during the trail to not call its factual witness anymore and withdrew its statements.

Held

- 1. AEW was ruled in breach of contract and negligent in failing to properly design the project works, as well as violating its coordination and inspection obligations.
- 2. The Contractor was required to bear 25% of the common damages.
- 3. The Claimant (the Client) was entitled to recover its adjudication costs against the Contractor, which had already paid them.

Comments

In this case, Mr Justice Akenhead gave a landmark ruling on recovering adjudication costs based on a decision that:

"Adjudication is a fact of life now in construction contracts (note: in UK)... it was within the bounds of reasonable foreseeability that there could be adjudication in circumstances such as arose here. There was a sufficient causative link between the defaults of AEW and this adjudication."

That is to say, in case a sufficient causative link can be found between the party's default and negligence and any subsequent adjudication, all the related costs and expenses in adjudication could be recovered by the other party.

Another key point was drawn from this case – it is vital and important for an expert to understand and analyse the case and the issues behind it. The judge found that AEW's expert was not instructed to consider the most obvious question and the expert declared that he would defend the indefensible (AEW's default) under cross-examination. Finally, the judge concluded that AEW's expert was the one whom he never found to be aware of his duties, given his statement. As a result, the judge disregarded all of the testimony by AEW's expert, calling it "wholly unconvincing" on all the aspects of liability.

Building Material – Bamboo

For building surveyors, when bamboo comes to mind, so do BEAM standards. Bamboo is a readily renewed form of building material, but how readily are we talking about?

The CPD seminar on Building Material – Bamboo was held successfully on 16 December 2013. The BSD was delighted that Mr Tony Chow, Marketing Consultant of Bamboo International, one of Hong Kong's very few bamboo material suppliers, came to enlighten us on the science behind this gem.

Bamboo can be considered a type of grass that grows at a rate ranging from 10cm to 30cm per day. The root of the plant is also unique in that the sprouts are connected in the form of networks. This is known as a rhizome system. With around 1,200 special, one may wish to know that "moso bamboo" is, by far, the most suitable breed of bamboo for construction purposes.

We learned during the presentation that forward-thinking consumers who opt for bamboo as an alternative to timber flooring have a choice between natural bamboo (small expansion rate) and woven bamboo (higher compressive strength), which also gives different patterns.

Despite the high regenerative capacity of this grass, we all remain reasonably skeptical about the use of bamboo in construction. However, one should know that it is already employed as basketball court flooring and outdoor raised floor decks in Hong Kong.

While we let time do the trick of proving bamboo's durability, it is doubtless that its inherit carbon footprint is lower than the alternatives, especially given Hong Kong's proximity to its major bamboo source in China. Passionate about the prospects of this material, Tony admitted that more scientific research is needed to help bamboo take a leap forward as a construction material and help us do Mother Earth justice.
