High-Rise Health Issues

Packed with skyscrapers, Hong Kong is notorious for being a high-density city, with some districts home to over 400,000 people per square kilometre. These extremely cramped living conditions have been identified as a major cause of illness among residents. Aggravating the potential health hazards of dense urban areas is poor management in many of the city's ageing apartment blocks. Buildings, it seems, are like people - without the proper care and attention, they become unhealthy. Property owners and facility management companies need to adopt measures to ensure healthy buildings that in turn, protect the well-being of their residents.

According to a University of Hong Kong (HKU) report in 2013, "The cramped living conditions [in many local residential buildings] make it easy to spread infectious diseases in public areas, such as entrance lobbies and lifts." The paper - Performance of Property Management Companies in High-rise Flats: A Pilot Study - focused on 41 private blocks of flats from Fortress Hill to Chai



Wan and was co-authored by Dr Ervi Liusman, who currently lectures at the Chinese University of Hong Kong (CUHK).

Since the outbreak of Severe Acute Respiratory Syndrome (SARS) in 2003, the performance of many property and facility management (PFM) companies has been under the spotlight, prompting them to step up their game. "These companies now have staff constantly clean the public areas, lifts, and lift buttons. More frequent cleaning is carried out when the government issues warnings against possible outbreaks of infectious diseases," says Dr Liusman. Indoor air pollution is another problem. "When it comes to air quality in public areas, PFM companies can impose bans on smoking in public areas and forbid incense burning outside units and stairwells. But this requires the cooperation of individual residents." Ventilation in old buildings is often inadequate and when people smoke or burn incense in common areas, such as stairways and corridors, the health of residents may be affected. "Poor ventilation in buildings is among the major reasons that many Hong Kong people suffer from allergies," she adds.

Restaurants on the lower floors of mixed-use buildings (where upper floors are residential) often install industrial exhaust systems that produce large amounts of greasy emissions that rise to affect the inhabitants of the upper-floors. "Because the building design cannot be altered, one possible way to mitigate the effect of the exhaust gas is to install a filtering system," says Dr Liusman.

Other potential health hazards in buildings are more physical in nature. Illegal structures, such as balconies and additional floors, exert pressure the original structures were not built to withstand. "Some people knock down the structural walls in their units. It may reduce necessary support for the structure and have an impact on the building's stability," says Wong Kit-loong, CEO and Executive Director of the Hong Kong Housing Society. There have been incidents in which illegal works have fallen off or buildings have collapsed because of unauthorised alterations.

All buildings in Hong Kong are built by registered construction companies in compliance with government standards and regulations. Once completed, residents can only move in after occupation permits have been issued by the

Buildings Department following a thorough inspection. Ideally, they're built to be structurally sound and able to ensure the safety for their inhabitants for at least 50 years. Currently, there is intense debate within the housing sector about the safety of buildings after that time. "In our experience, the key is adequate and sufficient repair and maintenance," Wong notes. "One of the most common safety issues in buildings is spalling concrete. This affects the structural safety of buildings."

As buildings age, the facilities and fixtures in public areas undergo wear and tear. Regular inspections to identify problems followed by repairs and refurbishment are necessary steps to ensure their structural integrity and the safety of the inhabitants. In terms of healthy building practices and the application of the Buildings Ordinance, the rules are the same for public and private residential buildings, says Wong. "They are all required to comply. For private developments, how well they do depends on the building management companies and the owners' corporations and their approach to repairs and maintenance. The maintenance of public housing estates is handled by organisations like the Housing Society. For us, residents' safety is first and foremost. But private PFM companies may have other priorities. Sometimes public space may be sacrificed or the quality of management is compromised owing to the high cost. Nevertheless, I believe strict compliance with regulations and safety standards should be the priority of qualified PFM companies and responsible owners' corporations.

According to Dr Liusman, the HKU study has shown that younger buildings are generally maintained and managed better than older buildings. "In some old buildings that had changed PFM companies shortly before our visits, we observed cracks in ceilings and concrete spalling. The PFM companies soon carried out repairs and maintenance. We also saw that sometimes the quality delivered by the same PFM company varied from one building to another. But it was because the older buildings [with poorer quality of management] had just been taken [over] by the PFM company."

To address the other problems in ageing buildings, including broken and dislodged windows and spalling concrete, the government has implemented the Mandatory Window Inspection Scheme (MWIS) and Mandatory Building Inspection Scheme (MBIS). "Residential buildings

over 10 years should [participate in] the MWIS. However, [this] depends on the owners because they need to pay. The government also requires buildings over 30 years to [participate in the] MBIS," adds Dr Liusman. "PFM companies are supposed to organise structure[al] survey[s] for buildings. But we did not see many buildings that had conducted the structur[al] survey during our site visits."

"For buildings over 40 years, the long-term solution is large-scale thorough renovation. If the PFM companies can achieve this, their performance improve[s]. But the final decision rests with the building owner corporations. The PFM companies can only recommend the renovation." Dr Liusman says the HKU study concluded that efforts by PFM companies have had an impact on building conditions.

In public housing estates, organisations such as the Hong Kong Housing Society ensure that the facilities for ageing buildings meet the current standards in areas such as water and electricity supply, space, lighting and ventilation. Modernisation and retrofitting are key, Wong explains. "For instance, some public housing blocks do not have lifts stopping [on] every floor. This can be inconvenient for elderly inhabitants. We have retrofitted lifts so that they serve every floor. We also enhance other areas, including strengthening the power supply and the security systems."

In an attempt to look after ageing residents of public estates, the Housing Society has added some facilities for them. For instance, elderly and healthcare centres are located within the estates. "This not only helps address their health issues, it also provides preventive measures," Wong notes.

Describing the Housing Society as a 'housing laboratory', Wong says it has developed projects catering to the needs of the elderly with varying levels of financial means. Among them is the new Tanner Hill retirement housing project, which mainly targets senior citizens who want higher living standards. Apart from fixtures and furnishings for the elderly, the development features a traditional Chinese medicine clinic established in collaboration with the Hong Kong Sanatorium and Hospital and a clubhouse with a swimming pool, recreational rooms and a business centre.

多層住宅樓宇

的健康問題

香港高樓大廈林立,城市密度偏高,個別地區的居住密度更高逾每平方公里400,000人,一直為人詬病。居住環境狹窄不堪,是居民患病的主因。市區人口稠密,不少舊樓管理不善,令樓宇健康更加岌岌可危。建築物就好比人體,如果照顧不周,健康就會大打折扣。業主和設施管理公司應採取措施,致力確保樓宇健康,從而保障居民安居樂業。

香港大學 2013 年的研究報告指出:「[本港不少住宅樓宇]居住環境狹窄,導致傳染病容易在大堂入口、升降機等公共地方傳播。」研究報告題為《多層住宅樓宇的物業管理公司表現評估:先導研究》(Performance of Property Management Companies in High-rise Flats: A Pilot Study),由香港中文大學講師劉海慧博士等合著,研究對象為炮台山至柴灣一帶的 41 幢私人樓宇。

自 2003 年爆發嚴重急性呼吸系統綜合症(SARS)以來,不少物業及設施管理公司的表現一直備受關注,促使了這些公司提升管理質素。劉博士指:「現在,這些公司會安排員工定時清潔公共地方、升降機及升降機按鈕。每當政府發出有可能爆發傳染病的警告,員工就會更勤加清潔。」另一個問題是室內空氣污染。「在公共地方空氣質素的問題上,管理公司可將公共地方定為禁煙區,並禁止在單位外及樓梯間燃燒香燭,但這些措施都有賴居民合作。」舊樓往往缺乏足夠的通風設備,一旦有人在樓梯及走廊等公共地方吸煙或燒香,便可能影響居民健康。「樓宇通風不足,是導致不少港人過敏的元兇之一。」

混合用途樓宇的上層用作住宅,而位於低層的餐廳一般設有工業排氣系統,運作時會釋放大量油煙,影響樓上居民。劉博士指:「由於樓宇設計不能更改,其中一個可行辦法是安裝過濾系統,以減輕廢氣影響。」

樓宇內還潛伏著其他較實在的健康危機。違法僭建的露台及樓層等構築物,會造成超出樓宇本身結構所能承受的壓力。香港房屋協會(房協)行政總裁兼執行董事黃傑龍指:「一些住戶拆除了單位內的結構牆,可能導致樓宇結構失去必要的支撐,影響樓宇穩固度。」過往,某些違規建築或樓宇因未經授權更改結構而倒塌的意外屢次發生。

目前,香港所有樓宇都由註冊建築公司按照政府標準及規定建成。竣工後,樓宇須經屋宇署仔細檢驗並發出佔用許可證方可入伙。如無意外,樓宇結構建得穩固,起碼能安全住上50年。現時,房屋業界正就樓齡逾50年的樓宇的安全問題爭論不休。黃傑龍提到:「根據業界經驗,關鍵在於妥善的維修和保養。其中一項常見的樓宇安全問題是混凝土剝落,這會影響樓宇結構安全。

隨著樓齡增加,公共設施及設備亦會耗損。為確保樓宇結構完整及用戶安全,必須定期檢查樓宇並找出問題,然後進行維修翻新。黃傑龍表示,樓宇健康措施和《建築物條例》對公屋和私樓是一視同仁的。「公屋和私樓都必須遵守規定。以私樓而言,情況好壞視乎大廈管理公司和業主立案法團採取的維修保養措施;而公屋則由房協等機構負責保養。我們認為,住戶的安全永遠是首要考慮,但私營管理公司卻可能會先考慮其他因素。有些公司可能會因成本高昂而放棄管理公共空間,或在管理質素方面有所取捨。話雖如此,我相信,合資格的管理公司和盡責的業主立案法團都會嚴格遵守有關規定及安全標準。

劉博士指,港大的研究顯示,樓齡較輕的樓宇的保養和管理一般較舊樓妥善。「我們到訪一些舊樓時,發現天花板出現裂痕,混凝土亦有剝落。這些舊樓才剛換了管理公司,有關公司很快便安排維修和保養。我們亦發現,同一家管理公司對不同樓宇的管理質素雖有參差,但管理公司才接管那些舊樓不久,[管理質素難免未如人意]。」

政府已推行強制驗窗計劃及強制驗樓計劃,解決舊樓窗戶破損、 鬆脱,以及混凝土剝落等種種問題。劉博士補充:「樓齡超過 10年的住宅樓宇需參與強制驗窗計劃,但[這]取決於負責出 資的業主。政府亦規定樓齡超過30年的樓宇須[參與]強制驗 樓計劃。物業管理公司有責任為樓宇進行結構勘測。但我們到 場觀察時,發現不少樓宇都沒有經過勘測。」

「對於樓齡超過 40 年的樓宇,長遠的解決方法是大規模地全面翻新。管理公司若能做到這點,管理質素便會好轉。不過,樓宇的業主立案法團擁有最終決定權,管理公司只能提出翻新建議。」劉博士提到港大的研究結論,指管理公司的努力已為樓宇狀況帶來改變。公屋方面,房協等機構負責確保舊樓的設施符合水電供應、空間、照明、通風等各方面的現行標準。黃傑龍解釋,現代化與翻新工程是非常重要的。「舉例來說,一些公屋並非每層都有升降機,對於長者來說十分不便。我們已翻新這些樓宇的升降機,讓升降機可到達各層,亦改善了供電及安全系統等等。」

為照顧於公屋居住的長者,房協在屋邨內增設了長者護理中心等長者設施。黃傑龍提到:「此舉不但有助解決長者健康問題,亦能防範於未然。」

黃傑龍認為,房協的功能猶如「房屋實驗室」,房協現正多管齊下,提供各種經濟援助,照顧長者需要。其中,新推出的丹拿山長者房屋項目主要為追求更佳生活質素的長者而設。項目除了為長者提供配套設備及傢俱,更會與養和醫院合辦中醫診所,並會興建設有泳池、康樂室及商務中心的會所。

ver the past 30 years, Hong Kong has enjoyed a boom in property development. However, some aged buildings have been poorly maintained. The city's sustainable urban development depends on lengthening the life spans of its buildings, maintaining their facilities, and revitalising older buildings to satisfy the needs of their inhabitants. This issue's cover story looks at the health of Hong Kong's buildings and why comprehensive facility and property management strategies not only keep them in good shape, but also help promote their inhabitants' healthy living.

Sr TT Cheung (Tat-tong) is our featured High Flyer Surveyor in this issue. A well-known quantity surveyor, TT had committed to the institute service at a very young age and is a past President. He has accumulated extensive professional experience in quantity surveying, property development, expert witness to contract dispute cases and expert in dispute resolution works, while staying in the surveying field. He is also committed to community service. No matter the area, Sr Cheung excels in it with his expertise. He inspires us to expand the scope of our expert services.

As part of the HKIS's brand enhancement programme, we have kicked off our Map-making Competition. The goal of the contest is to enhance our youth's understanding of Central and for them to express their visions of Central through creative maps that highlight landmarks and public spaces in this commercial hub. A total of 14 teams formed by secondary school students entered the contest. A historical area, Central embodies significant changes during different periods and features many buildings with innovative designs. Through this competition, we hope to inspire the youth of Hong Kong to imagine its ideal modern cityscape and deepen their understanding of the obstacles to, as well as the opportunities in, urban development.





Also launched in August was our community event named "Touring Central with Surveyors". On August 20, along with representatives of our six divisions, I led a guided tour of Hong Kong's first developed urban hub for a group of local reporters. We hoped that media coverage of the event would entice citizens to sign up for future guided tours led by surveyors, who will enlighten them on Central's history and share their knowledge of its landmarks. In addition, the surveyors will also highlight issues such as ageing buildings, road networks, and land development modes. We hope that the public will become more engaged in informed discussions on urban development.







PRESIDENT'S MESSAGE

會長的話



The end of August is an exciting time for us because the annual JUPAS (Joint University Programme Admissions System) releases its results. It means a lot to us to see high-quality students enrolled in degree programmes in surveying and other related areas. We attach great importance to the nurturing of the next generation of surveyors. However, university education is only the starting point of the students' future careers. Their transformation into all-around professionals requires more than just textbooks. To build the professional knowledge of our six divisions, graduates need comprehensive practical work experience, as we think that some are not fully equipped with the necessary professional knowledge and skills for the "real world". Students should capitalise on their university studies to deepen their professional knowledge by carrying out specific profession-oriented research as early as possible. Universities should also enhance their curricula so that as soon as their graduates join the workforce, they can immediately contribute to their employers.

Recently the Census and Statistics Department released the findings of its research on sub-divided flats, which shed more light on the magnitude of the issue and its details. For instance, the total number of households living in sub-divided flats has increased to 90,000. The study also generated more detailed demographics of the households living in the SDUs. It found that not just low-income families lived in these units. There were also many young people who had just started working living in them because of their convenient locations. Because there is social demand for sub-divided flats. we need to adopt a more holistic approach to the issue. For instance, should the government tolerate those units so long as they meet the basic safety and hygienic standards? We also need to reconsider transitional housing options. The government needs to step up communication with professionals like the HKIS for solutions. Although the HKIS had submitted its recommendations on the issue, it can now look at it afresh with the latest statistics and findings.

三十年來,香港房地產蓬勃發展,部分舊樓卻連年 失修。香港的持續發展有賴延長樓宇壽命、保養樓 宇設施,亦要翻新舊樓,以迎合住戶需求。

今期的封面故事以香港的樓宇健康為題,探討完善的設施及物業管理策略如何有助保養樓宇,改善住戶的生活環境。

今期的傑出人物張達棠測量師 (TT) 是著名的工料測量師,早年已致力服務本會,曾出任會長一職。張達棠測量師在工料測量專業及物業發展方面經驗豐富,近年他專注於擔任工程合約糾紛專家證人工作,對解決工程合約爭議甚有心得。他亦致力貢獻社會,在各方面均出類拔萃,啟發業界努力拓展專業服務的領域。

為配合香港測量師學會的品牌提升計劃,我們舉辦了地圖製作比賽,加深年輕一代對中環的認識,表達他們對中環發展的願景。比賽共有14隊中學生隊伍參與,參賽者在地圖上發揮創意,為這個商業樞紐繪出各種地標及公共空間。中環歷史悠久,隨著時代發展而改頭換面,設計新穎的樓宇四處林立。學會希望通過是次比賽,激發香港年輕一代的想像力,鼓勵他們建構理想中的都市景觀,藉此瞭解都市發展過程中的困難及機遇。

八月份,學會亦舉辦了名為「測量師帶你行街 GUIDE」的社區活動。八月二十日,本人聯同學會六個界別的主席及代表,帶領傳媒遊走新舊建築並存的中區。學會希望藉由媒體報道該次活動,吸引市民報名參加之後的導賞團,由測量師向市民介紹中環的歷史和地標建築。測量師亦會帶領公眾思考貼身的問題,包括:樓宇老化、道路網絡、土地發展及規劃等話題。學會希望加深公眾對城市發展問題的認識,從而積極討論相關議題。

八月底是一年一度的香港大學聯合招生辦法(簡稱 JUPAS)放榜日。眼見不少高材生入讀測量及其他相關科目的學位課程,對本會意義重大。本會十分重視培養下一代測量師。不過,大學只是學生建立事業的起點。要成為學富五車的專家,不能單靠課本內的知識。畢業生需要豐富的實踐經驗,才能學習到本會轄下六個界別的專業知識。依我所見,部分學生缺乏應付「真實工作」所需的專業知識及技能。學生應運用大學所學,盡早從事相關專業的研究,提升專業知識水平。大學亦應提升課程質素,讓畢業生迅速適應職場需求。

近日,政府統計處公佈對「劏房」的研究結果,進一步披露了「劏房」問題的嚴重性及相關資料。舉例而言,「劏房」單位的總數已增加至九萬戶。研究亦分析了各類「劏房」住戶,指出入住的不只是低收入家庭,因其位置方便,亦吸引了眾多職場新人。鑒於社會對「劏房」確有需求,我們需要從更宏觀的角度研究相關問題。例如,如果「劏房」單位符合基本的安全及衛生標準,政府應否容忍它們繼續存在?此外,我們亦要重新考慮提供過渡性的住屋選擇。政府需要為別量師學會等各方專家多加溝通,尋求解決方法。香港測量師學會早前已就「劏房」問題遞交建議,亦會根據最新的統計數據及研究結果繼續審視這個議題。

NATURAL-BORN LEADER

Sr T T Cheung has been described as a visionary due to his talent for identifying emerging opportunities ahead of others and leading the profession in its drive to achieve goals that have had a far-reaching impact not only on the profession in Hong Kong but also overseas.

Cheung could be described as a natural leader. Since early childhood he has taken up many leadership roles. He was class representative at primary school, a college prefect and house captain at secondary school, the resident hall students' association chairman and student senator at university and then the leader of local and international professional associations. "Leadership qualities can be cultivated from childhood. In life, we need to compete with others for survival and to stand out," notes Cheung, who was HKIS President from 2004-2005.

His dedication to the surveying sector has motivated him to expand the local profession, particularly quantity surveying, taking it out of Hong Kong and winning global recognition. Cheung was Chairman of the Pacific Association of Quantity Surveyors from 2001-2003 and is Chairman-elect of the International Cost Engineering Council for 2016-2018. In the 1990s, he was pivotal in introducing international practices to the mainland quantity surveying profession.

The traits of a leader include vision, mission and charisma, says Cheung. "A leader's vision should be identified with by others. Driven by his mission, he sets a clear plan of action to realise his vision.'

On top of these traits is perseverance. While President of HKIS, Cheung created the Property and Facility Management Division because he agreed with the vision of some pioneer surveyors on the potential of this specialised field opened to surveyors. "The creation of a new division at HKIS requires a referendum because it involves amendment to the constitution. Our proposal was not passed on the first attempt," Cheung recalls.

It took considerable lobbying in the second attempt. "I led the preparation work and with much effort, eventually we got the new division established. It has been more than 10 years since and the division has been doing well. Although I was not the only one working on its establishment, as president I led it. I motivated the others with my vision, mission and charisma. This has had a long-lasting impact on the industry. It is not just an additional division at HKIS. It has helped those outside the sector recognise that surveyors can deliver high-quality property and facility management services."

Success means never feeling tired,

Cheung is also among the field's leading lights, helping the local profession gain national and international exposure and tapping business opportunities. Under the Closer Economic Partnership Arrangement between the mainland and Hong Kong, some local professional service providers can deliver their services across the border. On behalf of HKIS, Cheung negotiated with government officials and their mainland counterparts. "Because it concerned national-level policy issues, initially it was a challenge and involved numerous meetings in Beijing. We encountered resistance from our mainland counterparts. It's tough for us to get the mutual recognition from them. Eventually the HKIS Quantity Surveying Division, which I represented, signed a mutual recognition agreement with the China Engineering Cost Association (CECA), the national body representing the cost profession in China, in 2005 in Beijing. This was accomplished partly because of my deep personal relationship with CECA," he adds. "Our relationship has been built on great mutual trust. We always have cordial discussions and I have helped them with many improvements."

Back in the early 1990s, there was no concept of quantity surveying on the mainland because engineers led the estimation of building costs. Cheung was among the individuals who helped set up meaningful exchanges between CECA leaders and scholars from Hong Kong Polytechnic University, he notes. "We helped them set up advanced research on practices of international quantity surveying. HKIS can take some credit for helping shape the current professional cost engineering practices in China."

Cheung has been involved with CECA for 20 years. "I've been one of the three speciallyinvited national-level committee members (who are not mainland Chinese) for 12 years. I've helped bridge the Chinese association with

international ones and bring Chinese regulations in line with international standards," he notes. As the Pacific Association of Quantity Surveyors Vice-chairman, Cheung led a delegation to the mainland in 1999. "At that time, Chinese officials wanted to align domestic practices with international ones. These visits facilitated exchanges that had far-reaching impact."

Cheung's effort and vision came to fruition in 2005 when the first batch of 200 members of the HKIS Quantity Surveying Division received mutual recognition on the mainland, which allowed them to practice there. "We were the first profession to achieve this amongst architects, engineers and other surveying disciplines" he adds.

"The impact on Hong Kong's quantity surveying field has been profound. This recognition equals professional mainland qualifications. It means HKIS Quantity Surveying members can handle projects on the mainland upon registration. These days, over 50 per cent of the existing projects in the portfolios of most Hong Kong quantity surveying firms are in China."

In the international arena, Cheung has helped raise the profile of Hong Kong surveyors. He was the PAQS Chairman from 2001 to 2003 and introduced significant changes to the association. He helped the association set up a research committee to build on its international profile. He advocated reforms requiring those who attend the annual meeting to only be current leaders of member associations, so that it would not turn into a 'social club'. "This has helped ensure that the meeting will have meaningful exchanges on the latest important developments in different regions," he notes. "I also attached great importance to nurturing young surveyors and cultivating their global perspective, hence the 'Young Quantity Surveyors Group' was established. I also helped form the Council of Advisors to tap into the expertise and vast experience of past council members. I have remained the convenor of this council."

Cheung's international contributions to the profession will peak when he is elected Chairman of ICEC for 2016 to 2018. He will be the first Chinese to assume that position. He has been the association's Asia-Pacific Director for eight years. ICEC has over 40 member countries and regions representing more than 120,000

project cost management professions over the world. It is recognised by other international associations such as PAQS and the International Federation of Surveyors (FIG). Cheung says he aims to strengthen the association by capitalising on its global platform.

The right attitude in life is what has driven Cheung throughout his successful career and he advises young professionals to adopt the same. "We should have passion for what we do. Diligence is key. The world is fair because everyone has 24 hours a day and we need professionalism and motivation for a lifetime of learning." Cheung began studying law when he was 47 and now he has a Juris Doctor degree in addition to his first class honour BSc degree in QS from HKU and MSc degrees in UCL and other professional qualifications.

Coming from a grassroots background, Cheung's studies, local & overseas, were supported by multiple scholarships, bursaries, grants and loans. "That's given me a passion for community services. To show my gratitude for the support I received in my younger days, I am willing to pay back society by taking up public offices and contributing to charities," notes Cheung, who sits on many government committees such as the Housing Authority, the Hospital Authority, the ICAC, Construction Industry Council, Construction Workers Registration Authority, Licensing Appeals Board, Appeal Board Panel (Town Planning), just to mention a few..

He has also been involved with the Duchess of Kent Children's Hospital for over 20 years and is Vice-chair on the board of the Society for the Relief of Disabled Children. Since 2008, Cheung has co-organised the "Kids on the Block" puppet show with the Hong Kong Society for Rehabilitation. The show teaches primary school children about the harmonious integration of the disabled into society. Around 200 performances are held at schools each year and over 300,000 students have seen the show since 1995.

Cheung has been recently appointed by the Housing Authority as chairman of the Review Committee on quantity assurance issues relating to fresh water supply of public housing estates. Cheung seems to have never ending energy. His motto is "Success means never feeling tired"

張先生認為領袖必須目光遠大、心懷使命,並具備個 人魅力等特質。「身為領袖,其願景應足以引起他人 共鳴,並須肩負起使命,制訂清晰的計劃實踐願景。」

除了這些特質外,領袖最重要是具備堅毅不屈的精 神。張先生出任香港測量師學會會長時,贊同一些測量師的前瞻觀點,認為物業設施管理是有待測量師拓 展的專業領域,因此創立了物業設施管理組。他憶述: 「創立新組別的過程涉及修訂香港測量師學會章程, 必須在會員大會投票通過,但議案在提交第一次投票 時卻遭到否決。」

有感正確的人生態度是開創事業成就的動力,張先生建議年輕同業應立定正確的人生態度。「我們對工作要有熱誠,勤勉不懈自是不二法門。這個世界很公平,每個人每天都只有24小時。我們必須保保47時間,然便被持法,不可能有多數 張先生 47 歲開始修讀法律,不但擁有香港大學工 料測量一級榮譽理學士學位、倫敦大學學院建築 管理理碩士學位及其他專業資格,現時更取得法 律博士學位。

張先生來自草根家庭,多年來全靠獲取獎學金、助 學金、學費減免及貸款來完成在本地及海外學業。「這些歷練使我熱心投入社會服務。很感激社會在我年少時給予幫助,沒有這些幫助我便沒有今天。因此我很樂意擔任公職事務等。支持悉屬之

回饋社會。」張先生現為多個政府委員會的委員,包括房屋委員會、醫院 管理局、廉政公署、建造業議會、建造業工人註冊委員會、牌照上訴委員會、上訴委員團(城市規劃)等。

此外,張先生亦服務了大口環根德公爵夫人兒童醫院超過20年,現時為香港弱能兒童護助會副主席。張先生自2008年起,代表香港弱能兒童護助會與香港復康會合辦「街坊小子木偶劇場」,教導小學生何謂傷健共融的社會。「街坊小子木偶劇場」每年在本地中、小學演出約200場,自1995年至今已有逾300,000名學生觀賞表演。

張先生最近更獲房屋委員會委任,出任公共屋邨食水供應問題品質保證檢討委員會主席。即使身負多項重任,張先生仍似有無窮精力,他的座右銘 是「成功永不言倦」

Visit by the Executive Secretary of the IPMSC's Standards Setting Committee

The Executive Secretary of the Standards Setting Committee of the International Property Measurement Standards Coalition (IPMSC), Mr Alexander Aronsohn, accompanied by Ms Mina Leung of RICS Asia, visited the HKIS on 4 August and was welcomed by the HKIS Senior Vice President, Sr Edward Au; Chairman of the General Practice Division, Sr Joseph Ho; and members of the Standing Committee on the Code of Measuring Practice, including Sr Dr Lawrence Poon (Chairman), Sr Ronald Chan, and Sr Lam Lit Yin.

There was dialogue and an exchange of views on the development of International Property Measurement Standards (IPMS) by the Standards Setting Committee, which is a group of 65 professional and non-for-profit organisations from around the world. The IPMS will ensure that property assets are measured in a consistent way, creating a more transparent marketplace, greater public trust, stronger investor confidence, and increased market stability. The IPMS for Office Buildings have been published and the IPMS for Residential Buildings are currently under consultation until 30 September 2015.

The Standing Committee on the Code of Measurement Practice will follow up on the study to see how the IPMS can be adopted by the HKIS.

The HKIS Dissertation / Thesis Award 2014 Executive Summary of Winning Papers

The Importance of Hong Kong Mortgage Corporation: Impacts of Mortgage Loans Securitisation on Banks' Capital Adequacy

In recent years, the loans allocated to the real estate sector by banks have increased and many banks have financed a large number of long term loans by short term deposits. Eventually, concentration and liquidity risks resulted. Hence, the Hong Kong Mortgage Corporation (HKMC), which was modelled after the U.S. mortgage corporations Fannie Mae and Freddie Mac, was established in 1997 to enhance bank liquidity and capital adequacy.

However, since Fannie Mae and Freddie Mac helped introduce sub-prime mortgages to the U.S., which caused a devastating housing crisis there, this thesis intends to see if a similar devastating crisis could ever happen to the HKMC and Hong Kong's real estate sector (whose quantity of residential mortgage loans is similar to that of the U.S.).

With regard to such, I first investigated the impact of mortgage loan securitisation guaranteed by the HKMC on the capital adequacy ratios (CAR) of the three largest banks in Hong Kong, namely HSBC, the Bank of China (HK) (BOCHK), and Hang Seng Bank, by performing simulations to observe the changes in each bank's CAR ("a percentage of the institution's capital base to the sum of the institution's risk-weighted amount for credit, market and operational risk") at different percentages of the mortgage loans securitised by the HKMC. Then, I studied the HKMC's effectiveness in securitising the mortgage loans of these three banks. All this aimed to answer the ultimate question of this paper – Is the HKMC doing enough to provide sufficient liquidity to Hong Kong's banks?

From the results, I discovered that a large number of mortgage loans being securitised by the HKMC only led to a small percentage increase in each bank's CAR level. Furthermore, the 215 million mortgage loans that the HKMC securitised in 2012 only occupied a small percentage of the mortgage-backed securities of HSBC, BOCHK, and Hang Seng with very high mortgage exposure in Hong Kong.

These results did not support the explanation that the high CAR levels of Hong Kong's three biggest banks were due to the mortgage loans securitisation backed by the HKMC. Therefore, it can be concluded that the HKMC did not do enough to provide liquidity to banks in Hong Kong.

A Study on Innovation Climate and Obstacles in Implementing Green Construction in Hong Kong Construction Companies


Hong Kong's construction industry has started to implement more green practices during the construction stage in recent years. However, not many construction companies

have implemented them on a large scale. It is believed that a lack of resources and interest by the companies are the major reasons for the low green construction participation level. Therefore, the obstacles to green construction in regards to an innovative climate and leadership are examined in this study.

Green construction can be understood as practices that reduce pollution, while an innovative climate consists of resources and support from construction companies. Leadership, on the other hand, has three types, namely transformational, transactional, and passive-avoidant leadership.



Simplified model showing the relationship between green construction, innovative climate, and leadership

Questionnaire surveys and interviews were administered for this investigation. The results showed that Group C contractors implemented higher levels of green construction than Group B contractors. Also, Group C contractors enjoyed a stronger innovative climate and transformational leadership, while Group B contractors demonstrated stronger management-by-exception management and weaker innovative styles.

In summary, support for innovation and resources are positively and directly associated with green construction, while certain types of leadership affect green construction indirectly by presenting an innovative climate, as shown below.

With these results, it is hoped that Hong Kong's construction companies can gain a better understanding of the obstacles to green construction and develop corresponding strategies to implement green construction more effectively.

Our Hon Treasurer, Sr Tang Chi Wang, will represent the HKIS at this event.

Some BS firms have kindly agreed to arrange tours for the BSPs to visit their offices in order to let them gain a better understanding of BS's work. I am glad to see an improvement in the quality of the students admitted into surveying programmes in recent years and am sure that they will support the continuous growth of the BS profession.

Waterproofing is a Common Part of a Building

In a 2014 court judgement, "Wing Ming Garment Factory, Ltd v Wing Ming Industrial Centre (IO)," the Court of First Instance reaffirmed that, "...the waterproofing membrane in the upper roof was a common part of the Building..." This reinforced the decision of the Court of First Instance, which upheld upon appeal the 2009 case of "Hong Leong Industrial Complex v HL Resources, Ltd" (4 HKC 463) back in 2010.

Consequently, it is now mandatory to find a way to resolve the problem arising from removal of the top layer roof finishing from a building before re-roofing it, since the owner of the roof may put forward an excessive/disproportional claim against the co-owners/the IO for lifting the roof finishing to perform the re-roofing. This would greatly affect the building surveyor's work in renovation and maintenance. A CPD is being organised to discuss the devil of the common parts, so please stay tuned for further details.

Report on SEASC 2015

13th South East Asian Survey Congress

The 13th South East Asian Survey Congress was held in Singapore from 28-31 July. It was hosted by the ASEAN Federation of Land Surveying and Geomatics and the Singapore Institute of Surveyors and Valuers. It provided a platform for governments, industry, and academia to discuss the opportunities in and challenges of geospatial data creation, maintenance, and management. The theme of the Congress this year was "Expanding the Geospatial Future". Over 80 papers on the topics of satellite navigation, laser scanning, imaging, 3D GIS, cadastres, building information modelling, mobile mapping, and monitoring systems were delivered by surveyors and geospatial experts. The programme also featured three plenary sessions on geospatial visionaries, enablers, pioneers, regulators, and solution providers.

The Congress attracted over 400 participants from the Southeast Asia Region and various countries. A HKIS Delegation including Sr Simon Kwok (HKIS Immediate Past President), Sr Dr Conrad Tang (LSD Vice Chairman), and Sr Alberich Yu (LSD Council Member) attended the Congress.

Sr Simon Kwok delivered a presentation on the Modernisation of Height Systems in Hong Kong at the pre-Congress technical seminar on vertical reference frames, which was organised by the International Association of Geodesy (IAG), International Federation of Surveyors (FIG), UN Global Geospatial Information Management for Asia and the Pacific (UN-GGIM-AP), International Committee on GNSS (ICG), and the Singapore Land Authority. Sr Kwok discussed Hong Kong's experience in modernising its vertical height system. He covered: (1) the comprehensive re-levelling of the benchmark network; (2) the re-adjustment of the levelling measurement with reference to the Hong Kong Principal Datum; (3) the densification of a network of points covering

the whole territory of Hong Kong with levelling, GNSS, and gravity observations; and (4) the creation of a geoid model for GNSS heighting.

Sr Dr Conrad Tang, Vice Chairman of the LSD, chaired the technical session on cadastral innovation. Sr Tang and his PhD student, Mr Zhang Haodong, delivered a talk on *A Structured* Evaluation Model for Cadastral Survey Systems and its implementation in Hong Kong.

Sr Yu attended the various technical sessions and equipment exhibition. He was impressed by the equipment and software for streamlining the point cloud data rapidly captured by the laser scanner to produce a 3D map, the intelligent automatic system for setting out and machine guidance, and the virtual design construction process (VDC) using BIM to review the works project and solve the design mismatch.

It was warmly received by Mr Soh Kheng Peng, Chief Surveyor of Singapore and the Director of the Land Survey Division of SLA. The Quality Property and Facility Management Award 2016

The QPFMA is a biennial award that has been jointly organised by the HKIS PFMD and the Hong Kong Association of Property Management Companies (HKAPMC) since 2010. The QPFMA 2016 will be the fourth ceremony for the award that honours and stimulates greater public recognition of the outstanding projects in the property and facility management industry. All of the award-winning projects delivered contemplative performances in terms of comfort, safety, and security to their users and occupiers, whilst complying with the law and respecting the environment. A joint working group has been formed by the HKIS/ HKAPMC to organise the details of the Award and members will be updated on its progress.

物業設施管理測量師在綠色城市所扮演的角色

香港地小人多,住屋擠迫,由住宅或工商業衍生的環境污染問題,亦相對其他經濟發達地區嚴重。作為對社會責任有承擔的物業設施管理測量師,須建立一套具可持續性的物業管理系統,融入廣為人知的環保 3R 原則,並定期進行評估及監察,確保日常業務如處理廢物、清潔、維修、裝修及翻新工程等運作,對環境的影響減至最低,也能減低對堆填區的壓力。須提醒管理層持續投放資源,承諾定期檢討環境因素及持續不斷作出改善,對環保議題出一分力,讓員工、顧客及公眾對其企業政策更有信心。

為推行有效的物業管理系統,測量師須先對企業運作的流程 作出環境影響評估,並制定計劃方案及員工指引、訂立目標, 以逐步實施減低對環境的影響。管理層除須定期作出內部檢 討外,亦須委任外部專業機構作出審核,以評估其目標成效。 企業亦可透過申請環境管理認證、以及參與環保獎項,例如 ISO14001、綠建環評等,以獲得專業肯定。

在過去的30年,香港市民產生的個人平均固體廢物量,由 每天 0.97 公斤大增三成至 1.27 公斤,惟鄰近的台灣及南韓 同期則錄得下降,故推行廢物管理及相關公眾教育實屬刻不 容緩。貫徹「環保 3R」的原則,廢物處理應首先以減少使用 (Reduce) 為大前題,面對全球暖化,減少能源消耗及碳排 放量變得日益重要。香港因缺乏土地及資源發展再生能源, 故香港政府致力推動大廈節約能源的發展,務求各類型大廈 均能減低能源消耗。為有效提高節約能源效益,物業管理人 員可以透過能源審計及碳排放審計分析能源消耗情況,從而 制定出針對性的節約能源計劃。若減少使用已是無可避免, 第二步應考慮採用可重覆使用的設計(Reuse),例如可拆除 及重新安裝的配件、可重覆使用的包裝及容器。最後,廢棄 前亦應作第三層管理,透過源頭分類回收(Recycle)、或安 排於二手市場出售或交換,盡量減少棄置廢物,降低堆填區 的壓力。一些具污染性的廢物,例如化學品、醫療廢物、廢 油等,更需要安排專業回收商進行回收,以免引致環境污染 及影響個人健康的問題。

與此同時,要提升香港市民的生活質素,政府及私人發展商的綠化、園境與樹木管理工作發揮著重要的作用。透過設計及栽種樹木、灌木、花草,塑造園林景色及植被,達致改善城市「水泥森林」的型態,以營造一個供人觀賞、休憩、工作及居住的舒適環境,並減少「熱島效應」及改善環境和生態,近年高空綠化也成為新趨勢,透過全面的綠化,園境與樹木管理措施,既能讓香港市容更加優美,也令香港締造一個理想的生活與休憩空間,長遠而言更能提升香港的國際形象。

室內空氣質素管理提醒物業持份者對室內空氣污染物的控制,香港政府推出的自願性室內空氣質素檢定計劃有助用戶知道室內空氣的質量,計劃有兩個級別,即卓越級和良好級,藉此鼓勵持份者追求室內空氣質素的最好水平,改善生活。

在建築設計和選料上,建議採用可持續物料,雖然起初成本較高,但當計算生命週期,反而較經濟,屋頂綠化能減低大厦的能源消耗;光催化物料可藉著光能和二氧化鈦清除空氣中的污染物,也有除霉殺菌的功效;木塑材料可廣泛用於外地台,公園長凳和兒童遊樂設施等。

為協助物業設施管理從業員有效推行綠色物業管理,香港測量師學會物業設施管理組已編制一本綠色物業管理實務手冊(Green Property Management Practice),內容函蓋綠色物業管理概念、能源管理、節省用水管理、廢物管理、園林綠化管理、環保相關法規及環保應用設計。若從業員能廣泛地運用,長遠而言定能改善香港的環境和提昇港人的生活質素。

Progress Report of the 2015 Year Plan

At the beginning of my term as Chairman of the QSD, I set some major tasks for it to accomplish this year. It has been over nine months since the start of my term and I am happy to announce that the QSD has achieved many of its goals. I want to present the updated 2015 Year Plan as follows:

- 1. Mainland Issues
 - The QSD recently concluded with CECA a second supplementary agreement for the third batch of qualification assessments for members of CECA and the HKIS under the Reciprocity Agreement. The execution of the same is scheduled for mid October.
 - The visit to our Foshan counterpart is scheduled for 6-7 November. A seminar will be arranged there during that time.
- 2. The HKIS and AIQS Joint Conference is scheduled for 14 November. More details can be found in the last part of this month's Chairman's Message.
- 3. Two new Practice Notes for Quantity Surveyors on the subjects of "procurement" and "pre-contract estimates and cost plans" have been prepared and uploaded to the

HKIS website: http://www.hkis.org.hk/en/publication_sales.php. The hard copies of the same are being arranged.

- 4. The QSD attended the 19th Pacific Association of Quantity Surveyors Congress 2015 in Yokohama, Japan from 28 May to 1 June. A detailed report of this was included in the June issue's Chairman's Message.
- 5. The Independent Role of Cost Consultants in Infrastructure Projects and Security of Payment Legislation
 - Cost overruns in several major infrastructure projects have recently aroused much public concern. The QSD has raised the important role of independent cost consultants serving as a check and balance between independent design teams and cost control. It will continue to liaise with the Development Bureau (DevB) over the issue of independent cost consultants in infrastructure projects.
 - The QSD has actively worked on the issue of security of payment legislation. More details can be referred to in the June issue and this month's Chairman's Message.
- 6. The QSD has continuously followed up on the implementation of NEC with the DevB.
- The QSD has conducted continuous QSD activities, some of which are listed as follows:
 - New Members Welcoming Party on 4 March (see the March issue's Chairman's Message).
 - HKIS Quantity Surveying Division Scholarship Presentation Ceremony on 1 April (see the April issue's Chairman's Message).
 - HKIS QSD Annual Dinner on 12 June (see the June issue's Chairman's Message).
- 8. The QSD will continue to monitor the MOU with South Africa and Ghana.
- 9. The QSD has organised CPD/PQSL events in diversified areas, including joint CPD events with other divisions and institutions. More details can be found in separate parts of this month's Chairman's Message.

Promotion of the Quantity Surveying Profession

As reported in the January and July issues' Chairman's Messages, the QSD always plays an active role in promoting the quantity surveying profession to the general public. Apart from delivering career talks at secondary schools, it has also published the following four articles in Classified Post.

Through these publications, I hope that the general public and students can learn more about quantity surveying.

Security of Payment Legislation

As reported in last month's Chairman's Message, the QSD has closely followed the Security of Payment Legislation (SOPL). Two forums for collecting members' comments were organised by the QSD and HKIS on 2 and 20 July, respectively. A Working Group led by our Vice Chairman, Sr Raymond Kam of the General Council, was also established in July to study and review the SOPL and a preliminary meeting was held with the DevB on 20 August. Working closely with the HKIA and HKIE, a report summarising the HKIS's opinions and comments on the SOPL will be submitted to the DevB. The opinions and comments will also be circulated among members.

During the aforesaid forums and meeting, some key items for discussion were:

- 1. Coverage of the SOPL: new building works, renovation and maintenance works, oral contracts, consultancy engagements, and supply contracts.
- 2. The impact of the SOPL on the prevailing contract administration of general building works (e.g. payment procedures, payment certification, pay when paid, pay when certified, conditional payment, nominated sub-contracts, etc.).
- 3. Adjudication: the conditions for commencing adjudication, the criteria for being an adjudicator, an adjudicator's default appointing body, and the time constraint in handling a case (e.g. quantum or EOT claim).

The consultation period for the proposed SOPL will expire on 31 August. The HKIS asked the DevB to extend the consultation period to 30 September and the DevB has agreed to take into account all comments it receives by 30 September. Members are encouraged to submit their comments directly to the DevB.





