

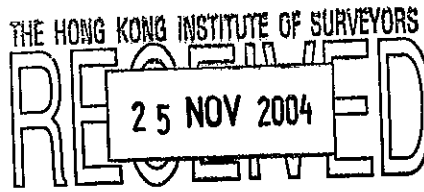



To facilitate discussion, your organization is requested to **make a written submission** and forward it by **10 December 2004** to the Clerk to the Panel on Planning, Lands and Works, Legislative Council Secretariat, 3/F, Citibank Tower, 3 Garden Road, Central (or by fax at 2869 6794 or e-mail at cshiu@legco.gov.hk). The submission should preferably be in both Chinese and English and with a softcopy as well.

You are invited to note that in line with our usual practice, written submissions received will be made available to the media and the public, and uploaded onto the website of the Legislative Council, unless you have advised otherwise. You may also wish to note that when addressing the Panel, you are not covered by the protection and immunity provided under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382). Your written submission is also not covered by the Ordinance.

On the date of the meeting, representatives are requested to arrive **15 minutes before the meeting time**. On arrival at the Legislative Council Building, they are required to obtain entry passes at the Security Control Post at the entrance beside the carpark before proceeding to the Waiting Room on the second floor. They will be invited to join the meeting when members are ready. Please note that representatives are required to wear the entry passes at all times while in the Building and return them to the Security Control Post before leaving the Building.
