# PRESIDENT'S MESSAGE

The year 2014 marks the 30th Anniversary of the Hong Kong Institute of Surveyors. Throughout the past three decades, the Institute has been growing significantly. It started with 85 members on 26 April 1984 and has now expanded to 8,000 members.

The success of the Institute is the result of the hard work of its members. I would like to express my heartfelt thanks to our founding members and past presidents for their vision and leadership. My thanks also go to every member whose contributions have made the industry flourish. During the past 30 years, there were many memorable and important activities in the Institute's history. For the HKIS 30th anniversary commemorative publication, we have compiled a chart of the Institute's major milestones from 1984 to 2013 to document the development of the profession.

The HKIS is dedicated to setting the standards of the surveying industry, developing outstanding surveyors, and making contribution to Hong Kong's development. As a reputable and responsible professional organisation, HKIS has received widespread recognition. We actively engage in social issues that are related to land, property and construction. In recent years, we have contributed our expertise to the areas of land and housing supply, building safety, sub-divided flats, arbitration on land premiums, building maintenance, resumption and compensation, first-

hand sales of residential properties, adverse possession, land boundaries, regulation of the property management industry, implementation of waste reduction by waste charging, and construction dispute resolution through mediation and arbitration.

With the liberalisation of the Mainland market, the ties of Hong Kong's surveyors with their Mainland counterparts have strengthened significantly. Since the introduction of the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA) in 2003, the Institute has continuously worked with its Mainland counterparts to develop agreements for the mutual recognition of each other's professional qualifications. As a result, 763 HKIS members have acquired the corresponding Mainland qualifications, while 834 Mainland surveyors have acquired HKIS qualifications. In view of the increased number of HKIS members working in Mainland, the Institute opened its first branch office in Beijing in November 2013. Through this new office, the Institute wishes to provide better support to its members working in Mainland and to establish closer connections with the Mainland government organisations, professional institutions and industry partners.

Surveying is a global industry. Our members' services cover Hong Kong, Mainland, Asia and the Pacific, and various parts of the world. The Institute is actively involved in international efforts to set standards for surveying practices and to tackle global problems in the areas of climate change, natural disasters, urbanisation, valuation and provision of housing and food. On the international level, the HKIS has entered into reciprocity agreements with various professional organisations from the UK, Australia, New Zealand, Canada, Singapore, and Japan.

2014 will be a memorable year with a series of events to mark the 30th anniversary. I look forward to seeing you at these functions to celebrate the Institute's achievements together.

I would like to express my sincere thanks to all surveyors, HKIS secretariat colleagues and counterparts in the community for their support for and contribution to the Institute's remarkable development. I wish the HKIS and its members every success in the years to come.

2014 年是香港測量師學會成立 30 週年誌慶,在過去的三十年,學會發展迅速,會員人數由 1984 年 4 月 26 日創會時的85名增加至現在的 8,000 名。

學會有今天的成就,實在有賴會員上下眾志成城的努力。我 衷心感謝創會會員的遠見及各位前會長的傑出領導,亦感 謝每一個會員的寶貴貢獻,令測量專業得以蓬勃發展。學會 在過去的 30 年,有著很多值得紀念的事件,在學會 30 週 年紀念特刊,我們特別編撰了由 1984 年至 2013 年的大事 表,以紀錄學會發展的重要里程碑。

學會一直致力訂立行業標準及專業守則,以及培育傑出的測量師,並為香港的發展作出貢獻。現時學會已成為一個有信譽,負責任的專業團體,並獲得社會廣泛的認同。一如既往,學會積極參與有關土地、房屋及建築的事務,為社會關心的問題以專業角度出謀獻策。近年學會關注的社會政策是土地及房屋供應、樓宇安全、劏房、補地價仲裁、樓宇維修、收地賠償、一手住宅物業銷售、逆權侵佔、確定土地界線、監管物業管理行業、實施垃圾徵費、通過調解和仲裁以解決工程糾紛等。

隨著中國內地開放市場,香港測量師與內地業界之合作關係越見緊密。自2003年建立《更緊密經貿關係的安排》(CEPA),學會已與內地各相關的專業團體,落實有關專業資格互認的協議。在互認協議下,已有763名香港測量師學會會員獲得了內地之專業資格,而內地亦已有834名測量師,獲得香港測量師學會資格。隨著學會在內地工作的會員人數不斷增加,學會於2013年11月,在北京開設第一個代表辦事處,為會員提供更佳的支援服務,並與內地的業界、專業團體和政府部門加強聯繫。

測量專業是全球性的行業,香港測量師的服務涵蓋香港、中國、亞洲及太平洋地區、以至世界各地。學會一直積極參與國際合作,制定全球性專業標準,並尋求解決方案,以對應氣候變化、自然災害、城市化、估價、房屋、食物供應等全球性問題等。在國際層面上,學會與英國、美國、澳洲、新西蘭、加拿大、新加坡及日本等多個專業學會均有互認協議。

在今年將會有一連串的活動,以慶祝學會 30 週年,期望各位會員踴躍參與,一同分享慶祝學會成就的喜悦。

我衷心感謝所有測量師、學會秘書處職員及社會各界對測量 專業的鼎力支持,令學會得以蓬勃發展。在此,我祝願學會 和各會員事業蒸蒸日上。 ■■

## Message from Beijing Forum 北京議會消息

#### Gathering in Beijing

On 16 April, the Institute's Beijing Office held its first members' gathering since it opened. More than 30 surveyors from the Building Surveying, General Practice, Quantity Surveying, and Property & Facility Management Divisions joined the gathering. There was a palpable air of excitement as members met and made each other's acquaintance for the very first time that evening. Everyone was very happy about finally having an office in Beijing. To both the China and Hong Kong members working in Beijing, the office not only strengthened their sense of affiliation with the Institute, but also allowed them to easily keep track of the latest news on its work.

During the gathering, members actively expressed their wishes for the future development of and the way forward for the Institute, its Beijing Office, and the surveying profession in China. They hoped to see the Beijing Office act as a bridge to enhance the exchanges between the Hong Kong-based and Beijing-based members. Furthermore, they expected that through channels already well-established by the Institute, the Beijing Office could help Beijing-based members keep in touch and strengthen communication with the relevant government authorities and promote the surveying profession in Beijing.

In order to forge closer communications between Beijing-based members and to advance the professional knowledge, experiences, and surveying practices of individuals, the participants suggested that the Beijing Office take the opportunity to share more information with them on local professional surveying practices and organise more activities, such as gatherings, events, experience-sharing sessions, visits, symposiums, and forums. They also expressed their desire to participate in events in Hong Kong and to have Hong Kongbased members visit Beijing to share their experiences with them.

The development of the next generation of surveyors in China was another topic that attracted a lot of discussion that evening. Members shared their views and strongly wished that the Beijing Office could help promote and develop the surveying practices of the Institute in China.

The expectations and suggestions raised by the Beijing-based members really gave the required support and encouragement

to the Beijing Office to start its work on developing the surveying practice there with confidence.

## The HKIS Dissertation/Thesis Award 2013 - Executive Summary of Winning Papers

## Factors Affecting Spatial Autocorrelation in Housing Prices: An Empirical Study of Hong Kong

PhD Category • Awardee : **LO Daniel Yet Fhang** University of Hong Kong

The thesis attempts to investigate the factors that affect the formation of and changes in spatial autocorrelation in housing prices. Based on an information search framework, we put forward three hypotheses. First, market price volatility depresses spatial autocorrelation. As in any other commodity market, past sales transactions in real estate are important sources of price information, which become more obsolescent and, hence, fail to be good price indicators when the market is volatile. Traders are compelled to rely less on past sales to establish the current prices of housing units. Consequently, spatial autocorrelation will diminish if one broadly follows the same line of logic.

As a result, the second hypothesis was constructed and states that market liquidity dampens spatial autocorrelation. Given that market liquidity reflects the amount of price information being circulated on the market, traders in a "thick" market do not necessarily have to infer from the transaction data of geographically distant properties. Hence, a weaker spatial autocorrelation of the "pool of housing prices" results.

Third, building age is crucial in assessing a property's redevelopment potential, the value of which is largely independent of the transaction prices of other properties located nearby. Assuming that a property's total value is an addition to its use and redevelopment values and that the former's role decreases while the latter's increases with age, one can further hypothesize that spatial autocorrelation decreases as building age increases. Several spatial autoregressive hedonic models have been developed, with which the three hypotheses were tested using geocoded open market transaction data in Hong Kong. The results indicated no contrary evidence to reject any of the hypotheses at the 1% significance level.

The findings of the study carry several straightforward, but far-reaching, implications beyond that contained in the theoretical literature, among which is the significance of and its impact on property valuation. A better conceptual understanding of the causes of spatial autocorrelation in housing prices can greatly prompt the development of more parsimonious hedonic models that are more econometrically appealing. In this sense, statistical problems and complications (e.g. loss of a degree of freedom) associated with traditional models, which generally and routinely incorporate a long list of locational variables, can be circumvented.

In addition, hedonic models we derived based on our findings, which gave a simpler, yet more realistic, representation of the housing market, made real estate mass appraisals less computationally-intensive. Such appraisals are used for a variety of purposes, including, but not limited to, taxation, mortgage assessment, government policy formulation, and investment. They are of specific interest to accountants, bankers, real estate investors, government policymakers, and economists.

# Study on Barriers of Implementation of Building Information Modeling in Facilities Management

MPhil Category • Awardee : **HE Zhaoqiang** University of Hong Kong

As a key innovation in the building industry, Building Information Modeling (BIM) during the design and construction process has surged globally with improved IT technologies. But facilities management (FM), which, in theory, contributes far more values than during the design and construction stage, has yet to catch up with this trend. The real value of BIM lies in the amount of accurate information for a building throughout its life cycle. The value is so intangible that it may hardly be quantified. This study aims to explore and identify the key barriers behind the process. Three case studies on large FM organizations in Hong Kong were conducted through in-depth interviews and document reviews. Two reputable international FM software providers were also interviewed to gain a comprehensive understanding of the cutting-edge technologies involved. A cross-case study was also conducted to strengthen the findings from these three case studies.

BIM in FM was considered an innovative process when it debuted during the 1970s. The data collection and analysis were guided by two theoretical models that focused on information flow and required conditions, respectively.

The fragmentation between the project and FM teams was the most significant barrier, while the technology was generally ready for at least importing data. The FM team needed a detailed and accurate model that could be financed and supervised by the project team. The level of communication between the FM and PM directly impacted the level of implementation. Communication was obstructed by Hong Kong's fragmented industry structure. The FM team had no choice but to abandon models that were not suitable for FM during the construction stage.

To overcome such barriers, organizations may consider establishing a coordinating platform between the PM and FM teams. A company-wide BIM standard would also be useful during the coordination process.

The existing BIM literature mainly discussed the technical side and the benefits associated. Most of the empirical studies only focused on the construction phase. A systematic review of the implementation process was absent. This study should fill this research gap by applying generic innovation theory to BIM in FM implementation and pointing out a new direction of using IT innovation theory to explain the complicated BIM adopting process in FM. Due to the limited number of successful cases within the region, this study could only conduct three case studies that were restricted to large organizations. Further studies should extend the cases to generic FM organizations or explore solutions for overcoming barriers identified by this study.

An Empirical Study of Construction Safety Climate and Safety Performance in Mainland China – The Case of Shanghai

MSc Category • Awardee : **LIU Yumeng** Hong Kong Polytechnic University

The Mainland Chinese construction industry has been beset by high accident and fatality rates because of its inherently hazardous work environment. Safety climate refers to workers' awareness of and attitudes towards workplace safety, while safety performance is regarded as an evaluation of project participants' safety-related work behaviours. The relationship between these two concepts has been studied by many researchers. This study aims to further explore the relationship between new construction projects in China with particular reference to Shanghai.

First, a safety climate-related questionnaire survey devised

by the author resulted in **128 responses**, which gave her an overall picture of Shanghai's construction industry. Then an exploratory factor analysis *(EFA)* was adopted to identify the characteristics of Shanghai's safety climate. Finally, the author grouped **25 out of the 38 safety climate variables into eight underlying factors** using *EFA* with the SPSS 18.0 software programme.

These eight underlying grouped factors were further studied by multiple linear regression (MLR) to explore the relationship between the construction projects. Safety performance was measured by the number of injuries, safety participation, and safety compliance. Finally, "general safety participation" and "general safety compliance" were regarded as the ultimate accepted equations to describe the relationship. The results of the MLR analysis indicated that "Worker's compliance with safety rules and accident investigation" (Factor 3), "Communication of safety-related information" (Factor 5), and "Workmates' influence and support" (Factor 1) were the key contributors to "general safety participation". On the other hand, "Workmates' influence and support" (Factor 1), "Organisational commitment to health and safety procedures" (Factor 2), "Workers' commitment to health and safety procedures" (Factor 6), and "Time pressure and supervisor's competence in ensuring safety" (Factor 8) were regarded as the most influential factors for "general safety compliance".

To further study the different levels of safety management conducted on safety climate and performance, the author performed another MLR. Concerning safety participation and compliance, work team leader (WTL) groups and project management personnel (PMP) groups indeed weighed differently on the factors. Totally, four separate equations were presented to show the differences between them. With respect to "general safety participation," "Worker's compliance with safety rules and accident investigation" (Factor 3) was the factor shared by both groups, but the WTL group paid more attention to "Workmates' influence and support" (Factor 1), while the PMP group focused more on "Communication of safety-related information" (Factor 5). As far as "general safety compliance" was concerned, the WTL group emphasised safety communications and workers' commitment, while the PMP group was concerned more about safety communications, time pressure, and supervisors' competence in ensuring safety and organisational commitment.

Based on these regression model equations, the author recommends some effective strategies for project managers to achieve better site safety performance in Shanghai, but modifying these strategies before applying them to specific projects in other cities or regions.



# Surveyors Luncheon Talk



## **Horse & Surveying**

A luncheon talk titled, "Horse & Surveying," was successfully held on 11 April 2014 at the World Trade Centre Club Hong Kong. This was the third in a series of six luncheon talks organised as part of the activities to celebrate the 30<sup>th</sup> anniversary of the HKIS.

We were honoured to have our Past President, Sr Leung Shou Chun, as the guest speaker. His topic was horses, which are hardly related to land surveying. Yet, Sr Leung, who is well-known as a living encyclopaedia in the land surveying profession, managed to share some interesting facts about horses that broadened our knowledge.

The oldest set of aerial photographs to capture Hong Kong from a bird's eye view was taken in 1924. This was not news to any land surveyor in Hong Kong and had nothing to do with a real horse. However, these aerial photographs were taken from an aircraft transported to Hong Kong by a warship named Pegasus (飛馬號).

Pegasus Pegasus

Track gauge refers to the spacing between the rails on a railroad. The standard gauge that has been adopted by about 60% of the world's railways measures 4 feet, 8.5 inches (1.435 metres). This is, in fact, the width of two horses. During ancient times, carts were usually pulled by two horses and the spacing between the wheels was limited by their combined width, which averaged 4 feet, 8.5 inches. Later, when trains were invented, the standard gauge was set at the same width. Rail is now a very common means of transportation and is widely used to transport heavy goods, including rockets! As such, the size of a rocket being transported by rail is limited by the width of its rail car. Furthermore, its size is related to that of a horse.

"Putting the cart before the horse" is an idiom that describes things being done in the wrong order. Sr Leung shared with us his experiences as a land surveyor in such a situation. Having served as an experienced expert witness, he encountered a few cases in which he was told to locate a plot of land in accordance with the court's judgement. However, neither the court nor the barristers are experts at positioning and boundary issues. The boundaries they define sometimes conflict with adjoining lots and create a lot of ambiguities. Sr Leung believed that instructing a land surveyor to locate a wrong boundary under a court judgement is like putting the cart before the horse. It should be a land surveyor's job to define the boundary of a disputed plot of land before facilitating a court judgement rather than the other way around. Sr Leung ended the talk with a poem and enlightened us on how he prepared for this talk. This earned a round of applause from the audience.



## 我做會長的日子…… When I was the President ……



Sr PC Lau Past President (1996-1997) Interviewed by Christina Wong



This year marks the 30<sup>th</sup> anniversary of the establishment of HKIS. As part of the celebration to commemorate this event we have invited one of our past presidents, Sr PC Lau, to share his memorable achievements with us. Sr PC Lau was elected HKIS president for 1996/97. He has nearly 40 years of experience in construction and property development both in Hong Kong and Mainland China. He is also a former Member of the HKSAR Legislative Council.

#### Q1: How your leadership changed the Institute?

A1: My tenure was from December 1996 to December 1997 straddling the transfer of sovereignty over Hong Kong which took place on 1st July 1997. At that time, Hong Kong's housing and property market was mired in a state of speculative euphoria. HKIS Council and I spared no effort in raising public awareness to the potential risks associated with property bubbles in the making, guiding and alerting the general public towards basic fundamentals of supply and demand on land and housing, planning and development, as well as promoting protection of consumers' interest in property transactions. One particular example was the measurement of floor area for pre-sale of residential properties where HKIS had provided numerous inputs to and exchanged views with government, Legislative Council, Consumer Council, other professions and relevant concerned groups etc. Such tenacious and joint effort culminated in the ultimate legislation of the Residential Properties (First-hand Sales) Ordinance Ord 19 of 2012, thus offering legal protection to home buyers at large. I would thus say steering the Institute towards advocating for and protecting the greater good of the general public and society as a whole was my main calling at that time.

# Q2: Can you share your main involvement with the Institute and the changing landscape of the Institute during your tenure?

**A2:** The handover of sovereignty over Hong Kong was a long and bumpy process which started off in the early 1980s with Hong Kong society being immersed generally in

pessimistic antagonism when the issue was first brought up, which however was subsequently overtaken by overwhelmingly celebrative exhilaration as the handover date of 1st July drew closer, understandably from initial skepticism to the grand finale of certainty with joy. The surveying profession had contributed more than its fair share towards the smooth transition of Hong Kong's handover when, in addition to our advocacy for betterment of land and housing issues for society as we always do, senior members of HKIS such as Sr Kan Fook Yee (HKIS founding president 1984/85) and Sr Leung Chun Ying (current HKSAR Chief Executive and HKIS past president 1995/96) were actively involved in the handover process including being as advisors to Beijing, heavily involved in the consultation and drafting of the Basic Law, as members of the Provisional Legislative Council etc. Through their professional and expert advices and advocacy, a potentially explosive issue on land leases, in particular all those north of the Boundary Street, Kowloon, which were to expire on 30 June 1997, was resolved when a proposal to grant automatic extension to such expiring land leases for 50 years until 2047 was accepted by Beijing. The proposal was ultimately written into the Basic Law, Hong Kong's mini constitution, the now famous Articles 120 and 121 therein , exonerating land owners from additional land premium for such extension and more importantly removing all future uncertainties as well as releasing large tracks of land in the New Territories which were so much in need for Hong Kong's economic and social developments. Inspired by my predecessors' commitment to serve the community, I subsequently ran for and successfully won the Legislative Council election in 2000 where I served one term until 2004 and where I became the first surveyor Member ever to represent the Architectural, Surveying and Planning Functional Constituency in the Legislative Council since the handover of sovereignty. Since then, we are now honored to have another surveyor Member, Sr Tony Tse Wai Chuen, to represent the ASP FC in the current Legislative Council. And with that I would encourage surveyors to continue to play a proactive role in serving the community and our motherland.



# Q3: What are the most challenging tasks that you experienced during the tenure?

A3: Hong Kong society was overwhelmed in anxieties and uncertainties when the British and Chinese governments were entangled in grid-locked disputes over all sorts of issues during the one and half decades leading to the handover date of 1 July 1997. Jittery relatives and friends, some surveyors included, were migrating overseas for good. However, I had the opportunities of participating in the Mainland market in the early 1980s and witnessed the colossally rapid economic and social changes that were taking place all over the Mainland, so much so that I was deeply convinced that the only way for China was up. As such my family and I decided we would stay put in Hong Kong and to continue my conviction to serve the community. With three and half decades of reform and development, China is now the second largest economy in the world serving as one of the world's leading economic engines that is providing impetus for global economic growth. And Hong Kong as part of China since the handover has never failed those, me included, who voted to stay behind and sealed their faith with that of Hong Kong.

Q4: After nearly 40 years with the surveying profession, what do you see are the challenges ahead?

**A4:** Unlike some protected sectors, surveying is not a protected profession where we are open to competition from many other professions. As market liberalization is the global trend, such challenges will not subside but will continue to deepen. Faced with such challenges and in order to sustain the surveying profession's continual growth, we must strive to diversify into new services (eg infrastructure for QS; commercial, retail and other functional planning for GP; etc) and open up new markets (eg Mainland China, ASEAN countries etc). In addition, and building on our robust foundation and following our predecessors' footsteps, the surveying profession should strengthen our participation and role play in society, not only to influence the policy makers

and shakers but to become one of them, both for the betterment of society as a whole and the surveying profession.

Before the interview drew to a close, Sr PC Lau offered his piece of advice to our young surveyors, " Not only should you concentrate on and develop your own career and

family, but you should also contribute towards serving the community and our motherland by participating in social affairs and offering objective and rational advices to government and the Mainland authorities."

專訪:宋漢光測量師 Interview with Sr Sung Hon Kwong

三月一日中午,宋漢光先生約我吃素菜做訪問,當日是 農曆初一,善眾特別多,而作為佛教徒的他亦已茹素多 年。宋先生憶述加入土地測量行業的"因緣"。他説在 郵政局的工作有點悶,想找一些戶外動態的工種,恰巧 有土地測量員工作,他便加入了工務局。後來有機會赴 英國進修,學成回來便正式從事測量專業,直至一年前 才離開政府的工作崗位,享受精采的退休生活。宋文軒 (Kevin) 現正就讀香港理工大學土地測量及訊息管理課 程,其實他的理科根底不俗,原先在英國中學畢業時曾 考盧留在當地唸有關工程的科目繼續體驗生活。是什麼 原因今 Kevin 放棄已滴應了五年多的自由生活而重回香 港及父母的懷抱呢?答案簡單至極,那就是用錢也買不 來和家人的寶貴相處時間!我不是低估年輕人對傳統價 值重視的熱切,而是文軒還是在唸第一個學位時已懂得 珍惜此道,我相信宋先生一定在兒子成長的過程中循循 善誘,下了不少時間心機研究實踐,才令兒子有這樣的 想法。

在八十年代或以前,香港並未有正規的土地測量學位課程,主要靠海外工專提供專業培訓,才令香港有本土的測量師。直至本港理工大學成立土地測量系才令情況改變。時至今日理大坐擁一些國際級的師資為學生們提供更全面的教育,此乃 Kevin 回港升學的其一重要原因。雖然成長過程中爸爸每天回家後都會跟文軒分享一下工作點滴,但 Kevin 覺得父親給他的是一些撮要 (abstract)或 executive summary,雖則精練可貴,但在未有接受學校正規的理論(theory)教導前,他亦未能明白和充份利用。

由於我是 Land Surveying 的門外漢,相當感謝兩位宋 先生給我寶貴的一課基礎概念。土地測量既可很本地 化亦很國際化:因為在造地圖、分地塊界線這些 Local Practice 工種上需要查考很多本地法律及歷史發展背景的 由來;所以在外國升學回港工作的同業也需要在此作一些時間適應。但另一方面在技術研究發展上如 GPS、GIS 等卻要和國際的領導潮流接軌。所以要視乎畢業生將來投身那類型工作如政府、學術機構、顧問公司、服務承接商、研發公司等才知 Geographical Mobility 要求高還是低。即使日後有很多 computer aided program 去處理複雜的原始資料數據及輔助分析,但肯定的一點是學生們若有較強的數學能力絕對有利於進行設計、邏輯及理解的工作。土地測量畢業生也不愁沒有好工作,問題是在於自己的性格和喜好去選擇;不過由於世界科技日新月異,我們也要準備時刻增值自己的 software 以防折舊,這個大勢在測量各行業都要面對!

宋漢光先生席間跟我分享了很多做人處世之道、為人父母養育心得、跟子女溝通相處之學問、一些佛教的概念和道理、養生健康的經驗和當下香港的社會面貌。晚輩真是獲益良多,完全想不到替我們的測量師學會做一些簡單的義務工作可以有如此的意外交流學習,所以我在此呼籲年青的會員們多投入,多參與一些適合自己的會務或義務工作,令我們整個測量專業在香港、在中國、在世界各地承傳發揚,找到一個貢獻委身的位置,敬業樂業,更加享受這條自己選擇的專業道路。



Sr Sung Hon Kwong and I enjoyed a vegetarian lunch during our interview on 1 March. As a Buddhist, Sr Sung has abstained from meat for several years. He shared how his religion influenced his work as a land surveyor. He was bored with working in a post office and keen on outdoor work. So he joined the Public Works Department and started his career in land surveying. Afterward, he went to the UK for further education. After he returned to Hong Kong, he continued in land surveying until last year, when he retired.

Kevin, son of Sr Sung, is now studying geomatics (land surveying) at The Hong Kong Polytechnic University (PolyU). Kevin is good in science. He was scheduled to start a construction-related course in the UK after secondary school, but instead decided to remain in Hong Kong because he cherishes the valuable time he has with his family. One cannot underestimate the importance that Kevin assigns to traditional values. Clearly Sr Sung spent a lot of time and effort teaching Kevin well.

There was no formal land surveying degree in Hong Kong before the 1980s. Land surveyors were trained by foreigners. This changed after PolyU established the Department of Land Surveying and Geo-Informatics (LSGI) to provide a course that led to a professional degree. Today, PolyU hosts world class lecturers and tutors to provide a well-rounded education. This was crucial to Kevin's decision to remain in Hong Kong. When Kevin was young, Sr Sung shared his work experiences every day when he came home after work. Kevin remembers his father giving him the abstract and executive summaries during these sessions, which served as a foundation for Kevin when he embarked on his university studies.

Thanks go to Sr Sung and Kevin for providing me with a valuable basic concept of land surveying. Internationalization and localization can be found in Hong Kong's land surveying works. Local practice works (e.g. local laws and history-tracking) are required to prepare maps for dividing boundaries. Surveyors who studied aboard need time to adapt to these works when they work in Hong Kong. On the other hand, surveyors have to keep up with the latest trends and technologies (e.g. GPS, GIS, etc.). Geographical mobility requirements for graduate students are low in several types of work (e.g. government, research and development companies, consultancies, service providers, and academia). Although computer-aided programmes can cope with complicated data and data analyses, graduates who are good at maths use them to carry out design works and data analyses. There are many job opportunities for land surveyor graduates, who should rely on their personalities and habits to choose the right job. As advances in technology continue, surveyors should update their knowledge to keep from falling behind. This is a trend faced by every surveying stream.

During the interview, Sr Sung shared a lot of his life experiences, Buddhist concepts, ways to be healthy, and social views. I learned a lot during this interview and want to encourage other young members to commit to HKIS functions and volunteer works so that they can better enjoy their professional careers and help promote the surveying profession throughout the world.

Details With the enactment of the Buildings (Amendment) Ordinance in June 2011 and subsidiary legislation including the Building (Inspection and Repair) Regulation ("B(IR)R") in December 2011, Mandatory Building Inspection Scheme ("MBIS") has came into force since 30 June 2012. Under the MBIS, owners of buildings aged 30 years or above (except domestic buildings not exceeding three storeys) are required to appoint a Registered Inspector ("RI") to carry out the prescribed inspection of the common parts, external walls, and projections or signboards of the building upon receipt of a notice (once every ten years) served by the Building Authority under Part IIA of the Buildings Ordinance.

Buildings Department of the HKSAR Government has published a Code of Practice for the MBIS ("MBIS COP") in 2012. The MBIS CoP specifies the technical standards and procedural requirements for the RI to carry out building inspections, but it does not elaborate on inspection planning, professional judgement, defect diagnosis, and special construction methods and features commonly found in aged buildings.

Pursuant to section 5 of the B(IR)R, the inspection of surviving buildings involves examinations and assessments with reference to the standards used at the time when the buildings were built. It becomes crucial to understand the legislation, designs, materials, codes of practice, and practice notes that prevailed when the buildings were built.

In this connection, Building Surveying Division of The Hong Kong Institute of Surveyors has published a Professional Guide to Building Inspections ("PGBI") – Volume 1: Pre-1980 Residential & Composite Buildings in Hong Kong.

Sr Dr Daniel Ho and Sr Dr Edward Yiu who were the academic researchers of the PGBI will share with members about the main contents of the PGBI on inspection preparations and understanding of the various design codes which prevailed at the time when these pre-1980 buildings were built. Sr David Chan will also participate and share his 30+ years of practical experience in building inspections.

In pursuance of the duties as laid down in Sections 6A and 6B of the Factories and Industrial Undertakings Ordinance, the Regulations define general duties on employers, employees, contractors, suppliers of goods and substances for use at work, persons in control of work premises, and those who manage and maintain them, and persons in general.

Statutory duty is qualified by the words of "so far as is reasonably practicable", the risk of incident or accident has to be weighed against the measures necessary to eliminate the risk, including the cost, time, additional risk involved. If, for example, the employer establishes that the risk is small, but that the measures necessary to eliminate it are great, he may be held to be exonerated from taking steps to eliminate the risk on the ground that it was not reasonably practicable for him to do so. However, the positioning of the term within the legislation can dramatically shift the balance from one of "innocent until proven guilty" to the reverse, as is often the criticism of the legislation and the courts have on numerous occasions noted that what is "reasonably practicable" is to be determined objectively.


At the same time, Tongji proposed the formation of a training centre with the HKIS to promote the Institute together with the degree course. We promised to forward its proposal to our General Council for consideration

The Hong Kong Institute of Surveyors (HKIS) was invited by the Singapore Institute of Surveyors and Valuers (SISV) and the Association of Property and Facility Managers in Singapore (APFM) to join an Inaugural Conference on Management Corporation and Strata Management on Thursday, 10 April 2014, at the York Hotel Singapore. The conference aimed to bring together experts and practitioners in the Asia Pacific region to share some of their difficulties and how they can be resolved. It was also a good setting for encouraging greater dialogue and exchanges of views among the various stakeholders, including developers, owners, occupants, managing agents, and management council members.

The management of strata development has its challenges, particularly regarding its operational details. Conflicts can arise because of differences in expectations among the various stakeholders concerning management standards. Numerous themes were held to discuss the various aspects of strata management as follows:

#### 1. Strata Management in the Asia Pacific Countries

This was an overview of the practice of strata management in the Asia Pacific countries highlighting the essential features and differences. Valuable lessons were learned from the successful practices in these countries.

#### 2. Role of Managing Agents

Managing agents play an important role in the successful operation of corporations. The agents present shared their experiences by highlighting some of the challenges in management, including staff deployment, competency, and commitment.

#### 3. Participation of Residents and Occupants

The active participation of residents and management council members is a critical factor in the successful operation of management corporations. Council members and residents in attendance shared their views on some of the challenges they faced and the need to adopt a positive approach to community living.

#### 4. Role of Management Councils

Management councils oversee the day-to-day affairs of their management corporations. The conduct and attitude of council members are important factors for ensuring that operations are managed fairly and reasonably. The council plays a crucial role in the success of a strata development.

#### 5. Dispute Resolution in Strata Management

Conflicts and arguments arise in communities where people from different walks of life interact with each other. Such disagreements can be amicably resolved if each party is prepared to communicate and understand everyone else's point of view. The role of strata titles boards was discussed during the conference.

Our Council Member, Sr KS Wong, represented the HKIS-PFMD as the speaker on the topic of Strata Management Experience in Hong Kong. Sr KS shared our knowledge and experiences in with various stakeholders in the Asia Pacific Region. The keynote speaker of the conference was Mr Chin Chi Leong – Commissioner of Buildings, Singapore – who was in attendance with Dr Lim, President of APFM; Mr Tay It Tuan, Vice President of APFM; and Mr Peter Tan, Managing Director of Chambers Property Management Services P/L.

# 2014 HKIS QSD Scholarship Presentation Ceremony

With three years of experience in organising this event, the 2014 HKIS QSD Scholarship Presentation Ceremony was successfully held on 28 March 2014 in the Institute's Surveyors' Learning Centre.

Perhaps members may note that the objective of setting up the scholarship for students reading related quantity surveying courses at local universities and the Institute of Vocational Education (IVE) is to nurture and encourage more young people to join the surveying profession in view of the shortage of quantity surveyors in Hong Kong. The problem with the lack of quantity surveyors at all grades will not be eased in the near future due to the new housing construction initiatives put forward by the government. In the next ten years, the government will construct 470,000 housing units for the people of Hong Kong. So the demand for quantity surveyors will be overwhelmingly high. Hence, the career prospects for quantity surveying graduates will be guite promising in the next five years. The Council considers that we should not only attract a large number of young people to the profession, but also help maintain the social status of quantity surveyor as a highly-valued professional in the construction industry. By awarding scholarships and conducting other promotional activities, we will be at the forefront of industries in attracting more high caliber young people to join the profession.

Eighteen scholarships were awarded to students for their outstanding performances in key quantity surveying modules leading to the award of bachelor and associate degrees and higher diplomas. The awards were as follows:

## Meeting with the Architectural **Services Department**

The Communication Meeting with the Architectural Services Department (ArchSD) was held at its Queensway Government Offices on 27 March 2014. The other party attending the meeting was the Association of Consultant Quantity Surveyors (ACQS). The meeting was chaired by the Director of the Architectural Services Department, Sr KK Leung, with a number of his senior officials including the presence of a representative from the Development Bureau.

During the meeting, a number of items were discussed. We expressed our concerns and offered comments on the following topics:

- The wider implementation of NEC3 in works contracts let by the Works Branch, which includes the ArchSD in 2015.
- The use of Building Information Modeling (BIM) in Public Works projects. It appears that the ArchSD lags behind the Housing Department in the use of this state-of-the-art technology.
- The trend of using the design and construction (D& B) procurement strategy in public works projects. Only a handful of experienced contractors have the ability to tender for such projects. Hence, the competition for D & B projects will not be as keen as those projects let under traditional procurement approach.

### **Secondary School Visit**

With the successful launch of a series of visits to secondary schools during the last Council Year, the Council has embarked on another series of visits to secondary schools in order to encourage students to select quantity surveying as their course of study when they enroll in university.

We started off by visiting the Shaukeiwan Government Secondary School on 9 April 2014. Council Members, Sr Sunny Choi, Sr Dr Ken Hui, and Sr Steven Tang, together with Sr Thomas Ho (the Hon Secretary of the Institute) and I, joined this visit. First, we showed a video to students describing the Institute and the QSD. I then delivered a short speech regarding the structure of the Institute and the function of its six surveying divisions. Sr Sunny and Sr Dr Ken shared their experiences as quantity surveyors for the government and a tertiary educational institute, respectively. Finally, Sr Steven conducted a quiz with students and presented them with souvenirs. The students enjoyed the event very much.

# The Hong Kong Housing Authority's New Standard Conditions of Contract for Capital Works

I attended a Briefing Session on the implementation of the

New Standard Conditions of Contract for Capital Works of the Hong Kong Housing Authority (HKHA). Prior to this, the HKHA has conducted four Stakeholders Engagement Sessions from 2012 to 2013. For this New Standard Conditions of Contract, it appointed a consultant to draft the documents. The exercise began in February 2012. Having conducted a series of Stakeholder Engagement and Briefing Sessions with the Tender Committee, Building Committee, and Audit Sub-committee, the HKHA received joint approval from the Building and Tender Committee in November 2013 to adopt this suite of Conditions of Contract for Capital Works, which includes the following:

#### **Main Contracts**

The General Conditions of Contract (GCC) and Special Conditions of Contract (SCC) for:

- Building Works
- Foundation Works
- Civil Engineering Works
- Miscellaneous Works

#### **Nominated Sub-contracts**

- The Articles of Agreement and General Conditions of Nominated Sub-contracts to Building Works Contracts (NSC GCC)
- The Standard Library of Special Conditions of Nominated Sub-Contracts to Building Works Contracts (NSC SCC)

The new Conditions of Contract will be implemented in all new capital works (i.e., main contracts) with tenders issued from May 2014 onwards. The new nominated sub-contracts shall be implemented from August 2014 onwards after their associated building works contracts have adopted the new Conditions of Contract.

Members who work on the HKHA's capital works projects are advised to familiarise themselves with these new conditions of contract. The new Standard Conditions of Contract can be downloaded from the HKHA's website at:
