1,241 Expectations

The 2008 Legislative Council (Legco) Election was held successfully on 7 September 2008. A total of five candidates, including myself, competed for one seat in the Architectural, Surveying and Planning Functional Constituency. Of the total of 3,834 votes, Hon. Patrick Lau received 1,429 votes and became the Legco Member of our functional constituency for the coming 4 years. The number of votes received by me was 1,241, representing 1,241 expectations from my supporters. The results for the Architectural, Surveying and Planning Functional Constituency are as follows:-

Sichuan Reconstruction Work

The 5.12 Sichuan Earthquake has caused great casualties to the province in terms of both human lives and properties. According to the information announced by the State Council of the PRC on 25 August 2008, 69,226 people died, 374,643 were injured and 17,923 people were lost in the earthquake. Various efforts have been initiated by different organisations, public and private, to restore normal lives to the victims.

In order to contribute to the reconstruction of Sichuan, HKIS joined "The Hong Kong Construction Sector 5.12 Reconstruction Joint Conference", led by the Development Bureau of the HKSAR Government. Other non-government organisations, such as The Hong Kong Institute of Architects (HKIA), The Hong Kong Institute of Surveyors (HKIS), The Hong Kong Institute of Planners (HKIP) and The Hong Kong Institute of Landscape Architects (HKILA), also joined the Joint Conference.

At the second meeting of the Joint Conference held on 12 August, two projects were proposed to take forward to the reconstruction in Sichuan:

- 1. Project Working Group for Reconstruction of Provincial Highway 303
- Project Working Group for Reconstruction of Wolong Natural Reserve

The reconstruction of Provincial Highway 303 is crucial as it is an artery road connecting Wolong Town to other main towns in Wenchuan County. Its extension also leads to Chengdu City, the capital city of Sichuan Province. It is important for the logistics of food and other resources from other parts of the province to reach the town. For Wolong Town, it is the natural habitat of the giant panda. The reconstruction of Wolong Natural Reserve will restore the natural environment and prevent the potential extinction of the panda. The management facilities, community facilities and infrastructures will be rebuilt.

Volunteers would need to spend seven to ten days in Sichuan to participate in one of the projects above. Members of our institution demonstrated their great concern on the matter and expressed their sympathy towards the victims. So far we have received over 100 replies. In the capacity of the President of HKIS, I strongly encourage our members to enrol in the recon-

struction work, as the reconstruction of the devastated areas requires great input of knowledge from professionals like us.

As appointed by the Executive Committee, I am the Convener for the Sichuan relief work in HKIS. I will act as liaison with the HKSAR Government regarding the further arrangement of the reconstruction work and convey the latest progress to the HKIS volunteers.

Promotion Committee

In order to promote the professional image and services of HKIS, a Promotion Committee was proposed by the Executive Committee, which will comprise one to two representatives from each division including YSG.

The Executive Committee also recommended the President to be the Chairman for a term of two years, subject to the approval of the General Council. Terms of reference are to be confirmed later. The preliminary list of committee members has been drafted and the final list will be announced next month.

After the formation of the Promotion Committee, the capability statements of each division will be revised for more up-to-date information and clearer scope of services. The Committee will also visit various government and non-government organisations to promote the changing role of surveyors in the society, the future development of our profession and identify potential cooperation opportunities.

I am glad to share with you the following remarkable events in August and September:

- On 12 August, I attended the 5.12 Reconstruction Joint Conference at Central Government Offices;
- On 14 August, I met and exchanged opinions with a group of real estate professionals from Guangdong Institute of Real Estate Appraisers and Real Estate Agents. The meeting was housed at CBRE Hong Kong Office;
- On 10 September, I was invited to the Financial Secretary's Consultation at Central Government Offices;
- On 12 September, I was invited to be one of the guests for the DTZ Scholarship Presentation Ceremony at DTZ offices in Jardine House, Central;
- On 19 September, I had lunch with Professor Chen Zuyu.
 Professor Chen is a renowned expert in water resources and hydro power.

Silk Road for Information from Imagery

Reported by T N Wong Continued from last issue

Plenary Sessions

Many prominent speakers shared their experience to a full house of participants on the latest technological development and important works towards a better living world using Photogrammetry and Remote Sensing.

Mr Jos Achache of GEO spoke on "Co-operation to Build a Global Earth Observation System of Systems (GEOSS)." An initiative of GEO an intergovernmental organisation with 74 members and 51 participating organisations to work out a co-ordinated and sustained observation systems to provide easier and more open access to data.



Full house Plenary Sessions

Dr Juergen Dold of Leica Geosystems described the evolution of LIDAR systems in the geospatial and surveying market as an important step towards improving the accuracy of image data acquisition with lesser cost.





Fault Lines and Earthquake Zone, China

Professor Li Deren of Wuhan University, reported on the role of spatial information in the rapid emergency response to the Wenchuan earthquake. He described how photogrammetry.

remote sensing and spatial information technologies were applied to disaster response operations including the coordination of rescue efforts, combating secondary disaster, damage assessment and reconstruction.

Rapid data acquisition and information services using fully automatic, near real-time remote sensing systems without ground control had enabled a faster rate in search, rescue work and disaster relief.

It is important to develop a national level rapid response system that can collaborate work by different agencies and facilitate data and resource sharing. This requires the further development of China's National Spatial Data Infrastructure and the enhancement of high-resolution earth observation systems through strong international co-operation in spatial information science and technology. The International Charter and GEOSS from GEO represent an excellent beginning.

Technical Sessions

All technical sessions were well attended. Out of more than 2.800 abstracts submitted, 2,600 technical presentations were selected and presented. This had demonstrated the keen interests of all the participants in the works of Photogrammetry and Remote Sensing.

Since there were such a large number of technical presentations it would be difficult to give a detailed account of the contents. It would be appropriate to summarise, categorise and report them according to the relevant works of each of the eight Technical Commissions.

Technical Commission I reported on Image Data Acquisition - Sensors and Platforms

About 100 oral papers and 200 poster papers are related to SAR and LiDAR systems (this shows the increasing interest in these techniques). The showcase of the LiDAR systems was its improved accuracy by a factor of four and the time saved, and hence saved cost by a factor of ten. The systems have become more portable and versatile.

Technical Commission II reported on Theory and Concepts of Spatio-Temporal Data Handling and Information

TCII addresses major issues in geo-information science. These include spatio-temporal modelling, spatial reasoning, analysis and data mining, multiple representations, visualisation, spatial decision support, system integration and interoperability, quality and uncertainty of spatial data and models, and 3D and dynamic data handling.

Though 3D visualisation is becoming more common there are many issues and challenges, namely quality propagation through spatial analysis, spatial decision support with highly complex data, interoperability of heterogeneous systems and geo-sensor networks.

The penetration of GIS technology in an increasing number of areas leads us to believe we need more theory on spatial modelling, interoperability and visualisation. This is evident from the tremendous rise of services like Google Earth and Microsoft Virtual World. These services have a widespread impact on society and the way we deal with spatial information.

Technical Commission III deals with Photogrammetric Computer Vision and Image Analysis

Automation of close range bundle adjustments, where only control points require manual interaction, was developed. The generation of highly detailed surface models constructed from images has advanced to a point where images are becoming an interesting alternative to LiDAR.

The direct access to 3D information from LiDAR systems has triggered a large amount of research, including research into increased morphological quality for digital elevation models, ease of 3D-reconstruction for large build-up areas, and detailed analysis of forest areas.

Information density can be increased by the availability of intensity and waveform, enabling more detailed classifications. Also, the interpretation of aerial and terrestrial images successfully grasped techniques from pattern

recognition and machine learning, especially for the modeling of road networks and facade structures.

The analysis of video sequences is becoming a hot topic, especially for the highly challenging and relevant task of so-called 'simultaneous localisation and mapping', both from the ground and air, using UAVs.

Technical Commission IV deals with Geodatabases and Digital Mapping

The acquisition, organisation, analysis, visualization, modelling and dissemination of geospatial information had been made easy by the advancement and development of space, geospatial, computing and communication technologies.

These geospatial information had been used effectively for natural resource management, environmental and ecosystem protection, disaster management and climate modeling.

Rescue and relief operations rely on the collection, integration and analysis of data - including 3D data.

The recent availability of high resolution stereo data from aerial and satellite platforms has revolutionised data acquisition and provided an opportunity to develop techniques for automatic data extraction. Image databases with high temporal resolution are expanding, especially for ocean applications.

Developments in visualisation allow us to display landscapes and seascapes virtually, and to depict both global and local processes. The use of GIS to access, analyse and disseminate spatial data has enhanced web-based services. Web GIS allows us to more efficiently manage massive distributed computing/storage resources. Open-source software provides new, cost-effective solutions to web-based geospatial information and services.

Technical Commission V deals with Imaging and Laser Scanning Techniques

Imaging and laser scanning techniques are used in industrial and engineering metrology, cultural heritage documentation, virtual reality 3D data acquisition, robotics, 3D motion analysis, quantitative medical imaging, biometry, and many more.

A central issue in many developments is the integration of sensor technology with reliable data processing schemes to generate precise and highly automated online or real-time photogrammetric 3D measurement systems.

Technical Commission VI deals with Education and Outreach

TC VI deals with educational matters related to photogrammetry, remote sensing and the spatial information sciences. The technological advancements in these three fields are numerous.

Internet-based information services such as Google Earth and car navigation are widely used by the public today. More technical and educational training are needed for the growth in interest in these applications.

Education and training are no longer restricted to a few years of university. Rapid advancements in technology have increased the importance of lifelong education in our fields. The internet and e-learning play significant roles in lifelong education. Despite the growing availability of educational materials and e-learning courses, it is not easy for beginners and students to find appropriate educational materials. Promoting online information to the public will help to widen recognition and acceptance of e-learning material. A number of sessions on capacity building were presented.

Technical Commission VII deals with Thematic Processing, Modelling and Analysis of Remotely Sensed Data

Highlights of presentation included the following topics:-

 Rapid developments in SAR remote sensing data sources, such as the high resolution RADARSAT-2 from Canada, the COSMO-Skymed SAR satellite from Italy (the highest SAR spatial resolution system in the world, providing detailed images of the earth under all weather conditions), and the German TerraSAR.

The launch of these satellites has driven much research in image and data fusion methodologies. The recent Sichuan earthquake is a good example of how SAR data, along with other data sources, can be used to greatly assist relief efforts in difficult terrain and adverse weather conditions.

- Fundamental physics to enable a better understanding of the geophysical parameters which influence the signals recorded by remote sensing sensors.
- New image processing algorithms and analysis techniques which show that rapid progress has been made in image classification methods, going from traditional/

conventional pixel-based techniques to advanced context-based and texture-based classification procedures.

Other important presentations cover change detection methods.

Technical Commission VIII deals with Remote Sensing Applications and Policies

Remote sensing is the science used to carry out acquisition of information about properties of objects or phenomena without physical contact.

Space-borne satellites are used to capture data for Earth observation. Each new satellite will serve as a platform for a new scanning observation system; each new system will manifest progressively better resolutions, both spectral and geometrical.

The old days of capturing the moment on black and white or colour film are long gone. Now data are collected digitally by dividing the captured scene into a mesh of small equalsize picture elements known as pixels.

TC VIII focused on many remote sensing applications namely impact analysis of human settlement; hazards and disasters; public health; air pollution; coastal zone management; polar, alpine and cryogenic research; land degradation; desertification and arid lands. It also deals with issues related to management of tropical zones; policies, treaties and data access; water security; precision agriculture; sustainable forest; landscape management; geological mapping and geomorphology.

HKIS 25th Anniversary

keung, Senior Divisional Officer of Fire Services Department, included 34 firemen, 6 ambulancemen, a medial officer, a registered nurse and an information officer. The Team flew to Chengdu in two batches on May 15 and 16 and were assigned to carry out search and rescue work at Hanwang in Mianzhu, one of the most devastated areas. The Team recovered 24 bodies from the rubble of a collapsed office building and factory plants in the vicinity, and assisted the PRC Army finding a

woman survivor trapped under a collapsed building.

At that time, he introduced and implemented the term contracts for the bank's fitting-out work of branches and offices, as well as churn projects.

CW is the Project Manager in the Corporate Real Estate Department of an international bank and responsible for fitting-out of its branches. He was the project in charge for the fitting-out projects of a major convenience store chain in Hong Kong.

With rental costs for Hong Kong retail space on the rise in recent years, it makes good economic sense for retailers to make their operations as cost-efficient as possible. For some, rental cost can account for up to 50% of their operating costs. The key to coping with rising rental pressure is by reduction in store size, relocation and closure of underperforming shops while expanding outlets and flagship stores at location close to prime area. As a result, there are a lot of associated fitting-out projects in the market which in turn jack up the fitting-out costs.

Corporate Real Estate Department and its project team are traditionally treated as a "cost centre". They are driven to look for all means to deliver "value-for-money" projects. Some retailers are negotiating longer-term fitting-out contracts, up to two years, with their suppliers to achieve lower costs and shorter fitting-out period. In addition, these longer-term relationships have the potential of delivering better value to the end users. This paper discusses about the financial and business benefits, and the challenges of using term contracts in Hong Kong through 2 cases of convenience stores and bank branches.

When the Pacific War broke out, Hong Kong had already been fortified for a century. Batteries, redoubts, observation posts, blockhouses, pillboxes, searchlight positions, tunnels, trenches, shelters, and bunkers were built extensively. All these preparations for war were finally put to test when the Japanese invaded Hong Kong in December 1941.

Since the end of the war, many of these relics were gradually forgotten, and were quietly disappearing. The spectacular economic development of Hong Kong, not surprisingly, have claimed many of these unwanted concrete blocks and structures. Yet, despite the seemingly unabated developments, there still lie a large number of ex-defence works - whether along the coast, on the hillside, or in the heart of the city. The talk attempts to outline some of these relics.

Through studying these lumps of concrete, the search for the past, nevertheless, is not altogether impossible.

Under the Scheme, a vehicle owner can choose his/her preferred vehicle registration mark, apply to the Transport Department and use it upon approval following a bidding exercise. Auctions of traditional and personalized vehicle registration marks are conducted by the Transport Department from time to time. Since 1994, members of HKIS have been participating in the auctions as Auctioneers.



My response to the Young Land Surveyor's Concern

It was reported under the President's Message in the last issue of Surveyors Times that young surveyors of different Divisions have raised their concern on the future of their profession. I am happy to share my views with the young land surveyors about the future of our profession. Because of the economic downturn, the construction industry had shrunk for some years and job opportunities for land surveyors had unavoidably been affected.

The general picture is still grim today but the good news is that the government has announced the 10 major-infrastructure projects which might somehow improve job opportunities for young land surveyors. The government has resumed recruitment of land surveyors which also helps the profession a bit.

The Institute has met the Permanent Secretary for Works to discuss, among other things, the contribution of surveyors in large projects and the value of surveyors has received the appropriate recognition. We still wait to see how such recognition can finally be converted into job opportunities but it is definitely moving towards the right direction.

As young land surveyors, my advice would be that they should always try to improve themselves and venture into areas beyond the scope of their own profession. For example, land surveyors should get to know more about the laws of Hong Kong whether it is on land matters or on contracts. They should also keep themselves abreast of the latest technology in GIS, GPS and Remote Sensing. Development trends are seen in these areas. After all, opportunities only go to those who have the competitive-edge over others and such competitive edge can only be achieved through continuous professional development. So young fellows, keep your spirit high and work hard for your future!

The Chief Executive of the HKSAR announced in the 2007-2008 Policy Address that the Government will push ahead with 10 large-scale infrastructure projects. Government of the Hong Kong Special Administrative Region Drainage Services Department Advisory Service on Construction Contract Adopting New Engineering Contract

The Government of the Hong Kong Special Administrative Region (the Government) is inviting express of interest in providing advisory service in relation to the adoption of New Engineering Contract (NEC) suit of contract for a construction project (the NEC pilot project).

The NEC pilot project involves the improvement to a 180m open nullah at Fuk Man Road, Sai Kung and associated landscaping works and minor road improvement works. The works are scheduled to commence in early 2009 for completion in early 2012. The NEC project is administered by Drainage Services Department.

Since it is the first time that the Government adopts NEC for public works contracts, to ensure a smooth implementation of the pilot project and a successful trial of NEC, the Government intends to appoint a technical adviser who has substantial experience on NEC projects to provide advice to the Government during contract stage of the NEC pilot project.

The tentative roles of the technical adviser are: (i) to provide guidance on developing cooperative working skills, attitudes and behaviours among the parties in the contract; (ii) to advise on interpretation of the NEC document and advise Government on the effective administration of the

NEC pilot project; (iii) to advise Government on financial management including target cost adjustment and cost auditing; (iv) to promote dispute avoidance and risk management; and (v) to assist the Government in monitoring the performance and measuring the results of the NEC pilot project. The technical adviser shall work part-time and on a need basis and the advisory service will be based on a charge-out rate, subject to a lump sum ceiling proposed by the technical adviser before appointment and agreed by the Government.



Hong Kong Convention and Exhibition Centre: Phase 2 Expansion - Heavy Lifting of Mega Trusses

On 11 September 2008, Mr Christian Venetz, VSL Hong Kong's Design and Technical Manager, Mr Henry Chan, Project Manager of VSL Hong Kong Limited and Mr Antony Lam, VSL's site Method Engineer, presented the successful and challenging erection of the Main Trusses A to D of the Hong Kong Convention and Exhibition Centre (HKCEC) Expansion Project to our members in a CPD.

At the beginning, Christian and Henry introduced the design of the lifting system, which lifts up 4 heavy trusses in pairs simultaneously. Due to the limited lifting capacity of normal cranes and the limited access of the site, VSL's lifting system was chosen. The lifting system was formed by using 4 strand jacks around each lifting column. In order to lift the trusses, additional temporary bracings were added and the truss capitols have to be detached and installed separately. Other than lifting vertically, a pair of trusses was slid horizontally across 54 m at 36 m above ground level using a similar jacking method. Other challenges of the project included the limited height of the feature roof of HKCEC Phase II and the extensive temporary work design and checking involved.

At the end of the talk, Antony described the other challenges in lifting of other smaller components of the trusses such as the end-post. He further introduced in detail how the strand jack lifting system works. The system includes a hydraulic pump and a computerised control and monitoring system.

This seminar was a good opportunity for members who missed the site visit a few months ago to learn from this mega building project.



Strategic Aspect of Project Management

A CPD event on "Strategic Aspect of Project Management" was successfully held on 28 August 2008 at the HKIS Surveyors Learning Centre. Dr Paul H K Ho, Head of the Division of Building Science and Technology, City University of Hong Kong kindly delivered a talk to our members. Dr Ho is the Past Chairman of Quantity Surveying Division, HKIS and has worked as a quantity surveyor and a project manager for over ten years.

At the beginning of the talk, Dr Ho highlighted that the traditional approach of project management in terms of time, cost and performance parameters was inadequate for achieving the client's objectives in a property development project. Dr Ho then introduced the strategic approach of project management, which manages the project company and its project on an issue-by-issue basis. Dr Ho further explained the five basic steps of the management process, namely, initial identification of issues including analytical techniques at project and company level, prelim-

inary assessment of issues, detailed analysis of issues regarding potential impact and urgency, development of course of actions, and implementation, monitoring and feedback.

I would like to thank my colleagues from YSG, including Joanna Kwok and Alison Lo for their kind help during the event.

Hong Kong Railway Projects

On 20 August 2008, Ir Russell Black, Projects Director of the MTR Corporation Limited (MTRCL), was invited to give a presentation on the latest development of MTR. About 100 members attended this event.

The Government announced approvals for five new railway extension projects. They are all scheduled for urgent implementation following the announcement by the Chief Executive of the HKSAR in the 2007-8 Policy Address. In this seminar, Ir Black gave an overview of these projects.

At the beginning, Russell talked about the merger of KCRC and MTRC, and the concession arrangement involved. KCRC would grant a Service Concession to the MTRCL to operate the KCR system, with an initial period of 50 years. The KCRC would receive a one-time upfront payment, a fixed annual payment and a variable annual payment based on revenues generated from operation of the KCR system.

Russell also briefed about the following links:

- Kowloon Southern Link (West Rail Line to Hung Hom)
- Tseung Kwan O Line South Extension (Tseung Kwan O Line to Tseung Kwan O South Lohas Park residential area)
- West Island Line (Island Line extended westward to Kennedy Town) - with a lot of tunnels and lifts connecting the entrances to stations
- South Island Line to the South Horizons residential area and Wong Chuk Hang
- Kwun Tong Line Extension to Ho Man Tin and Whampoa
- Sha Tin to Central Link
- North Island Line
- Guangzhou-Shenzhen-Hong Kong Express Rail Link (XRL) (completion in 2015)

Russell mentioned that a public consultation programme had been run successfully for the West Island Line project to get the support of the local community. This kind of consultation will be used for future projects.

For the XRL project, Russell said that a high speed train will run from Hong Kong to Futian, Shenzhen, which will take 14 minutes only. This will reduce the travelling time a lot for the integration of two places. Some sections of the

future major interchanges: Hung Hom Station and Admiraltv Station were also shown.

Towards the end of the presentation, he talked about the target cost contract which is another successful example of MTRC. This pain-share and gain-share arrangement was successfully implemented for the completion of TKO Line in the past. Although much time and resources is required to agree the target cost, it is a worthwhile method in reducing disputes.



Sichuan Reconstruction Work

The 5.12 Sichuan Earthquake has caused great casualties to the province in terms of both human lives and properties. According to the information announced by the State Council of the PRC on 25 August 2008, 69,226 people died, 374,643 were injured and 17,923 people were lost in the earthquake. Various efforts have been initiated by different organisations, public and private, to restore normal lives to the victims.

In order to contribute to the reconstruction of Sichuan, HKIS joined "The Hong Kong Construction Sector 5.12 Reconstruction Joint Conference", led by the Development Bureau of the HKSAR Government. Other non-government organisations, such as The Hong Kong Institute of Architects (HKIA), The Hong Kong Institute of Surveyors (HKIS), The Hong Kong Institute of Planners (HKIP) and The Hong Kong Institute of Landscape Architects (HKILA), also joined the Joint Conference.

At the second meeting of the Joint Conference held on 12 August, two projects were proposed to take forward to the reconstruction in Sichuan:

- 1. Project Working Group for Reconstruction of Provincial Highway 303
- Project Working Group for Reconstruction of Wolong Natural Reserve

The reconstruction of Provincial Highway 303 is crucial as it is an artery road connecting Wolong Town to other main towns in Wenchuan County. Its extension also leads to Chengdu City, the capital city of Sichuan Province. It is important for the logistics of food and other resources from other parts of the province to reach the town. For Wolong Town, it is the natural habitat of the giant panda. The reconstruction of Wolong Natural Reserve will restore the natural environment and prevent the potential extinction of the panda. The management facilities, community facilities and infrastructures will be rebuilt.

Volunteers would need to spend seven to ten days in Sichuan to participate in one of the projects above. Members of our institution demonstrated their great concern on the matter and expressed their sympathy towards the victims. So far we have received over 100 replies. In the capacity of the President of HKIS, I strongly encourage our members to enrol in the recon-

struction work, as the reconstruction of the devastated areas requires great input of knowledge from professionals like us.

As appointed by the Executive Committee, I am the Convener for the Sichuan relief work in HKIS. I will act as liaison with the HKSAR Government regarding the further arrangement of the reconstruction work and convey the latest progress to the HKIS volunteers.

Promotion Committee

In order to promote the professional image and services of HKIS, a Promotion Committee was proposed by the Executive Committee, which will comprise one to two representatives from each division including YSG.

The Executive Committee also recommended the President to be the Chairman for a term of two years, subject to the approval of the General Council. Terms of reference are to be confirmed later. The preliminary list of committee members has been drafted and the final list will be announced next month.

After the formation of the Promotion Committee, the capability statements of each division will be revised for more up-to-date information and clearer scope of services. The Committee will also visit various government and non-government organisations to promote the changing role of surveyors in the society, the future development of our profession and identify potential cooperation opportunities.

My Recent Activities

I am glad to share with you the following remarkable events in August and September:

- On 12 August, I attended the 5.12 Reconstruction Joint Conference at Central Government Offices;
- On 14 August, I met and exchanged opinions with a group of real estate professionals from Guangdong Institute of Real Estate Appraisers and Real Estate Agents. The meeting was housed at CBRE Hong Kong Office;

Plenary Sessions

Many prominent speakers shared their experience to a full house of participants on the latest technological development and important works towards a better living world using Photogrammetry and Remote Sensing.

Mr Jos Achache of GEO spoke on "Co-operation to Build a Global Earth Observation System of Systems (GEOSS)." An initiative of GEO an intergovernmental organisation with 74 members and 51 participating organisations to work out a co-ordinated and sustained observation systems to provide easier and more open access to data.



Full house Plenary Sessions

Dr Juergen Dold of Leica Geosystems described the evolution of LIDAR systems in the geospatial and surveying market as an important step towards improving the accuracy of image data acquisition with lesser cost.





Fault Lines and Earthquake Zone, China

Professor Li Deren of Wuhan University, reported on the role of spatial information in the rapid emergency response to the Wenchuan earthquake. He described how photogrammetry.

remote sensing and spatial information technologies were applied to disaster response operations including the coordination of rescue efforts, combating secondary disaster, damage assessment and reconstruction.

Rapid data acquisition and information services using fully automatic, near real-time remote sensing systems without ground control had enabled a faster rate in search, rescue work and disaster relief.

It is important to develop a national level rapid response system that can collaborate work by different agencies and facilitate data and resource sharing. This requires the further development of China's National Spatial Data Infrastructure and the enhancement of high-resolution earth observation systems through strong international co-operation in spatial information science and technology. The International Charter and GEOSS from GEO represent an excellent beginning.

Technical Sessions

All technical sessions were well attended. Out of more than 2.800 abstracts submitted, 2,600 technical presentations were selected and presented. This had demonstrated the keen interests of all the participants in the works of Photogrammetry and Remote Sensing.

Since there were such a large number of technical presentations it would be difficult to give a detailed account of the contents. It would be appropriate to summarise, categorise and report them according to the relevant works of each of the eight Technical Commissions.

Technical Commission I reported on Image Data Acquisition - Sensors and Platforms

About 100 oral papers and 200 poster papers are related to SAR and LiDAR systems (this shows the increasing interest in these techniques). The showcase of the LiDAR systems was its improved accuracy by a factor of four and the time saved, and hence saved cost by a factor of ten. The systems have become more portable and versatile.

Technical Commission II reported on Theory and Concepts of Spatio-Temporal Data Handling and Information

TCII addresses major issues in geo-information science. These include spatio-temporal modelling, spatial reasoning, analysis and data mining, multiple representations, visualisation, spatial decision support, system integration and interoperability, quality and uncertainty of spatial data and models, and 3D and dynamic data handling.

Though 3D visualisation is becoming more common there are many issues and challenges, namely quality propagation through spatial analysis, spatial decision support with highly complex data, interoperability of heterogeneous systems and geo-sensor networks.

The penetration of GIS technology in an increasing number of areas leads us to believe we need more theory on spatial modelling, interoperability and visualisation. This is evident from the tremendous rise of services like Google Earth and Microsoft Virtual World. These services have a widespread impact on society and the way we deal with spatial information.

Technical Commission III deals with Photogrammetric Computer Vision and Image Analysis

Automation of close range bundle adjustments, where only control points require manual interaction, was developed. The generation of highly detailed surface models constructed from images has advanced to a point where images are becoming an interesting alternative to LiDAR.

The direct access to 3D information from LiDAR systems has triggered a large amount of research, including research into increased morphological quality for digital elevation models, ease of 3D-reconstruction for large build-up areas, and detailed analysis of forest areas.

Information density can be increased by the availability of intensity and waveform, enabling more detailed classifications. Also, the interpretation of aerial and terrestrial images successfully grasped techniques from pattern

recognition and machine learning, especially for the modeling of road networks and facade structures.

The analysis of video sequences is becoming a hot topic, especially for the highly challenging and relevant task of so-called 'simultaneous localisation and mapping', both from the ground and air, using UAVs.

Technical Commission IV deals with Geodatabases and Digital Mapping

The acquisition, organisation, analysis, visualization, modelling and dissemination of geospatial information had been made easy by the advancement and development of space, geospatial, computing and communication technologies.

These geospatial information had been used effectively for natural resource management, environmental and ecosystem protection, disaster management and climate modeling.

Rescue and relief operations rely on the collection, integration and analysis of data - including 3D data.

The recent availability of high resolution stereo data from aerial and satellite platforms has revolutionised data acquisition and provided an opportunity to develop techniques for automatic data extraction. Image databases with high temporal resolution are expanding, especially for ocean applications.

Developments in visualisation allow us to display landscapes and seascapes virtually, and to depict both global and local processes. The use of GIS to access, analyse and disseminate spatial data has enhanced web-based services. Web GIS allows us to more efficiently manage massive distributed computing/storage resources. Open-source software provides new, cost-effective solutions to web-based geospatial information and services.

Technical Commission V deals with Imaging and Laser Scanning Techniques

Imaging and laser scanning techniques are used in industrial and engineering metrology, cultural heritage documentation, virtual reality 3D data acquisition, robotics, 3D motion analysis, quantitative medical imaging, biometry, and many more.

A central issue in many developments is the integration of sensor technology with reliable data processing schemes to generate precise and highly automated online or real-time photogrammetric 3D measurement systems.

Technical Commission VI deals with Education and Outreach

TC VI deals with educational matters related to photogrammetry, remote sensing and the spatial information sciences. The technological advancements in these three fields are numerous.

Internet-based information services such as Google Earth and car navigation are widely used by the public today. More technical and educational training are needed for the growth in interest in these applications.

Education and training are no longer restricted to a few years of university. Rapid advancements in technology have increased the importance of lifelong education in our fields. The internet and e-learning play significant roles in lifelong education. Despite the growing availability of educational materials and e-learning courses, it is not easy for beginners and students to find appropriate educational materials. Promoting online information to the public will help to widen recognition and acceptance of e-learning material. A number of sessions on capacity building were presented.

Technical Commission VII deals with Thematic Processing, Modelling and Analysis of Remotely Sensed Data

Highlights of presentation included the following topics:-

 Rapid developments in SAR remote sensing data sources, such as the high resolution RADARSAT-2 from Canada, the COSMO-Skymed SAR satellite from Italy (the highest SAR spatial resolution system in the world, providing detailed images of the earth under all weather conditions), and the German TerraSAR.

The launch of these satellites has driven much research in image and data fusion methodologies. The recent Sichuan earthquake is a good example of how SAR data, along with other data sources, can be used to greatly assist relief efforts in difficult terrain and adverse weather conditions.

- Fundamental physics to enable a better understanding of the geophysical parameters which influence the signals recorded by remote sensing sensors.
- New image processing algorithms and analysis techniques which show that rapid progress has been made in image classification methods, going from traditional/

conventional pixel-based techniques to advanced context-based and texture-based classification procedures.

Other important presentations cover change detection methods.

Technical Commission VIII deals with Remote Sensing Applications and Policies

Remote sensing is the science used to carry out acquisition of information about properties of objects or phenomena without physical contact.

Space-borne satellites are used to capture data for Earth observation. Each new satellite will serve as a platform for a new scanning observation system; each new system will manifest progressively better resolutions, both spectral and geometrical.

The old days of capturing the moment on black and white or colour film are long gone. Now data are collected digitally by dividing the captured scene into a mesh of small equalsize picture elements known as pixels.

TC VIII focused on many remote sensing applications namely impact analysis of human settlement; hazards and disasters; public health; air pollution; coastal zone management; polar, alpine and cryogenic research; land degradation; desertification and arid lands. It also deals with issues related to management of tropical zones; policies, treaties and data access; water security; precision agriculture; sustainable forest; landscape management; geological mapping and geomorphology.

Details Following the major earthquake at Sichuan on 12 May 2008, the HKSAR Government immediately deployed a Search and Rescue Team to assist the Mainland authority in rescue work. The 43-member Search and Rescue Team, led by Mr TAM Tai-

keung, Senior Divisional Officer of Fire Services Department, included 34 firemen, 6 ambulancemen, a medial officer, a registered nurse and an information officer. The Team flew to Chengdu in two batches on May 15 and 16 and were assigned to carry out search and rescue work at Hanwang in Mianzhu, one of the most devastated areas. The Team recovered 24 bodies from the rubble of a collapsed office building and factory plants in the vicinity, and assisted the PRC Army finding a

woman survivor trapped under a collapsed building.

majority of these works are actually handled by quantity surveyors under the supervision of civil engineers. In the building works, the traditional role of handling these works by architects had been changed to become the role of quantity surveyors, and the Government and Private Forms of Building Contract were changed to recognize such QS role. However, in the infrastructure works, such QS role is still with the civil engineers as stated in the Government Form of Civil Engineering Works.

In this forum, TT Cheung, being the past president of HKIS and a current CIC member representing the surveying profession will give a brief introduction on the current system of QS role in infrastructure works and explain the deficiency of the current system and the ways HKIS sees it fit. TT will also give a brief recap on what HKIS had done to promote the independent role of QS in infrastructure works and its results as of today. Comments and ideas from the participants will be invited for the way forward that they would like to see HKIS should do.

The Business Pros and Cons of Using Term Contracts in Fitting-out Projects

Joseph is currently a Senior QS in Page Kirkland Group's Hong Kong office and is running millions of fitting-out projects for a worldwide retail chain in Macau and Abu Dhabi. Before joining Page Kirkland, he was the Cost Manager in the Corporate Real Estate Department of an international bank and responsible for all the QS service in Hong Kong. At that time, he introduced and implemented the term contracts for the bank's fitting-out work of branches and offices, as well as churn projects.

CW is the Project Manager in the Corporate Real Estate Department of an international bank and responsible for fitting-out of its branches. He was the project in charge for the fitting-out projects of a major convenience store chain in Hong Kong.

With rental costs for Hong Kong retail space on the rise in recent years, it makes good economic sense for retailers to make their operations as cost-efficient as possible. For some, rental cost can account for up to 50% of their operating costs. The key to coping with rising rental pressure is by reduction in store size, relocation and closure of underperforming shops while expanding outlets and flagship stores at location close to prime area. As a result, there are a lot of associated fitting-out projects in the market which in turn jack up the fitting-out costs.

Corporate Real Estate Department and its project team are traditionally treated as a "cost centre". They are driven to look for all means to deliver "value-for-money" projects. Some retailers are negotiating longer-term fitting-out contracts, up to two years, with their suppliers to achieve lower costs and shorter fitting-out period. In addition, these longer-term relationships have the potential of delivering better value to the end users. This paper discusses about the financial and business benefits, and the challenges of using term contracts in Hong Kong through 2 cases of convenience stores and bank branches.



My response to the Young Land Surveyor's Concern

It was reported under the President's Message in the last issue of Surveyors Times that young surveyors of different Divisions have raised their concern on the future of their profession. I am happy to share my views with the young land surveyors about the future of our profession. Because of the economic downturn, the construction industry had shrunk for some years and job opportunities for land surveyors had unavoidably been affected.

The general picture is still grim today but the good news is that the government has announced the 10 major-infrastructure projects which might somehow improve job opportunities for young land surveyors. The government has resumed recruitment of land surveyors which also helps the profession a bit.

The Institute has met the Permanent Secretary for Works to discuss, among other things, the contribution of surveyors in large projects and the value of surveyors has received the appropriate recognition. We still wait to see how such recognition can finally be converted into job opportunities but it is definitely moving towards the right direction.

As young land surveyors, my advice would be that they should always try to improve themselves and venture into areas beyond the scope of their own profession. For example, land surveyors should get to know more about the laws of Hong Kong whether it is on land matters or on contracts. They should also keep themselves abreast of the latest technology in GIS, GPS and Remote Sensing. Development trends are seen in these areas. After all, opportunities only go to those who have the competitive-edge over others and such competitive edge can only be achieved through continuous professional development. So young fellows, keep your spirit high and work hard for your future!

New Dynamic of Infrastructure Development - Railways and Tunnel Construction

Anthony Yu



The Chief Executive of the HKSAR announced in the 2007-2008 Policy Address that the Government will push ahead with 10 large-scale infrastructure projects. Four of them are related to railways and tunnels. They are the South Island Line, the Sha Tin to Central Link, the Guangzhou-Shenzhen-Hong Kong Express Rail Link and the Airport Rail Link.

In order to share the experiences of Land Surveyors, Engineering Surveyors, Geospatial Engineers and Commercial Managers in major construction projects and to illustrate the impact of survey technologies to these projects, the Land Surveying Division of HKIS, ICES Hong Kong Region, RICS and the Lighthouse Club co-organised a half day seminar on this topic.

Government of the Hong Kong Special Administrative Region Drainage Services Department Advisory Service on Construction Contract Adopting New Engineering Contract

The Government of the Hong Kong Special Administrative Region (the Government) is inviting express of interest in providing advisory service in relation to the adoption of New Engineering Contract (NEC) suit of contract for a construction project (the NEC pilot project).

The NEC pilot project involves the improvement to a 180m open nullah at Fuk Man Road, Sai Kung and associated landscaping works and minor road improvement works. The works are scheduled to commence in early 2009 for completion in early 2012. The NEC project is administered by Drainage Services Department.

Since it is the first time that the Government adopts NEC for public works contracts, to ensure a smooth implementation of the pilot project and a successful trial of NEC, the Government intends to appoint a technical adviser who has substantial experience on NEC projects to provide advice to the Government during contract stage of the NEC pilot project.

The tentative roles of the technical adviser are: (i) to provide guidance on developing cooperative working skills, attitudes and behaviours among the parties in the contract; (ii) to advise on interpretation of the NEC document and advise Government on the effective administration of the

NEC pilot project; (iii) to advise Government on financial management including target cost adjustment and cost auditing; (iv) to promote dispute avoidance and risk management; and (v) to assist the Government in monitoring the performance and measuring the results of the NEC pilot project. The technical adviser shall work part-time and on a need basis and the advisory service will be based on a charge-out rate, subject to a lump sum ceiling proposed by the technical adviser before appointment and agreed by the Government.



Hong Kong Convention and Exhibition Centre: Phase 2 Expansion - Heavy Lifting of Mega Trusses

On 11 September 2008, Mr Christian Venetz, VSL Hong Kong's Design and Technical Manager, Mr Henry Chan, Project Manager of VSL Hong Kong Limited and Mr Antony Lam, VSL's site Method Engineer, presented the successful and challenging erection of the Main Trusses A to D of the Hong Kong Convention and Exhibition Centre (HKCEC) Expansion Project to our members in a CPD.

At the beginning, Christian and Henry introduced the design of the lifting system, which lifts up 4 heavy trusses in pairs simultaneously. Due to the limited lifting capacity of normal cranes and the limited access of the site, VSL's lifting system was chosen. The lifting system was formed by using 4 strand jacks around each lifting column. In order to lift the trusses, additional temporary bracings were added and the truss capitols have to be detached and installed separately. Other than lifting vertically, a pair of trusses was slid horizontally across 54 m at 36 m above ground level using a similar jacking method. Other challenges of the project included the limited height of the feature roof of HKCEC Phase II and the extensive temporary work design and checking involved.

At the end of the talk, Antony described the other challenges in lifting of other smaller components of the trusses such as the end-post. He further introduced in detail how the strand jack lifting system works. The system includes a hydraulic pump and a computerised control and monitoring system.

This seminar was a good opportunity for members who missed the site visit a few months ago to learn from this mega building project.



Strategic Aspect of Project Management

A CPD event on "Strategic Aspect of Project Management" was successfully held on 28 August 2008 at the HKIS Surveyors Learning Centre. Dr Paul H K Ho, Head of the Division of Building Science and Technology, City University of Hong Kong kindly delivered a talk to our members. Dr Ho is the Past Chairman of Quantity Surveying Division, HKIS and has worked as a quantity surveyor and a project manager for over ten years.

At the beginning of the talk, Dr Ho highlighted that the traditional approach of project management in terms of time, cost and performance parameters was inadequate for achieving the client's objectives in a property development project. Dr Ho then introduced the strategic approach of project management, which manages the project company and its project on an issue-by-issue basis. Dr Ho further explained the five basic steps of the management process, namely, initial identification of issues including analytical techniques at project and company level, prelim-

inary assessment of issues, detailed analysis of issues regarding potential impact and urgency, development of course of actions, and implementation, monitoring and feedback.

I would like to thank my colleagues from YSG, including Joanna Kwok and Alison Lo for their kind help during the event.

Hong Kong Railway Projects

On 20 August 2008, Ir Russell Black, Projects Director of the MTR Corporation Limited (MTRCL), was invited to give a presentation on the latest development of MTR. About 100 members attended this event.

The Government announced approvals for five new railway extension projects. They are all scheduled for urgent implementation following the announcement by the Chief Executive of the HKSAR in the 2007-8 Policy Address. In this seminar, Ir Black gave an overview of these projects.

At the beginning, Russell talked about the merger of KCRC and MTRC, and the concession arrangement involved. KCRC would grant a Service Concession to the MTRCL to operate the KCR system, with an initial period of 50 years. The KCRC would receive a one-time upfront payment, a fixed annual payment and a variable annual payment based on revenues generated from operation of the KCR system.

Russell also briefed about the following links:

- Kowloon Southern Link (West Rail Line to Hung Hom)
- Tseung Kwan O Line South Extension (Tseung Kwan O Line to Tseung Kwan O South Lohas Park residential area)
- West Island Line (Island Line extended westward to Kennedy Town) - with a lot of tunnels and lifts connecting the entrances to stations
- South Island Line to the South Horizons residential area and Wong Chuk Hang
- Kwun Tong Line Extension to Ho Man Tin and Whampoa
- Sha Tin to Central Link
- North Island Line
- Guangzhou-Shenzhen-Hong Kong Express Rail Link (XRL) (completion in 2015)

Russell mentioned that a public consultation programme had been run successfully for the West Island Line project to get the support of the local community. This kind of consultation will be used for future projects.

For the XRL project, Russell said that a high speed train will run from Hong Kong to Futian, Shenzhen, which will take 14 minutes only. This will reduce the travelling time a lot for the integration of two places. Some sections of the

future major interchanges: Hung Hom Station and Admiraltv Station were also shown.

Towards the end of the presentation, he talked about the target cost contract which is another successful example of MTRC. This pain-share and gain-share arrangement was successfully implemented for the completion of TKO Line in the past. Although much time and resources is required to agree the target cost, it is a worthwhile method in reducing disputes.
