Message from the President



The year 2014 marks the 30th Anniversary of the Hong Kong Institute of Surveyors. Throughout the past three decades, the Institute has been growing significantly. It started with 85 members on 26 April 1984 and has now expanded to 8,000 members.

The success of the Institute is the result of the hard work of its members. I would like to express my heartfelt thanks to our founding members and past presidents for their vision and leadership. My thanks also go to every member whose contributions have made the industry flourish. During the past 30 years, there were many memorable and important activities in the Institute's history. For this HKIS 30th anniversary commemorative publication, we have compiled a chart of the Institute's major milestones from 1984 to 2013 to document the development of the profession.

The HKIS is dedicated to setting the standards of the surveying industry, developing outstanding surveyors, and making contribution to Hong Kong's development. As a reputable and responsible professional organisation, HKIS has received widespread recognition. We actively engage in social issues that are related to land, property and construction. In recent years, we have contributed our expertise to the areas of land and housing supply, building safety, sub-divided flats, arbitration on land premiums, building maintenance, resumption and compensation, first-hand sales of residential properties, adverse possession, land boundaries, regulation of the property management industry, implementation of waste reduction by waste charging, and construction dispute resolution through mediation and arbitration.

With the liberalisation of the Mainland market, the ties of Hong Kong's surveyors with their Mainland counterparts have strengthened significantly. Since the introduction of the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA) in 2003, the Institute has continuously worked with its Mainland counterparts to develop agreements for the mutual recognition of each other's professional qualifications. As a result, 763 HKIS members have acquired the corresponding Mainland qualifications, while 834 Mainland surveyors have acquired HKIS qualifications. In view of the increased number of HKIS members working in Mainland, the Institute opened its first branch office in Beijing in November 2013. Through this new office, the Institute wishes to provide better support to its members working in China and to establish closer connections with the Mainland government organisations, professional institutions and industry partners.

Surveying is a global industry. Our members' services cover Hong Kong, Mainland, Asia and the Pacific, and various parts of the world. The Institute is actively involved in international efforts to set standards for surveying practices and to tackle global problems in the areas of climate change, natural disasters, urbanisation, valuation and provision of housing and food. On the international level, the HKIS has entered into reciprocity agreements with various professional organisations from the UK, Australia, New Zealand, Canada, Singapore, and Japan.

2014 will be a memorable year with a series of events to mark the 30th anniversary. I look forward to seeing you at these functions to celebrate the Institute's achievements together.

I would like to express my sincere thanks to all surveyors, HKIS secretariat colleagues and counterparts in the community for their support for and contribution to the Institute's remarkable development. I wish the HKIS and its members every success in the years to come.

About HKIS

The Hong Kong Institute of Surveyors ('HKIS' or 'the Institute') was founded in April 1984 and had 85 founder members. The Institute was statutorily incorporated by virtue of the Hong Kong Institute of Surveyors Ordinance in January 1990 (Cap. 1148). In July 1991, there was also passed the Surveyors Registration Ordinance (Cap. 417) to set up a Registration Board to administer the registration of surveyors.

The Hong Kong Institute of Surveyors is the only professional organisation representing the surveying profession in Hong Kong. The Institute strives to maintain a high professional standard and requirements amongst members including setting standards for professional services and performance, establishing codes of ethics, and determining requirements for admission as professional surveyors. The Institute imposes a mandatory requirement for all members to upgrade skills through continuing professional development.

As a reputable and responsible professional body of surveyors, the Institute has always maintained vigorous assessment standards for entry to the profession and has also maintained high professional and ethical standards of member surveyors, through the various codes of professional practices, the code of ethics, and continuing professional development. The Institute has taken on an important and responsive consultative role in government policy making particularly on issues affecting land, property and construction. The Institute plays an important role from time to time in giving advice to the Government on issues such as unauthorised building works, building safety campaign, problems of property management, town planning and development strategies, construction quality and housing problems.

The HKIS membership has now grown to over 8,000. As at 31 March 2014, there are 6,007 Corporate Members consisting of Fellows and Members – distinguished by the initials FHKIS and MHKIS; 66 Associate Members – distinguished by the initials AMHKIS; and 2,761 training grade members.

To qualify as a corporate member of the Institute, surveyors must possess a recognised academic degree or similar qualification, followed by a minimum of 2 years supervised professional experience within strict guidelines, followed by an Assessment of Professional Competence (APC).

The title "Surveyor" embraces a number of disciplines involved with land and its development with land and buildings, covering an extremely wide scope. Some surveyors work in private practices and others may work for a landowner, developer, building contractor or government departments and related bodies.

The Institute consists of six divisions:

- 1. Building Surveying Division
- 2. General Practice Division
- 3. Planning and Development Division
- 4. Quantity Surveying Division
- 5. Land Surveying Division
- 6. Property and Facility Management Division

A land surveyor measures and records the shape and position of the land, defines the boundary and sets out the legal boundaries of the sites. A general practice surveyor advises on the best use of the land, assesses the feasibility and viability of the proposed development project as well as the valuation, marketing, sale, leasing and management of completed developments. A planning and development surveyor further advises on the possible change of zoning, the likely environmental impacts and makes suggestions on preliminary development contents. A quantity surveyor is concerned with the building contractual arrangements and cost control, and will evaluate the likely cost of the development project and advise on the most suitable kind of contract for the project. A building surveyor is involved in the project management of building development proposal, holistic maintenance management of building and overall control of private buildings under relevant legislation. A property and facility management surveyor provides a comprehensive range of services in real estate management.

About **HKIS**

Internationally, the Institute has established and continues to expand its presence in the international scene through participation in various international platforms. Over the years, the Institute has shown its international importance and leading position by playing an important role in participating and joining different international organisations and committees included the World Organisation of Valuation Associations (WAVO), World Organisation of Building Officials (WOBO), Pacific Association of Quantity Surveyors (PAQS), International Federation of Surveyors (FIG), South East Asian Surveyors Congress (SEASC), International Valuation Standard Council (IVSC) etc. In May 2001, Past Chairman of the Quantity Surveying Division, Sr TT Cheung was elected as Chairman of the PAQS for the term 2001 to 2003 at the 5th PAQS Board Meeting. In January 2003, Past President (Council Year 1997/98) Sr WONG Thien Nyen was elected as the Vice President of the FIG Council 2003 – 2006. The status and reputation of the Institute have been much upgraded through the active participation in these international organisations and events.


Over the years, the Institute had also successfully organised a number of international events in Hong Kong or other countries. The FIG Working Week was the biggest congress event ever organised by the Institute. The Institute also regularly hosts the Cross Strait Land Conference (兩岸四地土地學術研討會) and the Cross Strait Geometric Conference (海峽兩岸測繪發展研討會).

Besides international participation, the Institute has established reciprocity relationships with other national surveying bodies and through membership in relevant world bodies and international organisations in order to maintain its professional edge at international level. The Institute is one of the 3 founding members, apart from the Singapore Institute of Surveyors and Valuers and the Institution of Surveyors, Malaysia, of the Surveyors' Alliance Asia which was inaugurated in November 2004. 

The Building Surveying Division (BSD) has been helping the general public to tackle various building related problems for the past few years.

MBIS Inspection Fee Scale Reference

In order to assist the public and building owners to budget their funds for a professional quality building inspection and the management of repair works by appropriate building professionals, the BSD released a reference fee scale in October 2012 for professional surveyors who undertake the relevant services.

We expect the fee scale to help the public gauge and compare the fee proposals prepared by different professionals or service providers in the market so that owners can select their providers wisely. We have made it clear to the media and the public that the fee scale is not mandatory, and building owners should still need to judge and compare the fees and services of different consultants with comprehensive perspectives based on the circumstances of each building.

We have also published a Professional Guide to Building Inspection, Volume 1: Pre-1980 Residential and Composite Buildings in Hong Kong in September 2013 as a guideline for the practitioner to conduct building inspection.

Press Conference on the "Proposed long-term strategy to handle Unauthorised Building Works"

BSD Spokesmen, Sr Vincent HO, Sr Andrew KUNG, and Sr David CHAN, held a press conference on 10 January 2013 to present our proposed long-term strategy on how to handle Unauthorised Building Works. The conference received good media coverage on the following day. President Sr Stephen LAI also forwarded the strategy to the Secretary for Development on 17 January 2013, so we hope our ideas and proposals can be further explored by the Administration.

Sub-Divided Flats

On 26 June 2013, after arrangements by the Society for Community Organisation (SoCO), the BSD's Past Chairman cum Spokesman, Sr David CHAN, and I visited some SDFs in Sham Shui Po. We noted that they were in an unsatisfactory condition with unacceptable fire safety provisions and very poor hygiene. A second visit was made on 19 July 2013 to record the details of these SDFs in order to formulate a proposal for presentation to the government on how to handle them, apart from strictly following the current enforcement policy in handling unauthorised building works that has been adopted by the Buildings Department. A press conference held on 23 July 2013 to formally publish this proposal.

"AP Easy" Building Maintenance Advisory Service Scheme

Hong Kong Institute of Surveyors in collaboration with the Hong Kong Institution of Engineers and the Hong Kong Institute of Architects will assist the HAD to launch the "AP Easy" Building Maintenance Advisory Service Scheme in April this year for OCs that intend to carry out large-scale maintenance projects. The aim is to offer professional and tailor-made advice and support services to assist them in engaging authorised persons/consultants to carry out such works.

Our Building Surveyors are all familiar with our own professional building knowledge and professional ethic. We are willing to help the public to tackle all building related problems and to ensure a health and safety living environment in Hong Kong.

Professional building surveyors deliver complete building solutions. In private practice, we are involved in all stages of the development process from inception to completion. We are available to provide tailor-made services for employers engaging in building development.

Professional building surveyors are qualified by examination and practical experience. We uphold the stringent professional standards of the Hong Kong Institute of Surveyors, which requires a high level of service and efficiency as well as compliance with a strict code of professional conduct.

Our areas of specialisation are as follows:

Survey of New Buildings

Building surveyor is a profession who has the identity by the name as "Surveyor of Buildings". A building surveyor's core expertise in survey of new buildings is as described below:

- building control in Buildings Department;
- technical advice on legal restrictions, such as Buildings Ordinance, Town Planning and Land Leases;
- development consultancy and project monitoring in joint venture developments and on behalf of project financiers;
- project management during development stage; and
- independent audit vetting services for Sales Brochure according to The Residential Properties (First-hand Sales) Ordinance.

Survey of Existing Buildings

- management of fitting-out work for residential building, office, commercial building; and
- conduct inspection services for Mandatory Building Inspection Scheme and Mandatory Window Inspection Scheme.

Four Major Scopes of Expertise

(i) SITE ACQUISITION STAGE

The building surveyor acts as a project manager in advising on the development potential with respect to technical and legal implications as follows:

- any restrictions imposed by the Buildings Ordinance, the lease conditions and the Town Planning Ordinance, and also on any construction difficulties likely to be encountered;
- financial and economic considerations affected by the construction aspects; and
- joint venture terms and following through the drawing up and execution of the agreement.

(ii) DEVELOPMENT STAGE (OR CONSTRUCTION STAGE)

The building surveyor acts as a project manager (or project consultant) to monitor the construction process, so that the buildings are constructed on time and within budget with the desired quality being achieved. The major services are as follows:

- preparation of feasibility studies and client brief;
- preparation of budgets and master programme;
- appointment of professional project design team, such as architects, engineers, and quantity surveyors;
- management of building design and selection of materials;
- coordination of government approvals;
- procurement, tendering, award of contracts and sub-contracts, contract administration, and coordinating the approval of shop drawings, samples, variations and claims;



- construction monitoring, such as time, cost and quality;
- communication and reporting; and
- undertake financial control, such as cash flow, progress payments and final account.

(iii) **PRE-COMPLETION STAGE**

- advise on capital costs and running costs (cost-in-use) and on replacement costs for fire insurance purposes;
- advise on maintenance strategy and prepare all maintenance manuals, as-built drawings and specialists handbooks; and
- on behalf of employer, coordinates and approves alterations to the building and building services proposed by tenants and occupiers.

(iv) AFTER COMPLETION

Building surveyors play a major role in the management and maintenance of buildings after their completion. The major services are as follows:

- advise on construction and legal constraints prior to letting and arranging for the fitting out works for the employer, leading to the issue of licences, such as restaurants, hotels, child care centres, kindergartens and old aged homes;
- advise on planning and implementation of maintenance programmes both day-to-day and long term;
- diagnose building defects and advise on remedial works and costs;
- provide expert knowledge on design and materials performance;
- alterations, additions and improvements to existing buildings;
- condition surveys of existing buildings and preparation of dilapidated schedule;
- inspect older buildings in respect of building and fire safety under the Buildings Ordinance and Fire Safety (Commercial Premises) Ordinance respectively;
- conditions surveys of existing buildings prior to major construction activities, and advise on effects and remedial actions including litigation and compensation;
- act as an expert witness in court and arbitrator in building and contract disputes; and
- advise on maintenance strategy, improvement and renovation works, and administer the Deed of Mutual Covenant and Building Management Ordinance.

Nine Core Services

Expertise possessed by professional building surveyors can be summarised and grouped in the following nine core services undertaken on behalf of employers:

- (i) project planning and design;
- (ii) project management and monitoring;
- (iii) project supervision (as technically competent persons required by Buildings Department to ensure construction safety);
- (iv) project revitalisation (alteration, addition, improvement, refurbishment and renovation);
- (v) building management and maintenance (repairs and maintenance);
- (vi) building measurements, surveys and fire insurance valuations;
- (vii) building safety and fire safety inspections and works supervision;
- (viii) facility management; and
- (ix) disputes resolution (expert witness and arbitration).

I am pleased to take this opportunity to share with you some milestone developments of the General Practice Division in the past 30 years.

Throughout years of development, the services offered by the General Practice surveyors can be wide and varied. Members through their professional training, skill and knowledge are in a position to offer skilled and effective advice in connection with planning, development, use, management and valuation of real properties; acquisition, compulsory purchase and compensation, negotiation of sales and lettings by private treaty and sale by tender or auction of real properties; and financial and economic aspects of investment in real property.

Besides real property related scope of work, experienced members are also involved in trade-related business assets and business valuation. Not to mention their involvement in project management, property and facilities management, and the recently required intellectual properties valuation.

Apart from their work in the private practice and quasi-government bodies, General Practice surveyors are also employed by the Hong Kong Government in various departments such as the Lands Department, Rating and Valuation Department and Housing Department to handle work including government land disposal, resumption, rating, taxation, sales and letting, public housing management and home ownership scheme, etc.

Thanks to the great contributions of our previous council members and the divisional members in the past 30 years, we have made lots of achievements and our divisional corporate membership increased from 150 in 1984 to 2,100 currently. Milestone developments of the Division included the following areas, Internal Affairs, External Affairs, Local Affairs and Professional Standards.

Internal Affairs

The Division has organised various continuous professional development ("CPD") events every year. Technical visits to the Mainland and the surrounding countries as a kind of CPD event have also been organised to broaden members' knowledge.

In 2011, a new Assessment of Professional Competence (APC) scheme was introduced to recognise the importance of professional knowledge in some specific areas and, as such, probationers undergoing the APC will have to attain the requisite standards in a more structured way.

External Affairs

The Division, under the name of HKIS, has made numerous achievements in this area. We have established good relationships with various international valuation organisations. We signed reciprocity agreements with various international valuation organisations such as the Australian Property Institute (in 1994), the Singapore Institute of Surveyors and Valuers (in 1997), the China Institute of Real Estate Appraisers (in 2003), and the New Zealand Property Institute (in 2003). We are also a member of the International Valuation Standards Council (IVSC) and World Association of Valuation Organisations (WAVO).

We also actively participated in conferences/ seminars organised by overseas valuation organisations to promote the HKIS and the Division and to exchange views on valuation issues. To name a few: valuation seminars held in Shenzhen in 1998, valuation conferences/ seminars held in Beijing in 2004 and 2011, ASEAN Valuation Association Conference in Brunei in 2012, and the Pan Pacific Congress in 2010 and 2012.

The HKIS, being one of the founding members of the Hong Kong Business Valuation Forum ("HKBVF"), has successfully set up the HKBVF jointly with RICS Hong Kong and the Hong Kong Society of Financial Analysts in 2005.



Local Affairs

In recent years, there have been many local affairs relating closely to our profession such as the Residential Properties (First-hand Sales) Ordinance, Enhancing Land Supply Strategy and Long Term Housing Strategy. Our members' views have been delivered to relevant authorities through various panels and working groups including Arbitration on Land Premium Task Force, Liaison Group with Sales of First-hand Residential Properties Authority, Land Policy Panel, Standing Committee on Code of Measuring Practice. The Division issued the Code of Measuring Practice in 1999 and its supplement in 2012 to cope with the changing needs of the profession.

Professional Standards

To meet the increasing need for valuing various types of assets including tangible, intangible and financial assets as well as business enterprises valuation, the Division set up a Business Valuation Panel in 2003 and issued the HKIS Valuation Standards on Trade-related Business Assets and Business Enterprises in 2004. To further emphasise the commitment of HKIS in ensuring integrity, ethical conduct of members, the HKIS Valuation Standards on Properties was issued in 2005, which is mandatory in most of the areas. To meet the drastic changes in the capital market and accounts reporting standards in recent years, with the great effort of members of the Valuation Standards Panel of the Division, the HKIS Valuation Standards 2012 Edition was effective on 1 January 2013. The updated standards combined the Guidance Notes on Valuations of Properties for Mortgage Purpose and the above mentioned two valuation standards. The HKIS is now having a comprehensive valuation reporting standards for various properties.

To further govern the requirements of eligible members to undertake valuation works for listed companies in Hong Kong, the Division has published a list of Property Valuers for Undertaking Valuation for Incorporation or Reference in Listing Particulars and Circulars and Valuations in Connection with Takeovers and Mergers.

Looking Forward

The Division will continue to build up communications between the GPD Council and the members as well as to maintain our relationship with overseas valuation organisations. The Division is organising its first valuation conference in June 2014 and is working with RICS Asia for a Joint Asian Valuation Conference this year. The Division will take a proactive role to strengthen HKIS position in the IVSC. With the support of the Ministry of Finance and the Ministry of Land and Resources of China, we are currently working on possible reciprocity arrangement with the China Appraisal Society and the Land Appraisal Society in China.

The Division will continue its input on various local affairs and will from time to time recruit relevant specialists and assign appropriate members to take care of appropriate issues. The arrangement of a certified Structural Learning Programme will also be continued. Last but not the least, the Division is working on further developing the recognition of our members' professionalism in the area of intellectual property valuation and project management.



It is my greatest pleasure to share with you some milestones of the Land Surveying Division in the HKIS 30th Anniversary.

At the outset, I would like to express the sincerest gratitude to all previous council members and the divisional members in the past 30 years for the great contributions toward the prosperous development of the HKIS. Those achievements are remarkable in various areas including Internal Affairs, External Affairs, Local Affairs and Professional Standards in the history.

History of Land Surveying Profession in Hong Kong

In 1970's, a group of both local and expatriate professional land surveyors decided to provide a professional forum for all land surveyors in Hong Kong, and thus they established the Hong Kong Institute of Land Surveyors (HKILS) in 1976.

In 1984, HKILS was formally recognised by the government as the only professional body representing the professional land surveyors. HKIS was also formally recognised by the government the next year. Corporate membership of the HKIS had also been recognised as a suitable qualification for appointment to the relevant grades and post in the civil service. The increase in the number of land surveyors joining HKIS eventually led HKILS to amalgamate with HKIS in 1991. In the same year, with the effort of land surveyors to strive for a local land surveying degree course, the Hong Kong Polytechnic (now known as the Hong Kong Polytechnic University) had successfully started a degree course in land surveying.

In 1994, the first batch of graduates in Land Surveying and Geo-informatics was produced.

Important Events

- 1976 Establishment of HKILS.
- 1984 HKILS was formally recognised by the government as the only professional body representing the professional land surveyors.
- 1985 HKIS was formally recognised by the government.
- 1991 HKILS amalgamated with HKIS.
- 1991 A land surveying degree course was started at the Hong Kong Polytechnic (now known as the Hong Kong Polytechnic University).
- 1993 The scale of charge for Land Surveying was finalised for publication. The draft Land Survey Bill was sent to the Legislative Council; and the Code of Practice replaced the supplementary regulations.
- 1995 The Legislative Council passed the Land Survey Ordinance. It required the Administration to consult the HKIS for any amendments to the Ordinance and the Code of Practice.
- 1996 The Land Survey Ordinance became operational on 15 January 1996. Three HKIS LSD members began to serve on the Land Surveyors Registration Committee.
- 1997 RICS Hong Kong Branch was dissolved. HKIS became the sole de facto body representing the land surveying profession in Hong Kong.
- 1999 Regarding the Assessment of Professional Competence, LSD issued the Notes for Guidance of Employers, Supervisors and Counsellors in June 1999. The Rules and Guide to Assessment of Professional Competence, which defines the training scheme of student members, was revised and implemented on 1 August 1999. In November 1999, at the 6th South East Asian Surveyors Congress (SEASC) held in Fremantle, Perth Australia, HKIS made a successful bid for the hosting of the 7th SEASC in Hong Kong in 2003.
- 2000 HKIS commented on the proposed Land Tities Bill that any instruments effecting the transaction of land parcels be attached with a land boundary plan prepared by the authorised land surveyors registered under the Land Survey Ordinance.
- 2001 HKIS expressed to the Administration its concerns about the proposed corporatisation of the Survey and Mapping Office and subsequently attended the Legislative Council joint meeting of the Panel on Public Service, and the Panel on Planning, Lands and works on 24 May 2001.
- 2002 HKIS published the Guidance Notes on Land Boundary Survey prepared by the LSD Boundary Survey Advisory Committee. HKIS prepared the Report on Survey and Mapping Development in Hong Kong for the information of all member associations and other members of the International Federation of Surveyors (FIG) at its 12th international Congress in Washington, DC, United States.
- 2007 HKIS hosted the FIG Working Week in Hong Kong.
- 2013 HKIS hosted the 7th Cross-strait Geomatics Conference and the 8th Beijing, Hong Kong, Macao Geomatics Conference in Hong Kong.

Internal Affairs

The Division has been organising various continuous professional development ("CPD") events every year. Moreover, technical visits to and joint conferences with our mainland counterparts in Beijing, Taiwan, Guangdong province, Hong Kong and Macau would be conducted every year to broaden members' knowledge.


External Affairs

The Division has made a lot achievements in this area. We have established good relationships with various international and mainland surveying organisations. We signed mutual recognition agreements with them such as the Chartered Institute of Civil Engineering Surveyors (ICES).

We also actively participated in conferences/seminars organised by overseas and mainland surveying organisations to promote the HKIS and the LSD and to exchange views on various surveying issues, including FIG Congress and Working Week, Cross-Strait Geomatics Conference, Beijing-HK-Macau Geomatics Conference, etc.

Local Affairs

With regard to the local affairs, the LSD has contributed a lot to the community and the surveying profession in Hong Kong. For the development of Hong Kong, we have been involved in various legislations which particularly relate to the aspects of land survey, control of standard of land boundary survey, preparation of plan and registration of land surveyors. They provide the society with a better living environment.



Professional Standards

To meet the increasing need for land surveying services, the Division has set up various committees, such as Boundary Survey Advisory Committee (BSAC), to cope with the drastic changes in the emerging market. To help emphasise the commitment of HKIS in ensuring integrity, ethical conduct of members, the LSD monitors closely the qualifications and standards of members as well as the practices in the industry.

The Way Forward

All Corporate Members and Associate Members of the LSD shall maintain a high level of competence in professional practice and technical performance and are obliged to undertake continuing professional development and lifelong learning to enhance their professional and technical competence. All Members, Probationers and Technical Trainees shall endeavour to achieve a high level of competence in performance and are obliged to undertake the pre-qualification structured learning.














Early Days of the P&D Surveying Division

Planning & development (P&D) surveyors have a long history in the United Kingdom. When the Hong Kong Institute of Surveyors was formed in 1984, its constitution allowed for the provision of a P&D Surveying Division.

At the time, there were very few P&D Surveyors in practice, with only seven P&D members in the HKIS by the late 1990s. They were Sr Eureka CHENG, Sr Kempis LAM, Sr P.C. MOK, Sr Edwin C.L. TSANG, Sr Andrew K.C. WONG, Sr Prof. William SEABROOKE, and Sr Julian WYATT, although these surveyors were also members of the then General Practice (GP) Division.

By late 2000, the consensus was that there might be a genuine need to train more P&D surveyors. Sr Edwin TSANG, a member of the GP Council, initiated an informal paper that called for the setup of a P&D Division. At the same time, the HKIS's Board of Education requested that P&D members initiate a P&D APC Examination scheme for future potential P&D members and appoint surveyors of other disciplines to join the working group.

The first W.G. meeting on P&D APC was held on 16 May 2000 at the HKIS headquarters. Among those in attendance were:

Between May 2000 and November 2001, ten W.G. meetings on P&D APC were held. The APC Guidelines were formulated and endorsed by the Board of Education. Although P&D membership was small, it was advisable for the P&D APC Exam to be administered by the P&D Group's education committee. A revised paper was drafted by Sr Tsang in October 2003.

Formation of the P&D Division

By 2000, there were still only the seven aforementioned P&D Members in the HKIS. A study on HKU & MSc (Urban Planning) graduates with GP membership involved Sr Francis LAU, Sr Francis LAM, and Sr Rita LAU. Given the small number of P&D members, multiple membership was thought to be a way to admit additional P&D Members. Accordingly, Sr LAU and Sr LAM were recruited as founding members of the Division.

The first Working Group on the formation of the P&D Division was held on 5 November 2003 with the following present: Sr Prof. William SEABROOKE, Sr Francis LAU, Sr Kempis LAM, Sr Edwin C.L. TSANG, and Sr Julian WYATT. Apologies came from Sr Eureka CHENG and Sr Michael CHAN.

On 20 November 2003, Sr Edwin TSANG was asked to sit on the HKIS's General Council as a representative of the P&D Division, whose formation passed through a number of hurdles starting with the setup of a Working Group by 2004. On 2 June 2004, a Provisional Council was established comprising:

The P&D Divisional Regulations based on the GP Council Regulations were drafted and approved. On 10 November 2005, the PDD Council approved the following members: Sr Francis LAM, Sr Albert SO, Sr Markus LI, Sr Norman NGAI, Sr William YIP, Sr Kenny KONG, and Sr YEUNG Ka Lai as Planning and Development Division members through the multiple membership arrangement. At the 2nd AGM on 23 November 2005, ten members were elected as council members. The same AGM approved upgrading the Provisional Divisional Council to Full Council status and the 1st Divisional Council Meeting was held on the same date. The Council focused on admitting new members through APC exams and the multiple membership arrangement. The 1st CPD course was conducted by Sr Prof. Barnabas CHUNG on the development aspect.

Membership Development

Although the APC was set up in 2002, only a few candidates have taken the APC examination. Membership growth has mainly come from the multiple membership arrangement. From seven members in 2003, membership steadily grew to over 60 by the end of 2013.

Education

The P&D Stream surveying courses at HKU and HK PolyU have been recognised by the Division for some time, but past records showed that registration for the P&D APC Exam was low compared to that for other divisions, possibly because students were not familiar with the work of P&D Members. However, the Division plans to recruit members on two fronts by recognising the new courses at HKU and establishing courses in Shanghai.

New Courses at the University of Hong Kong

The Division, after a mutual agreement, has recognised the new four-year BSc in Urban Studies course offered by HKU with the first intake occurring in 2012. Graduates will be eligible to take the P&D APC Exam in accordance with the established P&D APC Guidelines.

All MSc (Urban Planning) graduates, upon their completion of prescribed top-up courses to be offered by the Faculty, will also be eligible to take the P&D APC Examination.

Since early 2013, the Division has been discussing with Tongji University (同濟大學) about setting up a P&D course in Shanghai. The Letter of Intent of the said course has been signed by Tongji University and the Division on 4 March 2014. PDD Education Committee will follow up the implementation of the said course.

Career Prospects

The demand for P&D Surveyors is strong. Experienced members have either taken up top or senior posts in the government/quasi-government, universities, institutions, and private developers or are in private practice.

At present, no P&D professional institute exists in China that has a reciprocal recognition. Professionals like architects, engineers, and doctors have their own institutes, while surveyors in general practice, building surveyors, and quantity surveyors have reciprocal arrangements with their respective counterparts.

There are tremendous opportunities for P&D surveyors in China, where development opportunities are vast. Currently, the work that they should assume has been taken up by anyone who claims to be able to do the job.

Besides technical knowledge, professionalism and ethics are of extreme importance in our practice. Thus, properly trained P&D surveyors in Hong Kong have greater career opportunities than their Mainland counterparts.

Summary

The P&D Division's early work focused mainly on drafting APC Exam Guidelines. Its development went through a number of stages from Working Committee to Provisional Council to full Division Status in 2006. Membership grew steadily from a few members to 60 within ten years. 

Property and Facility Management Division

In the past, those of us from the three main branches of specialisation of the surveying profession were engaged in property and facility management. In 1999, the General Council saw the need to coordinate the activities of professional surveyors in this field and established the first cross-divisional committee on Property Management (PM). The PM Committee acted as the central source for coordinating activities internally and provided representations in outside government and other bodies related to property management activities. In 2003, the PM Committee was renamed Property and Facility Management Committee to embrace the growth importance in the development of facility management both globally and locally. Later in the year, the PFM Committee was reformed to become the Property and Facility Management Forum following the amendment of the HKIS Constitution recognising the establishment of specialist forums for cross-divisional and specialised services in the profession.

With the hard work of the PFM Forum under the leadership of its chairman, Sr Michael Price and the approval of the General Council, the formation of the Property and Facility Management Division was approved with overwhelming support in the Extraordinary General Meeting held on 18 May 2005.

The governing body of the Property and Facility Management Division is the **Divisional Council**, which sets out the policies, regulations, direction and manages the income, expenditure, affairs and concerns of the Division. To enable adequate representation from different sectors of organisation, the composition of the Divisional Council purposely designed as follows:

- (a) A Chairperson;
- (b) Vice-Chairperson or such other number of Vice-Chairperson as considered appropriate by the Divisional Council;
- (c) An Honorary Secretary;
- (d) An Honorary Treasurer;
- (e) At least five but not more than fifteen other members from the following areas:
 - Academia (minimum 1 number)
 - Facility Management (minimum 1 number)
 - Property Management (minimum1 number)
 - Government, Institution and Public Bodies (minimum 1 number)
- (f) Immediate Past Chairperson ex-officio;
- (g) Two representatives from the Young Surveyors Group; and
- (h) Not more than two Associate Members of the Division.

Divisional Education Committee was formed and, through representation in the Institute's Board of Education, to scrutinise, validate and keep under review academic qualifications for admission to studentship of the Division; to develop, implement and control the qualifying mechanism to corporate membership of the Division; and to establish and maintain a high standard of professional competence of member surveyors.

Divisional Professional Development Committee was formed to organise and promote continuing professional development of member surveyors.

Divisional Membership Committee was formed and, through representation in the Institute's Board of Membership is the gate-keeper of the Division, whereas qualified persons would be admitted, and members with achievements would be upgraded. The Committee also assists in setting up guidelines for the processing of membership applications.

The Divisional Council also nominates Division members be represented in the Editorial Board and other Committees, Working Groups and Task Force being set up by the Institute from time to time.

Introduction

It is my great pleasure on behalf of the Quantity Surveying Division, to congratulate the Institute on this memorable and joyous occasion to celebrate the establishment of the Institute 30 years ago.

History and Changes

The quantity surveying practice has a long history in Hong Kong. The oldest professional quantity surveying firm has been around for more than 60 years. It is believed that the date of employing the first expatriate quantity surveyor in the Government would be even more earlier than the establishment of the first professional quantity surveying firm in Hong Kong. In the past six decades, the profession has witnessed a number of significant changes:-

- the race of majority of quantity surveyors switched from expatriate to Hong Kong Chinese.
- the proportion of female quantity surveyors has been increased dramatically.
- the number of local graduates outweigh the numbers of overseas graduates.
- the measurement units have been changed from imperial to metric.
- the measurement practice has been evolved from working manually to electronically.
- the role and scope of services of quantity surveyors has been enhanced to keep abreast with the development of the society. In the old days, the quantity surveyors were working on building projects only. Nowadays more and more quantity surveyors are working on civil engineering, mechanical and electrical engineering, renovation, fitting out and maintenance projects.
- the export of professional quantity surveying services to other geographical locations, for instance, Middle East, South East Asia and the Mainland. It should be noted that Quantity Surveyor has had a long history serving Clients for Mainland's projects since 1980.

Achievement

Looking back the past three decades, the Quantity Surveying Division has made some remarkable achievements as follows:-

- Signing of Reciprocity Agreements with other overseas professional institutes, namely, Australian Institute of Quantity Surveyors (AIQS), Building Surveyor's Institute of Japan (BSIJ), China Engineering Cost Association (CECA), Chartered Institution of Civil Engineering Surveyors (CICES), Canadian Institute of Quantity Surveyors (CIQS), New Zealand Institute of Quantity Surveyors (NZIQS) and Singapore Institute of Surveyors and Valuers (SISV).
- Joining International Organisations in quantity surveying and /or cost engineering. The HKIS joined the Pacific Association of Quantity Surveyors (PAQS) as Founding Member in May 1996 and International Cost Engineering Association (ICEC) in December 1996.
- The membership size has grown from 71 founding members in 1984 to a staggering number of approximately 2,800 fully qualified members as of March 2014.

Practice in the Mainland

By way of Reciprocity Agreement with the China Engineering Cost Association (CECA) in 2005 and Supplemental Agreement in 2009, the HKIS now has 339 quantity surveyors who have obtained the qualification for registration as Cost Engineer in the Mainland. As of today, 144 quantity surveyors have successfully registered as cost engineer with the approval of the Ministry of Housing, Urban-Rural Development (MoHURD). Under the Reciprocity Agreement and Supplemental Agreement, the QSD also recommended 369 cost engineers from the Mainland for election as our full members.

The QSD is proud to be the first batch of professionals to successfully obtain the registration certificate and stamp to enable us to practice in the Mainland under the Closer Economic Partnership Arrangement (CEPA).



Organising International Congress in Hong Kong

The QSD had the honour to organise an international congress, namely, PAQS Congress 2001 in Hong Kong and Beijing. The purpose of holding part of the Congress in Beijing was to introduce this international organisation to our counterpart, CECA. Eventually, CECA joined the PAQS in 2003. Because of the size of member countries, it takes at least 10 years to have the opportunity to host the Congress.

After 13 years, the QSD has once again won the hosting right to organise the PAQS Congress 2014 in Hong Kong. This is one of the major events to celebrate the 30th anniversary of the Institute. By organising an international congress, we can showcase some of the remarkable achievements of Hong Kong in the past decade to overseas delegates.

At the time of writing, the Organising Committee is working really hard to finalise the details of the Congress. Apart from Committee meetings, Board Meeting and the Conference, the Organising Committee has to organise high level technical visits, entertainment to be performed in the Farewell Dinner and post Congress sightseeing tour. In conclusion, the work of the Organising Committee is tremendous. I wish them every success in organising the PAQS Congress 2014 to be held in June.

Nurturing the Younger Generation

The Council considers that a well planned and organised succession scheme shall foster the development of the quantity surveying profession. To meet this end, the Council has formed a Promotion Sub-committee to look after the promotion activities. One of the key objectives of the Sub-committee is to promote the quantity surveying and attract more young people to pursue the profession. This initiative is in line with the key objectives of the Institute in nurturing and encouraging more young people to join the surveying profession.

The QSD Council is the first Division to award scholarships to students reading bachelor degree and higher diploma in Universities or Institute of Vocational Education. As of March 2014, the following number of awardees have received the scholarship from the QSD:-

It is hoped that all these brilliant students will become the next generation of the quantity surveying profession.

Way Forward

Being the largest Division of the Institute, the Quantity Surveying Division will strive for excellence to meet the challenges as a result of the emergence of global economy and advancement in information technology. In the old days, we were focused on measurement of quantity. Entering the new era, the quantity surveyors shall equip themselves with modern, sometimes innovative, practice of the industry in order to be continued as a highly valued and renowned profession in the construction industry of Hong Kong and the Asia Pacific Region.

The 30th Anniversary of the Institute marks a milestone in the development of surveying industry in Hong Kong. It is a great pleasure for me and my team to be part of the celebrations.

Introduction

The Young Surveyors Group (YSG) was founded since 1984 and was previously called the "Junior Organisation". Since 2007, it was renamed to the Young Surveyors Group, a name being more easily recognised among other young professionals. The age limit was also amended from 35 to 40. YSG comprises student members, probationers and young qualified members from all divisions – the power of the surveying profession in future.

Objectives and Duties

The YSG aims to reflect the views and represent the interests of the young qualified members and to serve as a link between the Institute and the Training Grade Members of the Institute consisting Probationers and Students. Besides, it also serves to promote and enrich the professional, educational, social and cultural life among members of the YSG.

In order to achieve these objectives, a committee is formed with the composition of Office Bearers, (i.e. Chairman, Vice-Chairmen, Honorary Secretaries, Honorary Treasurer), Elected Members, Ex-Officio Member and Co-opted Members.

During the term, the YSG Committee is obliged to complete the duties as listed below:-

- a. Co-ordinate all YSG functions;
- b. Ensure that a sufficient number of sessional meetings of general interest are held within the YSG;
- c. Obtain and consider reports from the Committee on Divisional and other matters;
- d. Organise YSG Annual, Extraordinary and other General Meetings;
- e. Organise educational, social, cultural and charity functions;
- f. Encourage participation in YSG affairs by Probationers and Students; and
- g. Conduct local public relations in consultation with the appropriate Divisional Council or standing Committee of the General Council.

Membership

Up to March 2014, the YSG is serving 4,091 members which consist of 1,912 corporate members, 1,867 probationers and 312 students from the Universities.

Our Functions

Academic and Professional Events

The YSG has organised various Continuing Professional Development (CPD) and Pre-qualification Structural Learning (PQSL) events for our young members. Event topics cover the knowledge of different surveying disciplines, including indoor lectures, site visits and study tours to enrich the professional competence of our young members.

Social Events

Other than professional development, YSG encourages young members to participate in various social events such as ball games, sports class, cooking class and charity etc. The participants not only gain a lot fun, but also enhance their networks amongst members.

Public Relations

Beyond the Institute, YSG members are actively involved in promoting the surveying industry through participation in various educational visits to universities and secondary colleges and joining the Careers Expo. Besides, YSG have also maintained intimate relations with the young groups of other professional bodies. The joint-institute events, like the Youth forum and One-day seminar also help our members to broaden their horizon.

Way Forward

The many professional, social and charitable functions organised by YSG have done a great deal to develop the professional and energetic image of young surveyors. With the support of the General Council of the Institute and our members, I am confident that the YSG will be able to continue playing its vital role in strengthening the relations between the Institute and the training grade members. In addition, one of the new initiatives we have taken is that we have created a platform for building ties between young qualified members and probationers.

I look forward to seeing the Institute embark on its fourth decade with fresh confidence, and I wish the Institute every success in its efforts to support our common endeavours.




